COVID-19: Highlights and Situation Overview

- Worldwide, there have been over 46.7 million cases and more than 1.2 million deaths attributed to COVID-19.
- Markets in Yangon, Myanmar remain as transmission hotspots for COVID-19 according to the spokesperson of the Ministry of Health and Sports. The number of cases from the markets have been going up for 15 consecutive day. Cases in old folks' homes, monasteries and factories have also been high and according to the Ministry, inspections are being carried out in these establishments. Meanwhile, Mandalay Region has extended its COVID-19 preventive measures until November 15. All restaurants, bars and food shops will only be allowed for take-away orders only and operate within the existing. Some establishments and events shall be banned and closed temporarily. As of November 1, Myanmar has reported 699 new COVID-19 cases, bringing the country's total cases to 53,405.
- Today (November 2), Laos has extended its COVID-19 prevention measures until December 31, however, some measures including a ban on bars and karaoke venues, will be eased. According to a notice issued by the Prime Minister's Office, authorities have agreed in principle to allow entertainment venues, such as karaoke bars and nightclubs, to reopen. The move comes as the government hopes to mitigate the economic impact of Covid-19, particularly in regard to business operations. The updated COVID-19 prevention measures will also remain in place until December 31.
- Philippines continues to experience a downward trend since mid-September. The Philippines recorded a seven-day rolling average number of new cases that reached 3,970 on September 16, which has steadily declined to 1,844 on October 31. Health officials implemented new quarantine classifications for some regions on October 31, which include a General Community Quarantine (GCQ) in the Luzon Islands, the National Capital Region, and the cities of Batangas, Tacloban, Bacolod, Iligan, and Iloilo. The GCQ consists of allowing public transportation at a reduced capacity, with some businesses being allowed to operate at 50-100% of their regular capacity. Shopping malls are also allowed to operate, although only select stalls and stores are allowed to open. The Mindanao region will be on Modified Enhanced Community Quarantine (MECQ), which will enable people to get essential services and to go to work at 50% capacity in manufacturing and processing plants. The MECQ includes limited transportation services for essential goods and services, but prohibits the attendance in physical classes. The rest of the Philippines will be on Modified General Community Quarantine (MGCQ), where movement, work, transport, and school go back to normal, but mask-wearing, physical distancing, and other health protocols are enforced.

Travel Advisories (new update/s)

- Laos: In the notice issued by the government, the government will discuss policy on travel between Laos and Vietnam, and Laos and Japan, as well as other ASEAN countries. Laos will still continue the suspension on issuance of tourist visas for foreign visitors, however, people who have an urgent need for travel will be authorized. The closure of traditional and customary border checkpoints will remain in place, except for those authorized by the government for the transport of goods. International borders will remain closed to all regular travelers except Lao citizens or foreigners with authorization from the Taskforce.

Cases and Deaths as of 02 November 2020

- As of November 02 (2PM, GMT+8), worldwide, there were **46,774,452** confirmed cases, including **1,205,793** deaths. Globally, Case Fatality Rate (CFR) is **2.58**.
- In **China**, there were **91,978** confirmed cases with **4,746** deaths, including deaths in Hong Kong (105) and Taiwan (7). Confirmed cases in China include confirmed cases in Hong Kong (5,331), Macau (92), and Taiwan (558).
- 945,253 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **22,813 deaths**.

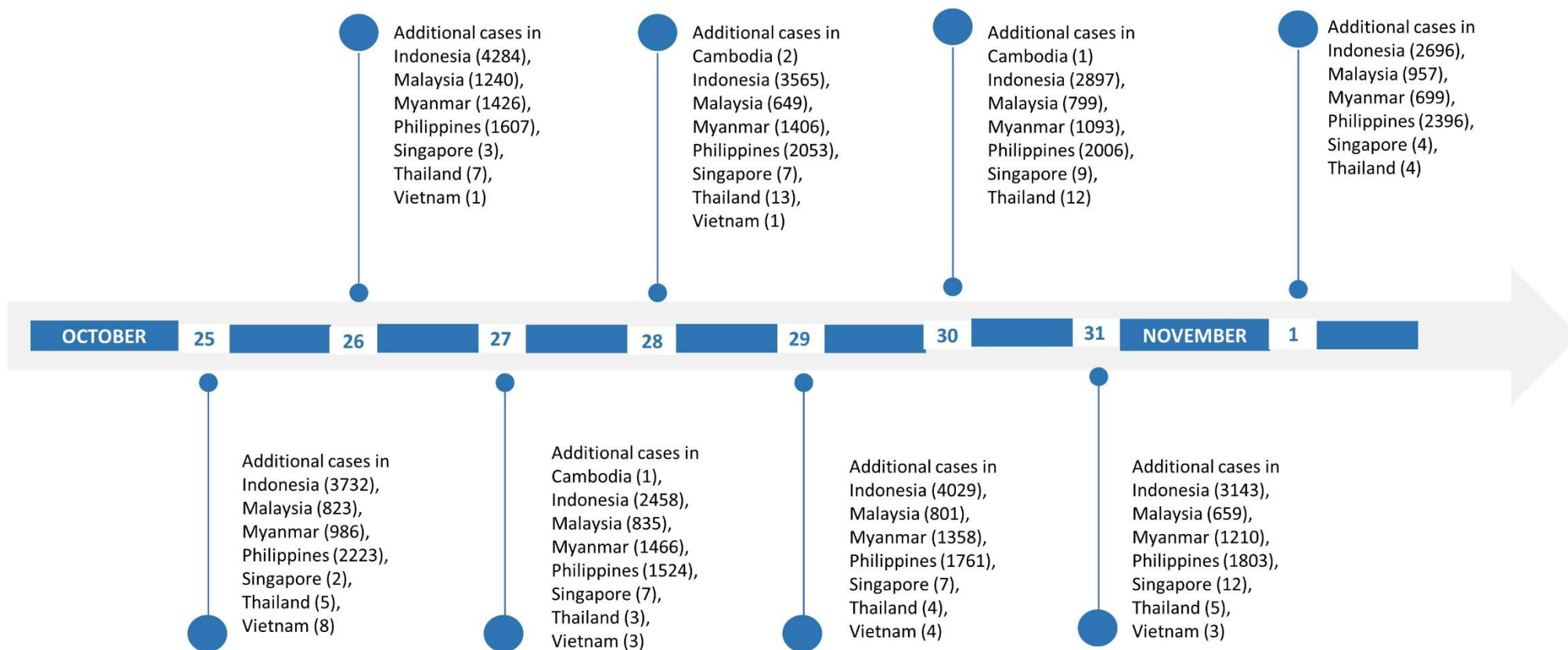

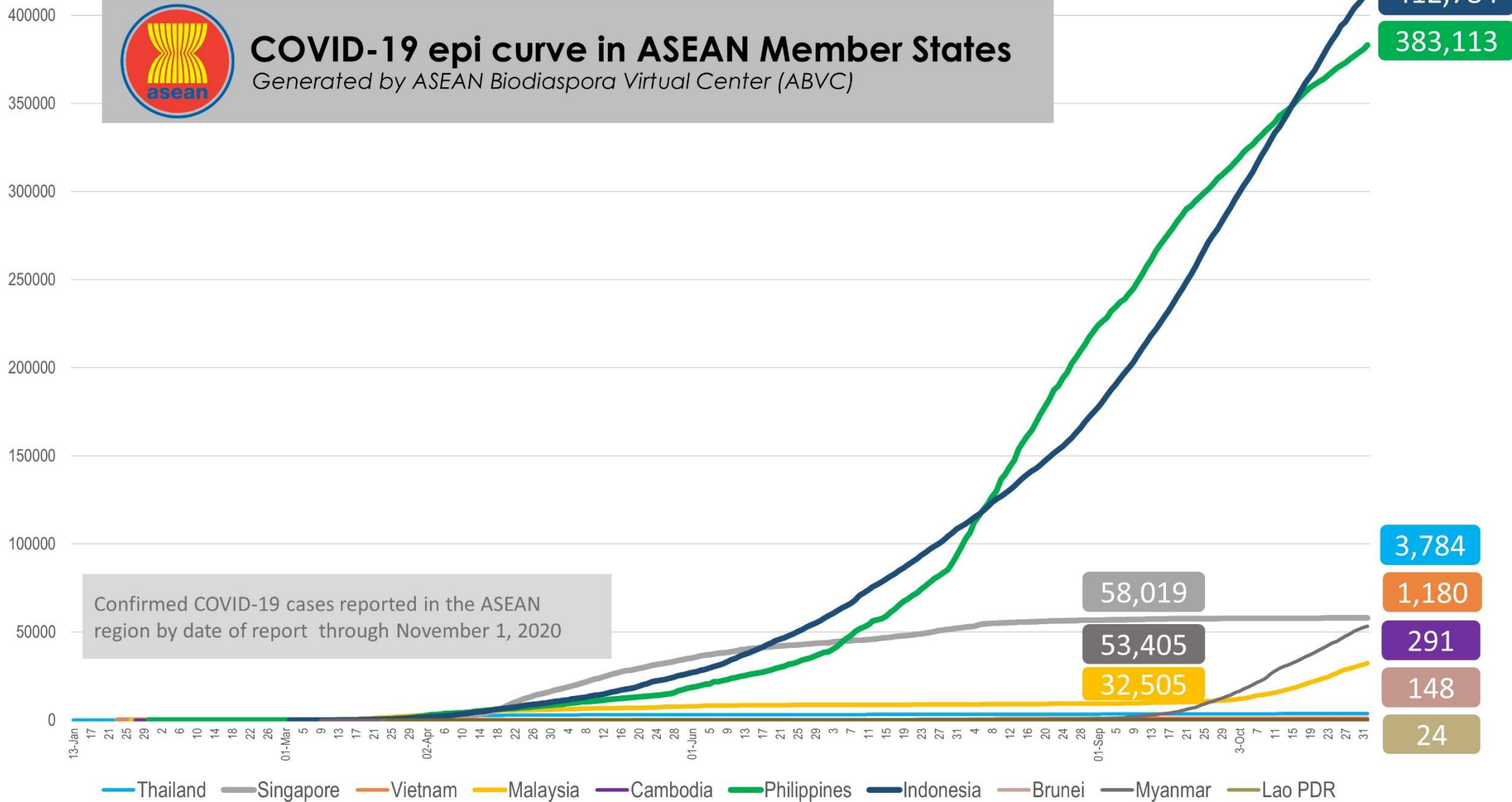
