COVID-19: Highlights and Situation Overview

- Worldwide, there have been more than 10 million cases reported as of today, and over a half million deaths attributed to COVID-19.
- World Health Organization (WHO) has published interim guidance on rapid hospital readiness and an accompanying checklist tool, which can be used to monitor the development of operational readiness capacity in hospitals and identify gaps that require investment and action. The checklist covers hospital governance, structures, plans and protocols to rapidly determine the current capacities of hospitals to respond to COVID-19. WHO has published interim guidance on biomedical equipment for COVID-19 case management and an accompanying inventory tool, which countries can use to collect in-depth facility inventories of biomedical equipment re-allocation, procurement and planning for COVID-19 case management. The tool is intended for use from the early stages of an emergency to early recovery (WHO Situation Report 159).
- Cambodia's Ministry of Education, Youth and Sport announce on June 28 that it will delay school openings and high school graduation examinations until the end of the year to prevent a second wave of COVID-19. The minister however said that although the government moves to offer digital learning services, about half of Cambodia's 3 million students still cannot fully access online lessons. He said that the government's stance is to maintain vigilance as it doesn't want the pandemic to spread again in Cambodia.
- Indonesia government has claimed an increase in the number of regions that are COVID-19 free and categorized as low-risk zones, however, epidemic risk mapping shows that 57 cities and regencies are still classified as red zones, or areas with high rates of transmission. The data showed East Java had recorded the highest number of red zones with 13 cities and regencies followed by South Kalimantan with 11. As of June 26, East Java has surpassed Jakarta, the first epicenter of COVID-19 transmission, with 10,901 confirmed cases compared to 10,796 in the nation's capital. Additionally, 157 cities and regencies were categorized as orange zones with a medium risk of infection, while 188 were classified as yellow zones or low-risk areas. The remaining 112 were either completely free of the disease or have not recorded any new cases in four weeks, with a 100 percent recovery rate of patients. As of June 28, the total number of cases in the country is 54,010.
- Myanmar is imposing a 15-day extension of its virus measures and directives until July 15 to prevent the spread of the pandemic from inbound travellers and within the country, according to a statement released on Saturday (June 27) by the Central Committee on COVID-19 Control. The nightly 12am to 4am curfew remains in place, along with the ban of gatherings of more than five people. Exceptions are made for funerals and work-related matters.
- China imposed a strict lockdown on nearly half a million people in a province surrounding the capital to contain a fresh coronavirus cluster on Sunday (June 28), as authorities warned the outbreak was still "severe and complicated." Health officials said Sunday that Anxin county -- about 150 kilometers (90 miles) from Beijing -- will be "fully enclosed and controlled", the same strict measures imposed at the height of the pandemic in the city of Wuhan earlier this year. The move comes after another 14 cases of the virus were reported in the past 24 hours in Beijing, taking the total to 311 since mid-June and spurring the testing of millions of residents.

- On 26 June 2020, Singapore's Prime Minister and Malaysian Prime Minister discussed the gradual and phased resumption of cross-border travel between Singapore and Malaysia. Both the Prime gareed that any bilateral arrangement would have to include mutually agreed public health protocols, to preserve the public health and safety of citizens on both sides, while taking into account the medical resources available in both countries. They also agreed to establish a Reciprocal Green Lane (RGL) and a Periodic Commuting Arrangement (PCA) to address the needs of different groups of cross-border travellers. The RGL will facilitate cross-border travel for essential business and official purposes between both countries. Travellers would have to adhere to a set of COVID-19 prevention and public health measures, which are under discussion and will have to be mutually agreed upon by both countries. The PCA will allow Singapore and Malaysia residents who hold long-term immigration passes for business and work purposes in the other country to periodically return to their home countries for short-term home leave. They will be able to return home for leave after spending at least three consecutive months in their country of work, and they will be allowed to re-enter their country of work after their home leave.
- On June 29, Thailand's Centre for COVID-19 Situation Administration (CCSA) announced the extension of the emergency decree is due to expire on July 1 and shall be extended for another month until end of July. CCSA said that the extension is necessary because the country will open up more businesses and permit more travel, and all schools will be reopened on July 2.

Travel Advisories (new update/s)

- Indonesia: All domestic flight guests are required to present the followings prior to departure: personal identification (KTP/ Passport or other valid official IDs), health certificate that proves non-reactive COVID-19 Rapid Test results or negative RT-PCR result that is valid for a maximum of 14 days on the day of departure, or a health certificate showing no flu-like symptoms issued by a medical doctor from a hospital or public health facility for areas without PCR test/ rapid test facilities. Guests flying to Bali (DPS) are required to present COVID-19 PCR results (not Rapid Test) with negative/ non-reactive results. Passengers are also required to download and activate 'Peduli Lindungi' mobile application and fill out an electronic health awareness card (e-HAC).
- Myanmar: The Myanmar government announced Sunday (June 28) a further extension of temporary entry restrictions for visitors from all countries until July 31. According to the announcement, the extension will be applied to the ministry's previous announcements of precautionary measures which will expire on June 30. The extended restrictions include entry restrictions of all incoming travellers, suspension of all types of visas including social visit visa, visa exemption services, and as well as a three-week quarantine for Myanmar nationals returning home by relief flights and across borders
- Philippines: The Land Transportation Franchising and Regulatory Board (LTFRB) said on Sunday (June 28) authorities are finalizing guidelines that will allow and govern resumed operations of UV Express and traditional jeepneys in Metro Manila, after full deployment of modernized Public Utility Jeepneys (PUJs). The government implemented Phase One of the resumption of public transportation in GCQ areas from June 1-21, which included the operations of rail transport, point-to-point (P2P) bus service, city buses, taxis, Transport Network Vehicle Service, shuttle services, tricycles, and bicycles. The LTFRB said

- that 15 routes for 318 modern jeepneys will be open in Metro Manila starting Monday, June 22. There will be nine more routes available on June 24, and 10 more will be added on June 26.
- Thailand: Following the announcement that Thailand would once again open its doors to certain categories of international visitors starting July 1, the government's COVID-19 task force has confirmed most will have to agree to a 14-day quarantine. It's understood that the first group to be granted entry to the Kingdom from July 1 will include business people, skilled workers and experts, teachers, students, and medical tourists, as well as foreign residents with Thai families residing in the country. In the case of those coming on short visits, on business or as guests of the government, they will have to agree to be tested for COVID-19 before departure in their home country, and again upon arrival in Thailand. They must also have health insurance that covers COVID-19 treatment, and agree to be monitored by medical staff during their stay.

Cases and Deaths as of 29 June 2020

- As of June 29 (2PM, GMT+8), worldwide, there were **10,129,139** confirmed cases, including **503,003** deaths. Globally, Case Fatality Ratio (CFR)* is **4.97**.
- In **China**, there were **85,193** confirmed cases with **4,648** deaths, including deaths in Hong Kong (7) and Taiwan (7). Confirmed cases in China include confirmed cases in Hong Kong (1,200), Macau (45), and Taiwan (447).
