

COVID-19: Highlights and Situation Overview

- Worldwide, there have been over 45.2 million cases and more than 1.18 million deaths attributed to COVID-19. Global coronavirus cases rose by more than 500,000 for the first time on Wednesday (October 28), a record one-day increase as countries across the Northern Hemisphere reported daily spikes. Most western countries and parts of Latin America have reported their highest single-day surges in the past few weeks. Many governments have started taking stronger measures to bring the spread of the virus under control. According to the World Health Organization's Europe director on October 29, the number of coronavirus cases in Europe has exceeded the 10 million mark since the beginning of the pandemic, with more than 1.5 million cases confirmed last week alone. As Europe is well into its second wave, many countries are implementing new restrictions in an attempt to curb the spread of the coronavirus. With France introducing a national lockdown starting Friday (October 30), Kluge of WHO Europe said lockdowns were a "last resort option" because they bypass the "still-existing possibility of engaging everyone in basic and effective measures."
- Indonesia's National COVID-19 task force has been using a real-time data platform called Sistem Bersatu Lawan COVID-19 (BLC) Monitoring Perubahan Perilaku (United in Fighting COVID-19 Monitoring Behavioral Change System) to curb the spread of the disease. The task force's expert team coordinator and spokesperson, Wiku Adisasmito, said in a virtual press conference hosted by the National Disaster Mitigation Agency (BNPB) on Wednesday that the team had been using the platform for four months and had been monitoring several locations with high cases of health protocols violations. It was also explained that BLC was designed to produce real-time, integrated, systematic and interoperable data that involved cross-sectors coordination. Indonesian health authorities confirmed on October 28 that the total number of COVID-19 cases has reached more than 400,000.
- Myanmar government on October 29 has extended the country's COVID-19 prevention measures until November 30. The National Level Central Committee on Prevention, Control and Treatment of COVID-19 announced that all existing instructions, orders and directions will be extended. This is the 11th time the committee extended the restrictions since the first introduction in April. On October 29, the country has reported 1,358 new COVID-19 cases, bringing the total number of cases to 50,430. It is now the nation with 4th highest number of cases in the ASEAN.
- Thailand's health officials are suggesting cutting mandatory quarantine for international arrivals to 10 days. Health Minister Anutin Charnvirakul said on October 29 that the proposal will be submitted to the government's COVID-19 task force for approval. It's hoped that a reduction in the quarantine period could help revive Thailand's tourism sector. A national quarantine policy is currently at draft stage and aims to ensure there are sufficient quarantine facilities to support the country re-opening further. The draft sets out guidelines for running a quarantine venue, with a requirement for all facilities to adhere to the same strict hygiene and safety standards, while working under the umbrella of the national communicable diseases committee in Bangkok.
- Thirteen out of 130 hospitals in the National Capital Region of the Philippines are
 in the "critical zone" for coronavirus disease (COVID-19) facilities while the
 Department of Health (DOH) modifies its classification for the utilization rate of
 COVID-19 beds. DOH also revised its classification for occupancy of COVID-19

beds in health centers to critical, high risk, moderate and safe from the previous classification of danger, warning, and safe levels. With these new classifications, the DOH said hospitals that are in the critical zone have a bed occupancy rate of more than 85%. "High risk" health facilities are those with an occupancy rate of 70% but is not more than 85%.

Travel Advisories (new update/s)

- Singapore: The country has lifted its border restrictions for visitors from mainland China and Australia's Victoria state from November 6. According to the Civil Aviation Authority of Singapore (CAAS) on September 29, this will take effect from midnight on November 6 and includes all travellers who are not Singapore citizens, permanent residents or long-term pass holders.
- Japan: According to Japan's Foreign Minister today (October 30), the country
 has eased travel curbs for China, Australia, South Korea and six other countries
 and regions. Japan has also lowered its infection risk advisory level for Thailand,
 Singapore, Taiwan, New Zealand, Brunei and Vietnam, besides China, South
 Korea and Australia.

Cases and Deaths as of 30 October 2020

- As of October 30 (2PM, GMT+8), worldwide, there were **45,111,671** confirmed cases, including **1,184,477** deaths. Globally, Case Fatality Rate (CFR) is **2.63**.
- In **China**, there were **91,874** confirmed cases with **4,746** deaths, including deaths in Hong Kong (105) and Taiwan (7). Confirmed cases in China include confirmed cases in Hong Kong (5,314), Macau (92), and Taiwan (553).
- **924,899 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **22,418 deaths**.
