

COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 177 million cases and more than 3 million deaths attributed to COVID-19.

Regional Update

- Malaysia's Prime Minister said that the lockdown during the first phase of the movement control order (MCO) enforced since June 1 will be lifted once cases fall below 4,000 a day. In his special address on Tuesday (June 15), the Prime Minister said there were four phases for the National Recovery Plan, and that phase two of the MCO would see the reopening of the economy in phases, where 80% of the workforce would be allowed back in the workplace. Phase two will begin once 10% of the population receives both COVID-19 vaccination doses. However, he said interstate travel and social activities would still not be allowed during phase two. He also said that only listed sectors will be allowed to operate while unlisted sectors will be ordered to remain closed. The government also consider moving on to phase three of the National Recovery Plan where all economic sectors can reopen – except for high-risk activities – if the country manages to lower the number of daily cases to below 2,000. The Prime Minister said that this phase would also be considered when the national healthcare system reaches a level where intensive care units are able to function at adequate levels and where 40% of the country's population has received both doses of the vaccine.
- Laos' Ministry of Health said on June 14 that the government will quarantine anyone who has had contact with an infected person to break the chain of COVID-19 infections. Health officials will make the decision to quarantine close contacts of infected persons on a case-by-case basis and categorize patients in accordance with their proximity or relationship. Those who have had direct contact with an infected person will be required to stay at a state quarantine center or hotel authorized by the COVID-19 Taskforce. People who live in separate houses or rooms with suitable facilities may self-isolate at home if deemed appropriate. The strict new policy is being implemented after authorities have faced difficulty tracing infected persons and preventing people with asymptomatic infections from spreading COVID-19 to friends, family members, or colleagues. Despite lockdown measures in place for 55 days across Laos, community spread has continued in Vientiane Capital. He also noted that many people have failed to comply with lockdown measures, continuing to consort with one another and hold gatherings at their residences, resulting in new cases of the virus every day.

Vaccine Update

- Laos has received another batch of Sinopharm COVID-19 Vaccines containing 500,000 doses from the Chinese government. The fifth shipment of China's Sinopharm COVID-19 vaccine arrived in Laos Monday (June 14) evening. The vaccines were presented to Director-General of the Department of Hygiene and Health Promotion, Dr. Phonepaseuth Ounaphom, by a representative of the Chinese Embassy to Laos at Wattay International Airport in Vientiane. Laos received its first shipment of Sinopharm COVID-19 vaccines from China on December 31 last year, containing around 2,000 doses, followed by 300,000 doses in February, 800,000 doses in early April, 300,000 doses in a fourth shipment in late April, and now 500,000 doses this June. A shipment of Pfizer COVID-19 Vaccines also arrived in Laos earlier this month through the COVAX Facility – a partnership between the Coalition for Epidemic Preparedness Innovations (CEPI), Gavi, the

Vaccine Alliance, UNICEF, and the World Health Organization (WHO) – consisting of 100,620 doses of the Pfizer BioNTech vaccine. The second shipment of Pfizer Covid-19 Vaccines will arrive in Laos next month, containing about 132,000 doses.

Travel Advisories (new update/s)

- Brunei: The Prime Minister's Office (PMO) announced on Tuesday (June 15) the further extension on the temporary suspension of cross-border activities and travels to and from five Indian subcontinent (India, Nepal, Sri Lanka, Pakistan, and Bangladesh) countries for another two weeks starting today (June 16) to June 30. Entry of foreign nationals via land and sea ports, including transits through Brunei Darussalam are banned except for entry and transit travels that have been granted approval by the Government of Brunei Darussalam. Entry and transits through Brunei Darussalam may only be considered for transit vehicles with Transit Permits that are issued by the government, provided that the travellers have attained endorsement from their local authorities for their travels, and will be subject to existing entry conditions and procedures, for the following purposes: (i) Official Government travel; (ii) Students who are required to attend school; (iii) Emergency services (such as ambulances, police and military); and (iv) Vaccinated foreign-registered transport operators with Cross-Country Permits issued by the government of for import deliveries of essential goods.

Cases and Deaths as of 16 June 2021

- As of 16 June 2021 (2PM, GMT+8), worldwide, there were **177,698,653** confirmed cases, including **3,839,353** deaths. Globally, Case Fatality Rate (CFR) is **2.2**.
- In **China**, there were **116,645** confirmed cases with **5,306** deaths, including deaths in Hong Kong (210) and Taiwan (460). Confirmed cases in China include confirmed cases in Hong Kong (11,881), Macau (52), and Taiwan (13,241).
- **4,386,384 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **85,505 deaths**, with a CFR of **1.9**.

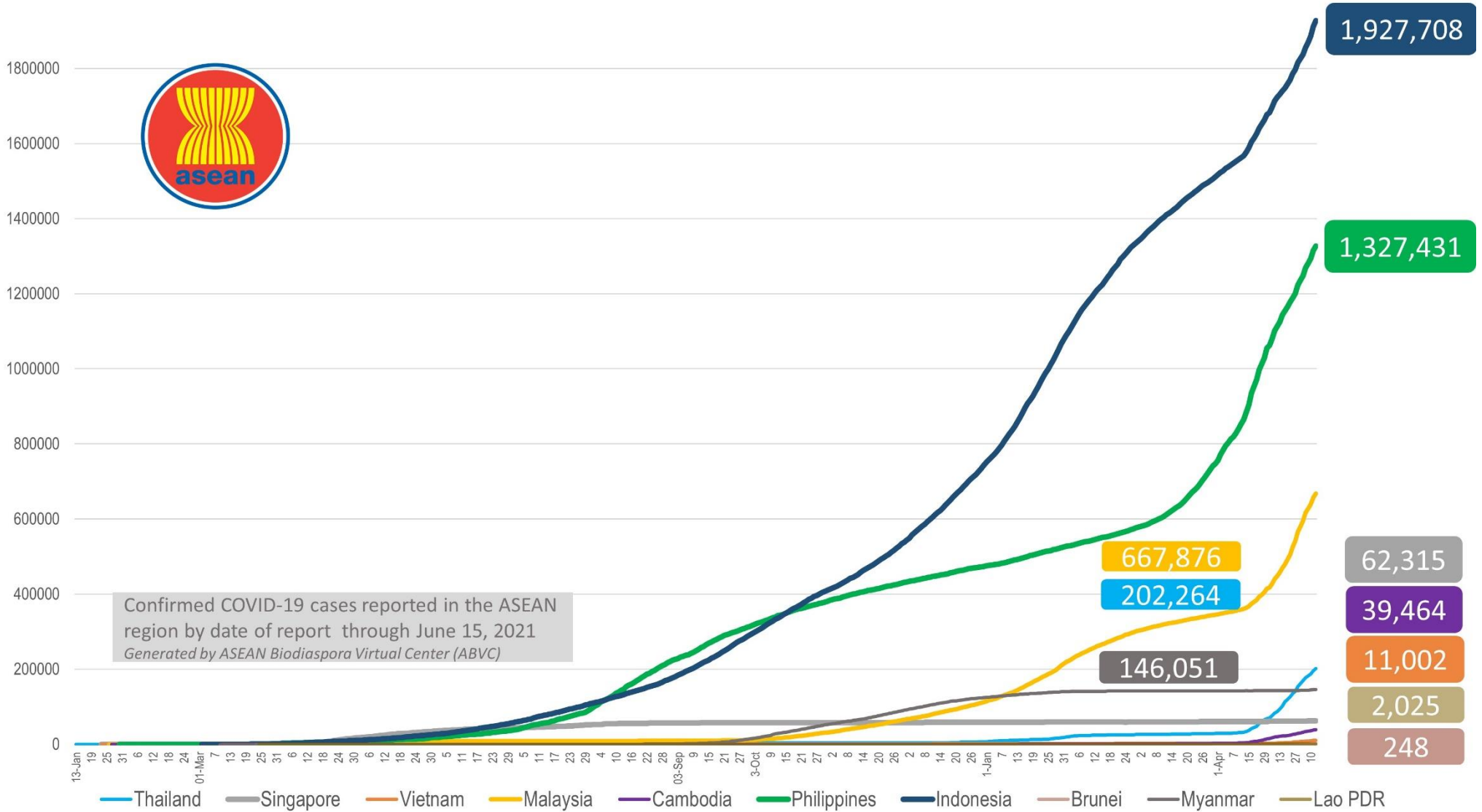

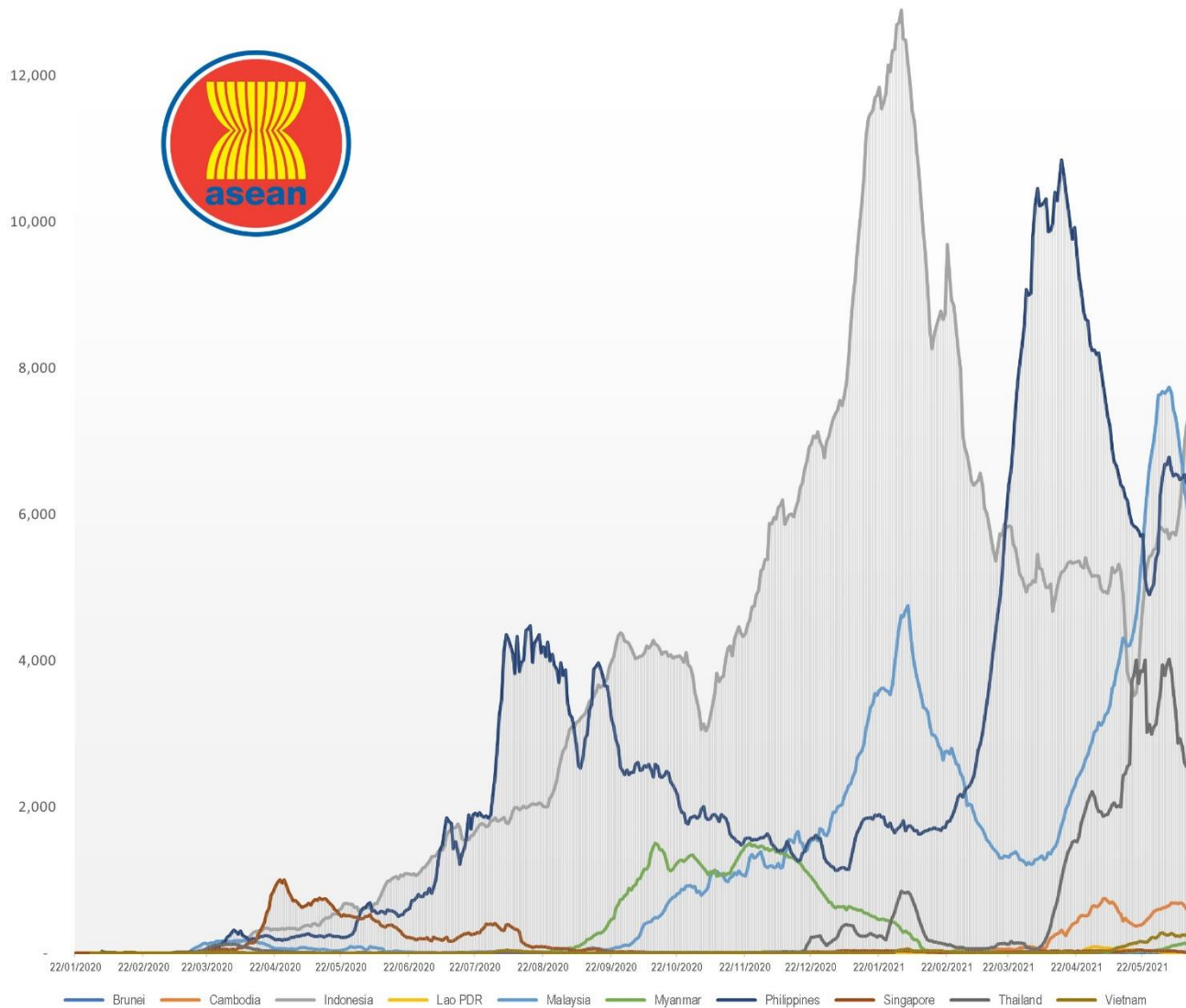
COVID-19 Epi curve among ASEAN Countries

as of 15 June 2021



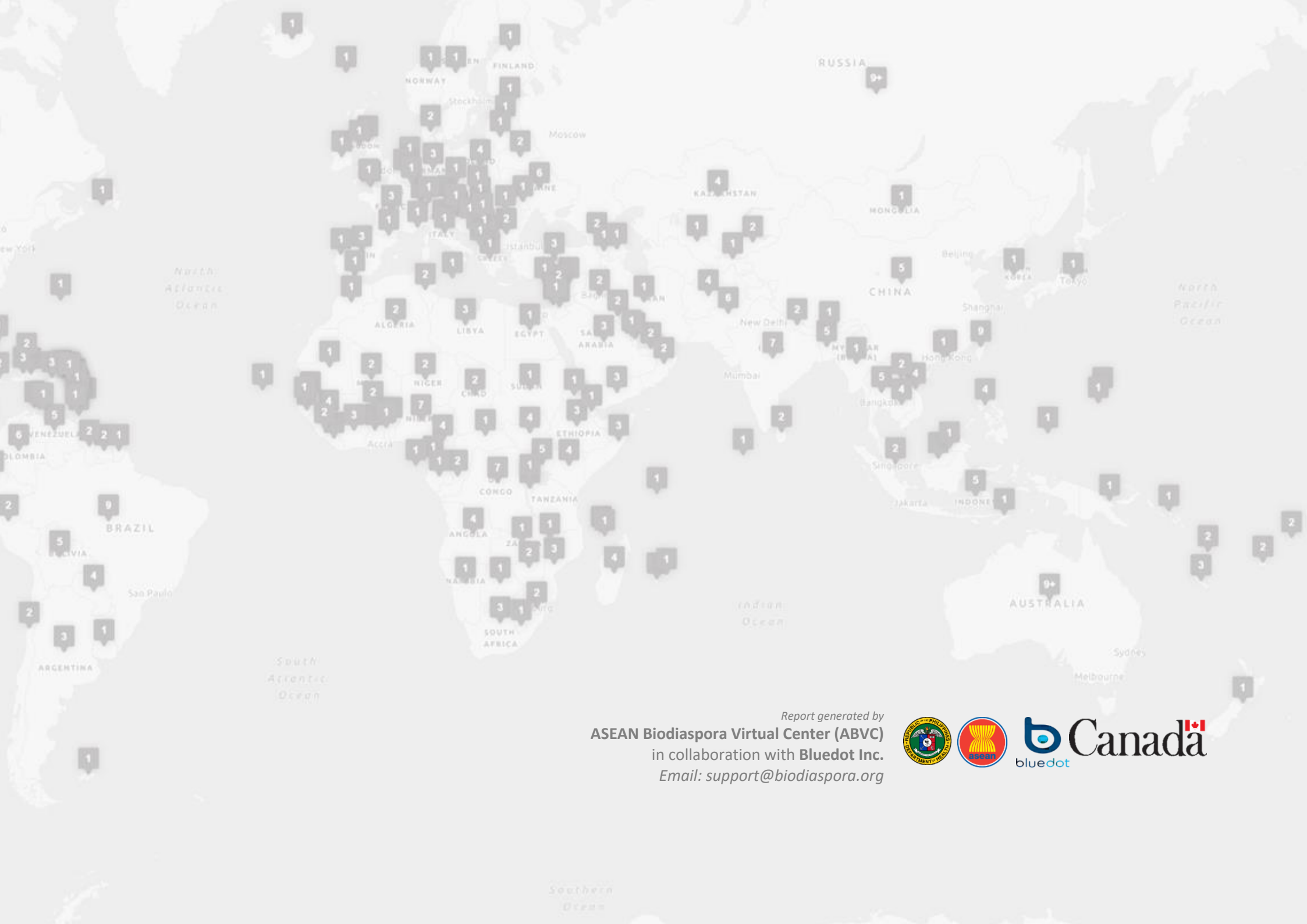
7-Day Rolling Average of COVID-19 new cases
