COVID-19: Highlights and Situation Overview

Global Update

• Worldwide, there have been over 234 million cases and over 4 million deaths attributed to COVID-19.

Regional Update

- Vietnam's commercial hub Ho Chi Minh City will start relaxing its coronavirus curbs from later on September 30 (Thursday), allowing more business and social activities after four months of measures aimed at arresting a spiraling death rate. Starting October 1, Ho Chi Minh City's industrial parks, construction projects, malls, barber shops, hospitality facilities and restaurants for takeaways can resume operations.
- Philippines further loosened COVID-19 restrictions in the national capital region on Friday (October 1), allowing restaurants to accept more guests and gyms to reopen after recording a decline in daily COVID-19 cases. An alert level system first and small-scale lockdown system imposed on the capital region on September 16 to allow for greater mobility and more businesses to reopen will remain in place until October 15. Restaurants and personal care services were permitted to double their allowable operating capacity to 20%, while fitness studios and gyms were allowed to reopen, but only to fully vaccinated clients.
- Laos government has announced an extension of COVID-19 restriction measures for a further two weeks. Government Spokesperson and Minister to the Prime Minister's Office, made an announcement evening of September 30 extending COVID-19 restriction measures at the national level for the 11th time since the nation began experiencing its second wave. Entertainment venues, cinemas, spas, karaoke bars, pubs, internet cafes, snooker halls, and casinos will remain closed across the country. Massage parlors, beauty salons, night markets, food gardens, and tourist sites across the country in areas that have community spread of COVID-19 will also remain closed. In addition, factories and industrial plants in areas with community spread within the factory or the community except for factories that have been authorized by the COVID Taskforce to continue operations, factories that produce consumer goods, medicines or medical equipment. Factories that remain open must do so in strict compliance with COVID-19 prevention measures. Any factory that does not comply with all regulations and measures will be temporarily closed.

Vaccine Update

• Malaysia reported a total of 20,202,624 individuals or 86.3% of the adult population in the country have completed their COVID-19 vaccination as of September 30. Based on the Ministry of Health (MoH) data on the COVIDNOW portal, about 3.7% more is required to achieve 90% of adult vaccination. As of yesterday, 94.2% or 22,042,703 individuals of the adult population have received at least one dose of the COVID-19 vaccine, while 52,774 or 1.7% of adolescents, aged between 12 and 17 completed their vaccination. A total of 329,163 doses of the vaccine were dispensed yesterday with 167,443 as the first dose and 161,720 the second, raising the cumulative total dispensed under the National COVID-19 Immunization Programme (PICK) to 43,696,743 doses. Malaysian authority said on Thursday (September 30) that it would now be mandatory for all federal government employees to be vaccinated against COVID-19, with exceptions only to be allowed on health grounds. The announcement comes as the country looks to boost vaccination rates with the aim of inoculating 80% of the population by the end of the year. Unvaccinated employees have been given until Nov 1 to complete their inoculations, while those who are unable to be vaccinated must submit health information verified by a government medical officer.

Those who fail to get vaccinated in time will face disciplinary action according to the Public Service Department. Meanwhile, COVID-19 vaccine development in Malaysia is still in the proof-of-concept stage before pre-clinical trial phases can start. Science, Technology and Innovation Minister said it has allocated RM15 million for COVID-19 vaccine research and development (R&D) at Universiti Malaya's TIDREC and scientists at University of Putra Malaysia (UPM). Apart from that, the Health Ministry (MOH) has also provided an allocation to develop COVID-19 vaccines at its Institute of Medical Research (IMR), which has been planned since April 2020. R&D under IMR involves the development of two COVID-19 vaccine technologies, namely, mRNA, which is currently undergoing in-vitro transcription process, and deactivated virus. The minister added that the said vaccines at IMR would be developed through strategic collaboration with researchers from UPM and the Veterinary Research Institute (VRI). The Health Ministry has announced that the CoronaVac COVID-19 vaccine from Chinese manufacturer Sinovac has been given conditional approval for those aged 12 and above. In a statement, the Health Ministry said the use of CoronaVac COVID-19 vaccine from Sinovac Life Sciences Co. Ltd., China and Pharmaniaga Lifesciences Sdn Bhd, Malaysia, was approved in a Drug Control Authority (DCA) meeting on October 1. The DCA, however, recommends that the use of the vaccine is prioritized for adolescents aged 12 to 17 without comorbidities and those who have allergies and are not suitable to receive the Cominarty vaccine.

• Brunei's Minister of Health said that COVID-19 booster shot programme will be eventually made available to the public in stages. The shot will be given at least six months after the administration of the recipient's second dose. According to the minister, everyone is advised to get a third dose, however, frontliners will be prioritized first.

Travel Advisories (new update/s)

- Thailand: The country has agreed to open a new border crossing with Cambodia to boost trade. The crossing at the newly constructed Nong Ian-Stung Bot-Ban Friendship Bridge in Sa Kaeo province will be opened early as Thailand has yet to complete construction of its checkpoint. In the meantime, goods will be transported through the Ning Ian checkpoint by container only.
- Laos: Borders and checkpoints will remain closed for another 2 weeks. Tourist and visitor visas will not be issued to foreigners, however diplomatic personnel, employees of international organizations, experts, and investors with an urgent requirement to enter the country will be granted entry but must comply with all COVID-19 prevention measures issued by the government. Ambassadors and heads of international organizations are authorized to use their residence for a 14-day quarantine, while employees at all lower levels must quarantine at an authorized quarantine hotel.

Cases and Deaths as of 01 October 2021

- As of 01 October 2021 (2PM, GMT+8), worldwide, there were **234,804492** confirmed cases, including **4,799,377** deaths. Globally, Case Fatality Rate (CFR) was **2.0.**
- In **China**, there were **124,640** confirmed cases with **5,691** deaths, including deaths in Hong Kong (213) and Taiwan (842). Confirmed cases in China include confirmed cases in Hong Kong (12,218), Macau (71), and Taiwan (16,223). CFR was **4.6**.
- 12,105,158 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 262,558 deaths, with a CFR of 2.2.




COVID-19 Epi curve among ASEAN Countries

as of 30 September 2021


