### **COVID-19: Highlights and Situation Overview**

#### **Global Update**

- Worldwide, there have been over 263 million cases and over 5 million deaths attributed to COVID-19.
- As of November 30, a total of 207 confirmed cases of the Omicron variant (B.1.1.529) reported across 18 countries. However, we have
  also found reports with limited details describing 226 total cases across 20 countries. Countries currently identified as potential origins of
  the Omicron variant include South Africa, Nigeria, Malawi, Egypt, Mozambique, and Namibia. It may be reasonable to assume that
  community transmission is occurring in these locations. Canada has also been identified as a location of origin, however, it is uncertain if
  the person contracted the virus in Canada. Cases of the Omicron variant have been reported for the first time today in Austria, Japan,
  and Reunion. Additional cases were also reported in the United Kingdom, Canada, Denmark, Australia, Italy, Sweden and Germany.

On November 30, health authorities in the Netherlands released information that the Omicron variant was detected among two test samples collected in the country between November 19 and 23. These samples precede the initial cases identified in the Netherlands among arriving travellers from South Africa on November 28. However, it is unclear whether the affected individuals from November 19-23 had a history of travel to southern Africa. This raises concerns on the potential for community transmission in the Netherlands and regarding the geographic origin of Omicron. While the two new samples reveal Omicron was in the Netherlands earlier than previously understood, they do not precede the earliest cases identified in southern Africa (on November 9, 2021 in South Africa). As of November 30, there have been fourteen Omicron cases identified among travellers in the capital, Amsterdam.

#### **Regional Update**

Singapore will hold off on further reopening measures while it evaluates the Omicron COVID-19 Variant and will boost testing of travellers
and frontline workers to reduce the risk of local transmission. According to the Ministry of Health (MOH) on November 30 (Tuesday), cases
confirmed or suspected to be infected with the Omicron variant will not be allowed to undergo home recovery, and instead be
conveyed to the National Centre for Infectious Diseases for isolation and management. MOH will also conduct full contact tracing for
these cases to identify their close contacts, place them on a 10-day quarantine at government quarantine facilities instead of allowing
self-isolation at home, and conduct PCR testing at the start and at the end of their quarantine. MOH added that they will be introducing
a set of measures that serves as a strong yet reasonable response to the new variant to protect the local community.

#### Vaccine Update

- The United States, through the US Agency for International Development (USAID), will provide an additional US\$2.4 million grant to Unicef and the World Health Organization (WHO) to further support Laos' COVID-19 vaccination programme. The grant will primarily focus on supporting the readiness, delivery and post-delivery monitoring of vaccinations. This new grant reflects the strong and expanding partnership between the governments and people of the United States and Laos. To date, the United States has provided over US\$13 million in support of Laos' fight against COVID-19.
- Brunei's vaccination drive for children between 5 and 11 has been granted permission by the Technical Division of the Ministry of Health (MoH). As such, the country is currently negotiating with Pfizer regarding vaccine supply. The health minister also shared that as of November 28, some 638 individuals had received the COVID-19 vaccine under the National Vaccination Programme. 403,094 individuals or 93.7% of the population received a single dose, while 344,914 individuals or 80.2% of the population have completed their vaccination regime. Among the elderly aged 60 and above, some 44,002 individuals or 101.6% of the population have received at least one dose of the vaccine, while 41,931 or 96.8% of the population are fully immunized.
- Singapore's COVID-19 vaccination rate has increased to 96% of the eligible population and authorities are now racing ahead to administer booster shots amid concerns over the Omicron variant. The health ministry of the city-state said late on Tuesday (November 30) that it had updated the official vaccination rate to account for a small drop in the population. As of November 29, about 96% of the eligible population had completed the full vaccination regimen, updated from 94%. That translates to about 86% of the total population of about 5.5 million. So far, the country has administered boosters to 26% of the population.

#### Travel Advisories (new update/s)

- Singapore: The Ministry of Health (MOH) said on November 30 (Tuesday) that while no cases of Omicron have been detected locally, the pre-emptive measures are needed for Singapore to assess the implications of the new variant. They will also help to reduce the risk of importation of the virus. From 11:59Pm on December 2 (Thursday), air travellers arriving on the quarantine-free Vaccinated Travel Lane (VTL) scheme will have to undergo supervised, self-administered antigen rapid tests at a Quick Test Centre on days three and seven of their arrival. Currently, these travellers have to take a Covid-19 swab test only prior to their departure for Singapore and after arrival here. Second, all air travellers entering, transferring or travellers from Hong Kong, Macau, China and Taiwan are not required to take pre-departure test within two days of leaving for Singapore. Currently, travellers from Hong Kong, Macau, China and Taiwan are not required to take pre-departure tests, and need to take a Covid-19 swab test only upon arrival. These places are in Category I of MOH's risk classification framework, which means they have the lowest risk of COVID-19 infections. Third, all travellers must take a Covid-19 polymerase chain reaction (PCR) test on arrival. This will affect non-VTL travellers entering Singapore who are not from Hong Kong, Macau, China and Taiwan. Currently, they do not have to take a test upon arrival, but have to be tested before the end of their stay-home notice period. MOH said that it will also conduct a one-time PCR testing exercise for surveillance purposes, for travellers who arrival. These tightened restrictions will be in place for four weeks and will be reviewed or extended if necessary.
- Indonesia: The Indonesian government expanded the entry ban on foreigners with travel histories in 10 countries (South Africa, Botswana, Angola, Zambia, Zimbabwe, Malawi, Mozambique, Namibia, Eswatini, and Lesotho) and Hong Kong in the last 14 days. The Southeast Asian country has also suspended and limited the issuance of visit and stay visas for residents of the 11 areas. A 14-day quarantine will be applied to Indonesians with travel histories in the cited places having reported the Omicron variant.
- Myanmar: Country's Foreign Ministry on November 30 (Tuesday) announced the further extension of entry restrictions for travellers until the end of December to curb the spread of COVID-19. According to the announcement, the issuance of all types of visas and visa exemptions services will also be suspended until December 31. The extension will be applied to all orders, announcements, and directives previously issued by the respective union level government organizations and ministries, the committee said in the statement.

#### Cases and Deaths as of 01 December 2021

- As of 01 December 2021 (2PM, GMT+8), worldwide, there were **263,294,527** confirmed cases, including **5,237,809** deaths. Globally, Case Fatality Rate (CFR) was **2.0**.
- In China, there were 127,860 confirmed cases with 5,697 deaths, including deaths in Hong Kong (213) and Taiwan (848). Confirmed cases in China include confirmed cases in Hong Kong (12,437) and Taiwan (16,601). CFR was 4.5..
- 14,070,697 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 291,842 deaths, with a CFR of 2.1.
