COVID-19: Highlights and Situation Overview

Global Update

• Worldwide, there have been over 251 million cases and over 5 million deaths attributed to COVID-19.

Regional Update

- Brunei's Prime Minister's Office and Minister of Finance and Economy minister said on November 9 that businesses such as restaurants, • cinemas and salons will be allowed to re-open for fully vaccinated individuals starting November 19, as the country moves into the Transition Phase. The minister said that the Transition Phase will begin as soon as the Sultanate achieves full vaccination coverage of 70% of the total population of the country by November 19. In addition, gatherings in public places, such as sport facilities will be allowed, and commercial premises such as restaurants, cafes, food courts, cinemas, arcades, indoor playgrounds, beauty premises (such as salons and barber shops), markets and tamu will be permitted for individuals who are fully vaccinated. Mosques, suraus and religious halls nationwide will also be re-opened with attendance limits to be determined by suitable numbers based on physical distancing. The management of premises is required to ensure that their employees are to be fully vaccinated, as well as to update the list of workers in the Bruhealth app. QR code requirements remain in effect, with premises still needing to register their QR codes and to ensure all individuals entering scan the code with their BruHealth app. The minister reminded that premises must ensure that only individuals with green or yellow Bruhealth codes are allowed to enter, and that premises must ensure the wearing of face masks except when eating and drinking. Gatherings in private homes during the Transition Phase, is permitted for individuals who have completed their vaccinations and is limited to only 10 to 30 people depending on the size of the residence. Some schools will also re-open for individuals who have completed their vaccinations and are conducting ART screening tests at regular intervals of every two weeks such as higher education institutions, technical and vocational schools, and driving schools. The minister said mandatory vaccination requirements also extends to the teaching workforce, non-teaching school staff, guardians at school, children's daycare centres, trainers and so on, except those who have been exempted due to health conditions such as allergies.
- Singapore has donated 200,000 antigen rapid test kits, 500,000 nasopharyngeal swabs and 100,000 tubes of phosphate buffered saline to Vietnam. The Ministry of Foreign Affairs (MFA), in a statement on November 9 (Tuesday) said that the symbolic handover ceremony of the donation was conducted by MFA Permanent Secretary Chee Wee Kiong and Vietnam Vice-Minister of Foreign Affairs Nguyen Quoc Dung. MFA said that the donations are part of the mutual contributions of medical supplies and equipment between Singapore and Vietnam since the beginning of the pandemic.
- Thailand government has presented medical supplies worth 2.5 million THB (75,000 USD) to help Vietnam in the fight against the COVID-19 pandemic. A hand-over ceremony was held at the headquarters of the Thai Ministry of Foreign Affairs in Bangkok on November 9. In his remarks, Permanent Secretary of the Thai ministry and President of the Thailand-Vietnam Friendship Association affirmed that Thailand will always stand side by side with Vietnam in difficult times, and expressed a hope that the two countries will soon contain the pandemic and recover their economies. Apart from the donations, Thai firms investing in Vietnam have also joined hands with the Vietnamese Government in the pandemic fight, raising millions of US dollars in support of the country's COVID-19 vaccine fund, and presenting medical equipment and necessities to Vietnamese localities.

 Indonesian government has decided to extend the implementation of public activity restrictions (PPKM) outside the islands of Java and Bali from November 9 to November 22. The coordinating minister for Economic Affairs stated that the criteria for determining PPKM level in this period include not only the assessment level of pandemic situation but also first dose vaccination coverage, adding that the regions with a coverage lower than 50% will have their PPKM assessment increased by one level.

Vaccine Update

- Malaysia reported that 95% or over 22.2 million of Malaysia's adult population have completed their COVID-19 vaccination as of November 9. Based on the Ministry of Health's data on the CovidNow portal, 97.6% of the adult population, or 22.8 million individuals, have received at least one dose of the vaccine. A total of 116,642 doses of vaccine were administered on November 9 alone, with 30,700 having completed two doses, 7,877 first dose recipients and 78,065 booster doses, bringing the total number of doses administered under the National COVID-19 Immunization Programme (NIP) to 50,656,181. As for teenagers aged 12 to 17, a total of 2,413,991 individuals or 76.7% of them have completed the vaccination, while 86.5% or 2,722,418 individuals have received at least the first dose of the vaccine. On the administration of booster dose, a total of 644,664 doses had been administered as of yesterday.
- Vietnam's Ministry of Health on November 10 has granted conditional approval of Covaxin COVID-19 vaccine produced by India's Bharat Biotech International Limited. The vaccine is formulated from an inactivated SARS-CoV-2 antigen and is presented in single dose vials and multidose vials of 5, 10 and 20 doses. The ministry also gave detailed conditions going along with the approval of the vaccine for emergency use in COVID-19 prevention and control. So far, Vietnam has approved nine COVID-19 vaccines namely AstraZeneca, SputnikV, Janssen, Spikevax, Comirnaty, Vero Cell, Hayat – Vax, Abdala, and Covaxin. As of November 9 (Tuesday), 31.6 million or 32.8% of the total population have received at least one dose of COVID-19 vaccine, while 30.3 million individuals or 31.4% of the total population have completed the vaccination regime, bringing the total of COVID-19 vaccine doses administered in the country to 61.9 million.

Travel Advisories (new update/s)

- Malaysia: Malaysia and Indonesia have agreed to implement a travel corridor between the two countries through a Travel Corridor Arrangement or Vaccinated Travel Lane (VTL). Malaysia's Prime Minister said that the relevant ministers will refine the arrangements so that the border between the two countries, involving the Kuala Lumpur-Jakarta-Kuala Lumpur and Kuala Lumpur-Bali-Kuala Lumpur routes.
- Vietnam: Vietnam's Immigration Department has announced another automatic stay extension for foreigners stranded in Vietnam due to the pandemic until November 30, 2021. The measure applies to those who entered since March 1, 2020, allowing them to leave the country without any penalty or official procedures. Those that have entered prior to March 1, 2020, are also eligible provided they show documents by their embassies or by Vietnamese authorities to confirm they were quarantined or treated for COVID-19.

Cases and Deaths as of 10 November 2021

- As of 10 November 2021 (2PM, GMT+8), worldwide, there were **251,862,856** confirmed cases, including **5,053,968** deaths. Globally, Case Fatality Rate (CFR) was **2.0**.
- In China, there were 126,783 confirmed cases with 5,697 deaths, including deaths in Hong Kong (213) and Taiwan (848). Confirmed cases in China include confirmed cases in Hong Kong (12,370), Macau (77), and Taiwan (16,451). CFR was 4.5.

• 13,445,066 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 282,332 deaths, with a CFR of 2.1.
