COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 225 million cases and over 4 million deaths attributed to COVID-19.
- According to the World Health Organization (WHO), the global number of new cases has remained stable over the past month. Between August 30 to September 5, the largest increase in the proportion of new cases (19%) was reported in the region of the Americas. The largest increase in the proportion of new deaths was reported in the regions of the Americas and Europe. In addition, during the same period, the regions of Africa, South-East Asia, and the Eastern Mediterranean experienced a decline in newly reported cases. Based on the BlueDot COVID-19 Data Suite, as of September 9, the top five countries with the highest seven-day rolling average number of daily new cases are the United States, United Kingdom, India, Iran, and Turkey. The top five countries/overseas collectivities with the highest seven-day rolling average number of daily new cases per million population are Grenada, Mongolia, Guam, Montenegro, and Bermuda.
- As of September 9, North and Central America is the continent with the largest proportion of countries (27%, or 11 out of 41) with a high incidence rate (>350 cases per 100,000 over the past 14 days) and a stable or increasing trend in daily new cases over the last seven days. Europe has the highest proportion of countries (31%, 16 out of 51) with a low (<=140 cases) to moderate (140.1 - 350 cases) incidence rate and an increasing trend in new cases over the last seven days. South America is the continent with the highest proportion of countries (71%, 10 out of 14) reporting a low incidence rate (<= 140 cases) with a stable or decreasing trend in new cases.

Regional Update

- Singapore's Education Minister said that all primary school pupils will be given three antigen rapid test (ART) kits starting September 13 (Monday) as they return from their September holiday break. The decision was part of the four-pronged approach set out by Education Ministry to keep schools safe. The approach also includes keeping children at home if they are unwell, safe management measures in schools, and ring-fencing of known COVID-19 cases and contacts. However, co-curricular activities (CCAs) will remain suspended, and safe management measures such as mask wearing and good personal hygiene practices will continue. The minister also urged everyone to encourage family and friends to be vaccinated to minimize the risks to children who cannot be vaccinated yet.
- Vietnam's COVID-19 outbreak epicenter Ho Chi Minh City will extend its restrictions. Ho Chi Minh City authorities said an extension until the end of September was necessary to isolate clusters, speed up inoculations and prevent hospitals being overwhelmed. However, authorities allowed the resumption of take-away and food delivery from restaurants and eateries between 6:00AM and 6:00PM from within each district. Eateries can only use online delivery services. The city has also allowed supermarkets, grocery stores, and pharmacies to open.

Vaccine Update

- As of September 9, a total of 10 countries accounted for 72% of all vaccinations administered globally. The top five countries/territories with the highest number of cumulative people vaccinated with at least one dose per 100,000 population are Gibraltar (118,000), Palau (95,930), United Arab Emirates (88,200), Portugal (86,380), and Iceland (81,580). The top five countries/territories with the lowest number of cumulative people vaccinated with at least one dose per 100,000 population are the Democratic Republic of the Congo (90), Haiti (300), Chad (310), South Sudan (470), and Tanzania (500).

- Malaysia's Special Committee on COVID-19 Vaccine Supply (JKJAV) reported a total of 227,476 vaccine doses administered on September 12. JKJAV said that out of this number, 76,346 people received the first dose while the remaining 151,130 received the second dose. This means that cumulatively, 38,488,051 doses have been administered since vaccinations began. 21,372,276 or 91.3% of the adult population has received the first dose while 17,177,911 or 73.4% of the adult population has been fully vaccinated.
- Embassy in Myanmar said in a statement that four million more doses of China's Sinopharm COVID-19 vaccines arrived in Myanmar's Yangon on September 12 (Sunday). So far, China has supplied 12.6 million doses of COVID-19 vaccines to Myanmar, of which 3.9 million doses were donated by China. According to Myanmar's Ministry of Health on September 12, over 3.23 million people have been fully vaccinated nationwide, while over 1.7 million people have received the first jab of COVID-19 vaccines as of September 11.
- Thailand administers over 40 million doses of COVID-19 vaccines. A data from the Center for COVID-19 Administration (CCSA) showed that nearly 40% of the country's population have received their first dose of the COVID-19 vaccine, while 18% have been fully vaccinated. Thailand aims to inoculate 70 percent of its population by the end of this year.
- Cambodia's national COVID-19 vaccination commission reported that the country has so far vaccinated over 97% of the adult population of 10 million. The country has also inoculated nearly 1.7 million children, or 86% of 12-17 age group of nearly two million.

Travel Advisories (new update/s)

- Thailand: Thailand plans to reopen Bangkok to fully vaccinated visitors in October. The Tourism Authority of Thailand said that from October 1, fully jabbed foreign travellers will be able to visit Bangkok and four other provinces without undergoing two weeks' hotel quarantine. Instead, the five areas – also including Chiang Mai, Chon Buri, Phetchaburi and Prachuap Khiri Khan provinces – are expected to follow a "sandbox" model of the type piloted since July in the holiday island of Phuket. Under the sandbox scheme, tourists have to stay within a certain area for seven days after arrival and take COVID-19 tests.

Cases and Deaths as of 13 September 2021

- As of 13 September 2021 (2PM, GMT+8), worldwide, there were **225,802,311** confirmed cases, including **4,648,957** deaths. Globally, Case Fatality Rate (CFR) was **2.1**.
- In **China**, there were **123,496** confirmed cases with **5,687** deaths, including deaths in Hong Kong (212) and Taiwan (839). Confirmed cases in China include confirmed cases in Hong Kong (12,146), Macau (63), and Taiwan (16,088). CFR was **4.6**.
- 10,974,950 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **242,750 deaths**, with a CFR of **2.2**.




