COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 458 million cases and over 6 million deaths attributed to COVID-19.
- Based on the BlueDot COVID-19 Data Suite, as of March 10, the top five countries with the highest seven-day rolling average number of daily new cases are South Korea, Vietnam, Germany, Russia, and the Netherlands. The top five countries with the highest seven-day rolling average number of daily new cases per million population are Brunei Darussalam, Iceland, South Korea, Hong Kong, and Liechtenstein. As of March 10, Europe is the continent with the largest proportion of countries (53%, or 27 out of 51) with a high incidence rate (>350 per 100,000 over the past 14 days) and a stable or increasing trend in daily new cases over the last seven days. South America has the highest proportion of countries (14%, or 2 out of 14) with a low (<=140) to moderate (140.1 - 350) incidence rate and an increasing trend in new cases over the last seven days. Africa has the highest proportion of countries (77%, or 43 out of 56) reporting a low incidence rate (<= 140) with a stable or decreasing trend in new cases. Of note, many countries may be underreporting cases due to limited or restricted testing capacity and limited reporting of at-home rapid antigen tests. According to the BlueDot COVID-19 Data Suite, on February 1, the seven-day rolling average number of daily new cases reached a peak of 197,232 cases, while the seven-day rolling average number of new deaths sat at 360 new deaths. Subsequently, both cases and deaths fell to their lowest point on February 27. However, as noted by the United Kingdom Health Security Agency's (UKHSA) Weekly national Influenza and COVID-19 surveillance report which contains data up until March 6, COVID-19 case rates have been increasing across the country for all ethnic and age groups when compared to the previous week, while COVID-19 deaths (a lagging indicator) continued to decrease. The BlueDot COVID-19 Data Suite shows that the seven-day rolling average number of daily new cases as of March 10, was 54,754 new cases and the seven-day rolling average number of new deaths was 104 deaths. Both numbers show a drop following the early February peak yet remain highly elevated as compared to the previous wave. The UKHSA report has also shown that for Pillar Two (swab testing for the wider population outside of Public Health England labs and National Health Service Hospitals), the test positivity is approximately 22.5%; a high-test positivity such as this suggests that there likely is underreporting and many more cases amongst the public. In a statement from the UK Scientific Advisory Group for Emergencies updated on February 11, when modelling the COVID-19 situation in the UK, the group moved away from focusing on hospital occupancy and towards hospital admissions. This was due to the relation between Omicron infections and shorter length of hospital stays. This meant that milder infections were not being accurately estimated. The UKHSA reports that between February 28 and March 6 the weekly hospital admission rate for COVID-19 increased from 9.84 per 100,000 to 11.26 per 100,000, when compared to the previous week. It was noted that the highest hospital admission rate was within the cohort aged 85 years and older.
- The European Centre for Disease Prevention and Control (ECDC) has reported for the week ending on March 6, that the European Union and European Economic Area (EU/EEA) overall had a high yet decreasing case rate. Looking at countries within the EU/EEA specifically, a few countries such as Liechtenstein, Austria and the Netherlands are showing increasing trends, which, similar to the United Kingdom (UK), are not included in the ECDC report. It is noted that most countries appear to have passed the peak of the Omicron wave, however, this is trend is blurred given that many countries have changed their population testing strategy and shifted to focusing on severe cases.
- The World Health Organization (WHO) technical lead of COVID-19, Dr. Maria Van Kerkhove, said that they think "Deltacron" is a result of contamination that has happened during the sequencing process. She, however, clarified saying that it's possible for an individual to be

infected with different variants of SARS-CoV-2. The WHO technical lead also stated that there have been examples of coinfection, in which people were infected with both influenza and COVID-19 "throughout this pandemic."

 China is currently battling their worst COVID-19 outbreak for two years as cases double in 24 hours. China reported nearly 3,400 COVID-19 cases on March 13, double of March 12, forcing the authorities to temporarily lock down individual schools, businesses, restaurants and malls over close-contact fears in Shanghai and lock down several north-eastern cities. Almost 19 provinces in the China are battling Omicron and Delta variants driving local authorities to ramp up efforts to contain infections.

Regional Update

• Singapore will implement streamlined COVID-19 safe management measures starting March 15. The streamlined rules will focus on five areas - group sizes, mask-wearing, workplace requirements, safe distancing and capacity limits. The maximum group size for social gatherings remains at five. But as previously announced, the maximum number of unique visitors per household will be adjusted from five people per day, to five people at any one time. Wearing a mask will continue to be the default but distancing will no longer be required although it is encouraged. Safe distancing is still a must when masks are not worn, and the required distance will be fixed at 1m for all settings. For event sizes, they will be set based on the capacity of the venue. Specific size limits for events like religious services, business events, funerals, solemnizations, wedding receptions and mask-on classes will be lifted. For settings or events with 1,000 people or fewer, these can proceed without being subject to any capacity limits, but for large events and settings with more than 1,000 people, a capacity limit of 50% will be imposed "as a precaution" due to "greater infection risks". The total number of daily COVID-19 cases in the country has dipped below 10,000 for the first time in about a month, with 9,701 new cases reported on March 13 (Sunday) and 6 new deaths, bringing the total number of cases and deaths to 939,436 and 1,145, respectively.

Vaccine Update

- A total of 10 countries accounted for 67.1% of all vaccinations administered globally as of March 10. The top five countries with the highest number of cumulative people fully vaccinated per 100,000 population are Gibraltar (121,570), United Arab Emirates (95,430), Portugal (92,590), Brunei Darussalam (91,610), and Singapore (90,460). Conversely, the five countries with the lowest number of cumulative people fully vaccinated per 100,000 population are Burundi (70), the Democratic Republic of the Congo (480), Chad (840), Haiti (910), and Yemen (1,260).
- Based on Malaysia's CovidNow portal, a total of 22,934,957 individuals or 97.5% of the group have completed COVID-19 vaccination, 23,211,514 individuals or 98.7% have received at least one dose of the vaccine, and 15,280,702 individuals or 64.9% have received a COVID-19 booster dose as of March 13 (Sunday). In addition, a total of 2,837,197 individuals or 91.2% of the adolescent population aged 12 to 17 have been fully vaccinated against COVID-19 while 2,937,206 or 94.4% of the group have received at least one dose of the vaccine. For children aged five to 11, a total of 1,167,019 individuals or 32.9 per cent of the group have received the first dose of the COVID-19 vaccine under the National COVID-19 Immunization Programme for Children (PICKids). On Sunday, a total of 45,025 doses of vaccine were administered, with 23,489 as first doses, 1,349 as second doses and 20,187 as booster doses, bringing the cumulative total vaccine doses dispensed under the National COVID-19 Immunization Programme (PICK) to 68,159,756.

• In Philippines's, Sinovac's COVID-19 vaccine, will be administered to children after the country's Food and Drug Administration (FDA) granted the vaccine an emergency use authorization (EUA) amendment. The FDA approved the vaccine's use for children aged six and above, and the second vaccine to be granted an EUA for children below 12 years old.

Travel Advisories (new update/s)

• Singapore: Starting March 15 (Tuesday), travellers on vaccinated travel lanes or arriving from places with low infection rates will only need to do an unsupervised self-swab antigen rapid test (ART) within 24 hours of entering Singapore. Travellers will have to report the unsupervised self-swab ART test result via sync.gov.sg before proceeding with their activities in Singapore. Travellers will also have to take a pre-departure test within 2 days before leaving for Singapore.

Cases and Deaths as of 14 March 2022

- As of 14 March 2022 (2PM, GMT+8), worldwide, there were **458**, **381**, **242** confirmed cases, including **6,073,655** deaths. Globally, Case Fatality Rate (CFR) was **1.3**.
- In China, there were 811,283 confirmed cases with 9,218 deaths, including deaths in Hong Kong (3,729) and Taiwan (853). Confirmed cases in China include confirmed cases in Hong Kong (674,447), Macau (82) and Taiwan (21,288). CFR was 1.1.
- 24,400,348 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 332,987 deaths, with a CFR of 1.4.
