COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 208 million cases and over 4 million deaths attributed to COVID-19.

Regional Update

- Malaysia permitted business to resume operations starting today (August 16) as the country moves to ease COVID-19 restrictions in the economic sector. According to the Prime Minister on August 15, the loosened curbs follow "early positive signs" that the national immunization programme are bearing good results. He noted that the admission rate of COVID-19 patients to hospitals across all age groups has begun to decline in the Klang Valley and in several other areas.
- The Philippines' Department of Health (DOH) said on Sunday (August 15) it has detected the first case of COVID-19's Lambda variant in the country and reminded the public to strictly observe minimum public health standards. The country recorded 14,749 new COVID-19 cases on August 15, its second-largest daily increase, bringing the total confirmed infections to 1.74 million. Meanwhile, according to DOH today (August 16), the highly contagious COVID-19 Delta variant has already been detected in all regions in the country, except the Caraga region. However, DOH is already assuming that the Delta variant is already present in the said region since the genomic biosurveillance capability of the country does not cover "that much of the population". The Philippines has so far detected a total of 809 Delta variant cases, after the Department of Health announced the detection of additional 182 cases on August 25.
- Vietnam's Ho Chi Minh City will extend its social distancing status by another month until September 15 to curb further transmission of COVID-19. The decision to continue the social distancing campaign was made on August 15 (Sunday) as the city completed 30 days of semi-lockdown under Directive 16 and recorded 149,286 COVID-19 cases. It had previously gone a social distancing campaign under Directive 15 for 40 days. Directive 16 requires people to stay home and only go out for basic necessities like buying food or medicines or to work at factories or businesses allowed to operate. The city continues to require people not to leave their homes from 6PM to 6AM the next day except in the following cases: vaccination, emergency, forces in charge of pandemic prevention, those authorized by the local authorities, employees of supermarkets, convenience stores.

Vaccine Update

- Malaysia's Special Committee on COVID-19 Vaccine Supply (JKJAV) reported that the country has administered 415,875 COVID-19 vaccine doses on August 15 (Sunday). JKJAV said that 143,671 people received their first dose while another 272,204 completed both doses. Johor administered the most first doses with 27,085, followed by Selangor (22,060), Sabah (19,624) and Terengganu (15,910). In Selangor, 71,724 received their second dose, followed by Kuala Lumpur (42,165), Johor (34,759) and Sabah (23,351). According to JKJAV, Malaysia has administered a total of 27,810,855 Covid-19 vaccine doses since the start of the National COVID-19 Immunization Programme. It also reported that 72.9% of the country's adult population had received at least one dose while 45.9% of the adult population had received both doses.
- Vietnamese Government has agreed to buy another 20 million doses of the Pfizer-BioNTech COVID-19 vaccine, as part of the deal for 31 million doses of the vaccine by the Ministry of Health in May. The Ministry of Health will be responsible for the purchase of the vaccine as

soon as possible as Vietnam projected to vaccinate 70% of its population against COVID-19 to achieve herd community by early next year. Vietnam received the first one million of Pfizer doses in July, while another three million are set to be delivered this month. The remaining 47 million doses are expected to be delivered in fourth quarter of the year. Earlier in June, Vietnam also agreed to buy 30 million doses of the AstraZeneca COVID-19 vaccine from the Vietnam Vaccine Joint Stock Company (VNVC). Vietnam has so far received 19 million doses of COVID-19 vaccine from the deal with VNVC, the global vaccine access mechanism COVAX, and as support from other nations. This consists of 11.5 million doses of AstraZeneca vaccine, 12,000 doses of Sputnik V, 746,000 doses of Pfizer, more than 5 million doses of Moderna, and 1.5 million doses of Sinopharm vaccine. As of August 14, more than 13.7 million individuals have received at least one dose and more than 1.2 million have been fully vaccinated.

Travel Advisories (no new update/s)

Cases and Deaths as of 16 August 2021

- As of 16 August 2021 (2PM, GMT+8), worldwide, there were **208,258,138** confirmed cases, including **4,379,009** deaths. Globally, Case Fatality Rate (CFR) was **2.1**.
- In **China**, there were **122,328** confirmed cases with **5,669** deaths, including deaths in Hong Kong (212) and Taiwan (821). Confirmed cases in China include confirmed cases in Hong Kong (12,034), Macau (63), and Taiwan (15,852). CFR was **4.6**.
- **8,699,784 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **188,766 deaths**, with a CFR of **2.2**.




COVID-19 Epi curve among ASEAN Countries

as of 15 August 2021


