COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 228 million cases and over 4 million deaths attributed to COVID-19.

Regional Update

- Vietnam's Ho Chi Minh (HCM) City will continue to impose social distancing until the end of September, but ease the lockdown in some districts where the situation is stable. At a press conference in the city, vice-chairman of Ho Chi Minh City People's Committee said that the city's plan on measures to prevent and control the COVID-19 pandemic in the city from September 16 to September 30, was to continue to apply social distancing and other tough pandemic prevention measures throughout the city under Directive No. 16 of the Prime Minister. For the areas where the pandemic has been basically controlled, which are District 7, Cu Chi district, Can Gio District, processing zones, industrial parks in these districts and hi-tech parks, people are allowed to go to the market once a week. In addition, the city also piloted the implementation of the COVID-19 Green Card associated with a personal QR code. The pilot still has to ensure the implementation of the 5K message and periodic antigen testing.
- Malaysia's National Security Council (MKN) director-general has announced that the enhanced movement control order (EMCO) will be implemented in Kampung Paya Mengkuang, Sanggang in Temerloh, Pahang from September 17 to September 30. He added that the decision was made after the Health Ministry's presentation on risk assessment as well as COVID-19 infection trends. Apart from that, EMCO in Kampung Dumpiring Bawah in Ranau, Sabah which was supposed to end on Thursday (September 16), has been extended until September 30.
- Laos government has extended the current nationwide lockdown for 15 more days to contain the spread of COVID-19. The lockdown will be extended until September 30 as the number of COVID-19 cases continues to rise. The Deputy Head of the Prime Minister's Office added that locally-transmitted cases of COVID-19 are on the rise in Lao capital Vientiane and other provinces, and fears that this could cause a major community outbreak as most cases involved the highly contagious Delta variant. The National Taskforce Committee for COVID-19 Prevention and Control on Thursday reported 23 new imported cases and 131 locally transmitted cases bringing the total number of COVID-19 cases in Laos to 18,059.

Vaccine Update

- Malaysia's Special Committee on COVID-19 Vaccine Supply (JKJAV) reported that a total of 17,973,545 people or 76.8% of the adult population in Malaysia have been fully vaccinated while 21,783,871 or 92.7% of the adult population had received at least one dose of vaccination, including the single-dose CanSino vaccine as of September 16. On the daily vaccination rate, 202,298 doses of vaccine of both the single-dose and double-dose regimens were administered yesterday, bringing the number of doses dispensed under the National COVID-19 Immunization Programme (PIC) to 39,685,414.
- Brunei resumed the COVID-19 first-dose vaccination on September 16 (Thursday) after receiving the Sinopharm vaccines from China. A total of 100,000 doses of Sinopharm COVID-19 vaccine and 102,400 syringes donated by the Chinese government arrived at Brunei on September 12. According to the authority of the Foreign Affairs, with the Sinopharm vaccine donation from China and the incoming AstraZeneca vaccine from Japan, at least 100,000 more people in Brunei can be fully vaccinated. The Brunei government had to

temporarily suspend the first-dose vaccination since September 1 due to shortage of supply of COVID-19 vaccines following thousands of locally transmitted cases detected since August. Meanwhile, according to Brunei's Ministry of Health, the vaccination appointment slots for those affected by the first-dose postponement will be automatically shifted and will be given priority in stages. To date, approximately 394,629 doses have been administered in the country. 237,610 or 53.81% of the population has received at least one dose of the COVID-19 vaccine while 157,022 or 35.56% of the population are fully vaccinated.

Travel Advisories (new update/s)

- Indonesia: The country is allowing foreigners holding more types of visas to enter the country as long as they are fully vaccinated against COVID-19. According to the statement on the immigration office's website, those holding the Asia-Pacific Economic Cooperation business travel cards, visitors with permits to stay for diplomatic and work purposes, as well as people having limited or permanent rights to stay can enter the country. Offshore visa applications have also been reopened as of September 16 (Thursday). Indonesia will require proof of full vaccination in visa applications, as well as a statement to ensure that the visitor will comply with all health protocols and has health insurance, or is willing to independently pay for medical costs if, in any case, travellers will get infected with COVID-19.
- Vietnam: Ho Chi Minh City will continue to issue travel permits to groups of people who are allowed to travel. The travel permits issued by the city police will continue to be valid until September 30, 2021.

Cases and Deaths as of 17 September 2021

- As of 17 September 2021 (2PM, GMT+8), worldwide, there were **228,080,837** confirmed cases, including **4,782,352** deaths. Globally, Case Fatality Rate (CFR) was **2.1**.
- In **China**, there were **123,821** confirmed cases with **5,688** deaths, including deaths in Hong Kong (213) and Taiwan (839). Confirmed cases in China include confirmed cases in Hong Kong (12,150), Macau (63), and Taiwan (16,115). CFR was **4.6**.
- 11,265,166 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **248,714 deaths**, with a CFR of **2.2**.




