

COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 420 million cases and almost 5.9 million deaths attributed to COVID-19.

Regional Update

- Vietnam's Ministry of Health issued its latest guidance on COVID-19 diagnosis and treatment. Accordingly, the patients with no or mild symptoms eligible for home treatment will be no longer subject to quarantine or treatment after seven days if the result of their rapid antigen test, conducted by a health worker or by themselves under a health worker's supervision, turns out negative. If the test result remains positive for the coronavirus SARS-CoV-2 after seven days, the quarantine period will be extended to 10 days for the fully vaccinated individuals and 14 days for those who are not. Healthcare stations in the places managing patients are responsible for certifying their COVID-19 recovery. Meanwhile, the Drug Administration of Vietnam (DAV) under the Ministry of Health on February 17 (Thursday) issued the list of three COVID-19 treatment drugs containing the active ingredient Molnupiravir, which had been granted certificates of registration for conditional circulation. The three drugs are Molravir produced by Boston Vietnam Pharma; Movinavir manufactured by Mekophar Chemical Pharmaceutical; and Molnupiravir Stella produced by Stellapharm J.V Co., Ltd. The DAV also asked the Ministry of Health in provinces and centrally-run cities to direct local medical examination and treatment facilities, medical staff, and drug supply establishments to notify patients of the benefits and risks when using these drugs, treatment methods, other drugs that can replace Molnupiravir in treating COVID-19.
- Singapore's Ministry of Health announced that people who have been identified as close contacts of COVID-19 cases will soon have their self-monitoring and self-test period reduced from seven days to five days. This comes under a revised measure called health risk notice (HRN) which will be initiated on February 18 (Friday). The health risk notice will replace the current health risk warning (HRW) that's issued by the Ministry of Health (MOH) for close contacts of COVID-19 cases. However, those who have already received HRWs should still complete their existing monitoring periods. The Ministry of Health said that the decision to reduce the self-monitoring period comes as individuals infected with the Omicron variant have shown to have a shorter incubation period.

Vaccine Update

- Based on Malaysia's CovidNow portal, a total of 22,941,779 individuals or 97.5% have completed the vaccination and 23,218,655 or 98.7% received at least one dose of the vaccine, while a total of 13,728,147 or 58.3% of the adult population in the country have received the booster dose as of February 17 (Thursday). For adolescents aged between 12 and 17, a total of 2,797,767 individuals or 89.9% of the group have completed the vaccination, while 2,880,352 or 92.6% have received at least one dose of the vaccine. A total of 341,960 or 9.6% of the child population involving children aged between five and 11 years in Malaysia have received the first dose of the COVID-19 vaccine under the National COVID-19 Immunization Programme for Children (PICKids) as of yesterday. On Thursday, a total of 173,669 doses of the vaccine were dispensed, with 54,398 doses, including 51,556 for children aged between five and 11 years, while 1,544 doses were

given as second dose and the remaining (117,727) as booster dose, bringing the cumulative number of vaccine doses administered under PICK to 65,702,191.

Travel Advisories (new update/s)

- Vietnam: According to the new regulations issued by the Ministry of Culture, Sports and Tourism on February 17 for the second phase of the pilot programme, foreign visitors and overseas Vietnamese returning home can take regular commercial flights, instead of charter flights, starting March 15 when Vietnam fully reopens tourism activities. Accordingly, travellers who are tested negative for COVID-19 by the RT-PCR method after the first three days of their tours are allowed to visit places in provinces and cities which are permitted to welcome international holidaymakers, namely Quang Ninh, Da Nang, Quang Nam, Khanh Hoa, Phu Quoc, Binh Dinh and Ho Chi Minh City. Travellers also need travel insurance that covers COVID-19 treatment with a minimum liability of USD 20,000, as compared with USD 50,000 set earlier. Starting March 15, international travellers do not need to register for a tour, but still have to present a certificate of full vaccination or recovery from COVID-19, and negative test results before boarding (24 hours for rapid test and 72 hours for PCR test). Within 24 hours of arrival in Vietnam, travellers must have a negative test result before participating in tourism activities

Cases and Deaths as of 18 February 2022

- As of 18 February 2022 (2PM, GMT+8), worldwide, there were **420,380,052** confirmed cases, including **5,886,369** deaths. Globally, Case Fatality Rate (CFR) was **1.4**.
- In **China**, there were **158,19** confirmed cases with **5,715** deaths, including deaths in Hong Kong (227) and Taiwan (852). Confirmed cases in China include confirmed cases in Hong Kong (30,955), Macau (79) and Taiwan (19,797). CFR was **3.6**.
- **18,496,865 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **319,180 deaths**, with a CFR of **1.7**.



COVID-19 Epi curve among ASEAN Countries:



From January 1, 2021 to February 17, 2022


