### **COVID-19: Highlights and Situation Overview**

#### **Global Update**

- Worldwide, there have been over 466 million cases and over 6 million deaths attributed to COVID-19.
- The World Health Organization (WHO) said on March 16 that registered COVID-19 cases are once again rising globally, despite testing levels having dropped significantly. After falling for weeks, reported COVID-19 cases rose globally by 8% last week, with more than 11 million cases and over 43,000 new deaths registered. In the Western Pacific region, new cases last week have increased by 29%. Case numbers in the region have been rising since the end of December and the Western Pacific has now overtaken Europe as the global hotspot for detected new cases, with 5.02 million, compared to 4.99 million in Europe. WHO chief Dr. Tedros Adhanom Ghebreyesus warned that the lack of visibility due to reduced testing meant "the cases we are seeing are just the tip of the iceberg". The WHO urged all countries to remain vigilant as pandemic is not yet over.
- The World Health Organization (WHO) last week confirmed the emergence of "deltacron". As the informal name suggests, the virus comes from a combination of the delta and omicron variants. These so-called "recombinant" events involve two virus strains infecting the same cell, which then replicates. Dr. Maria Van Kerkhove, WHO's technical lead for COVID-19, said cases of deltacron have been reported in few countries adding that the levels of detection are "very low". The variant has been found in France, Denmark, Germany, the Netherlands and Belgium, according to GISAID, an international database of genomic sequences. With so few cases identified, data on the variant is limited. But experts say it is important to track such developments to document how the coronavirus changes moving forward in the pandemic. As of now, both the Centers for Disease Control and Prevention (CDC) and WHO are just tracking Deltacron and it has not been classified as a variant of interest or concern.

#### **Regional Update**

Vietnam on March 17 (Thursday) recorded 353,965 new COVID-19 cases, including over 175,000 cases from previous days added to the national database by Vinh Phuc and Hai Duong provinces. The total number of COVID-19 cases in the country has reached 7,174,423. The three localities with the highest numbers of new cases are Hai Duong (160,734 cases), Hanoi (25,311 cases) and Vinh Phuc (23,845 cases). According to the Vietnamese authority said on March 17 (Thursday) that the government would shift its COVID-19 strategy from minimizing infections to minimizing hospitalization and death risks. According to the COVID-19 prevention program issued by the government, Vietnam would fight the COVID-19 based on a risk management approach. Units however still need to be ready for any future scenarios, including a wide enough pandemic that overwhelms the nation's medical capabilities and the emergence of more dangerous variants. Based on the approach, the authority said that people will have easier access to health services and prevention protocols can minimize their impacts on people's lives.

#### Vaccine Update

Based on Malaysia's CovidNow portal, a total of 22,940,801 or 97.5% of the adult population have been fully vaccinated, 23,216,630 or 98.7% received at least one dose of the vaccine, and 15,425,524 individuals or 65.6% have received the Covid-19 booster dose, as of March 17 (Thursday). For adolescents aged 12 to 17, a total of 2,841,412 individuals or 91.3% of the group have been fully vaccinated while 2,940,403 or 94.5% received at least one dose of the vaccine. For children aged five to 11, a total of 1,221,990 individuals or 34.4% of the group have received the first dose of the Covid-19 vaccine under the National COVID-19 Immunization Programme for Children (PICKids). On March 17, a total of 46,039 doses were administered, with 13,256 as first doses, 2,166 as second doses and 30,617 as booster doses, bringing the cumulative total vaccine doses dispensed under the National COVID-19 Immunization Programme (PICK) to 68,376,641.

#### Travel Advisories (new update/s)

- Cambodia: The country has announced new measures that significantly ease pandemic-related restrictions for foreign visitors, including dropping mandatory COVID-19 tests for travelers who have been fully vaccinated travellers. Foreign travellers also no longer need to take a rapid antigen test for COVID-19 upon arrival. Visas on arrival are also being restored for entry by air, sea and land. However, travellers who are not fully vaccinated are still required to undergo a 14-day quarantine after arriving in Cambodia.
- Malaysia: Travellers from Thailand and Cambodia, who are vaccinated against COVID-19, can now enter Malaysia by air without undergoing a lengthy quarantine through the country's Vaccinated Travel Lane (VTL) scheme, which was first launched with Singapore. Malaysian's Prime Minister has recently announced that the country will fully reopen borders to vaccinated travellers on April 1. Malaysia's

VTL scheme requires those travelling from Thailand, Singapore, and Cambodia to self-isolate at their accommodation while they wait for results from an on-arrival COVID-19 test.

- Thailand: Thailand will scrap a pre-arrival COVID-free certificate requirement. According to a government authority, starting April 1, visitors to Thailand will only have to undergo an RT-PCR test upon arrival and a self-administered antigen test on day five.
- Vietnam: The country's Ministry of Culture, Sports and Tourism has issued a document on the tourism reopening plan in the new normal. Under document No. 829/PA-BVHTTD dated March 16, citizens of Germany, France, Italy, Spain, the United Kingdom, Russia, Japan, the Republic of Korea, Denmark, Sweden, Norway, Finland, and Belarus can visit Vietnam for up to 15 days without need for a visa regardless of passport type and entry purpose, on the basis of satisfying all conditions as prescribed by Vietnamese law. The waiver will last for three years, from March 15, 2022 to March 14, 2025. Foreigners, overseas Vietnamese and their relatives with valid papers, including permanent and temporary residence cards, visa and valid visa exemption certificate, are permitted to enter Vietnam without having to undergo personnel and visa procedures, or apply for entry approval of ministries, agencies and localities. Travelers entering Vietnam via air routes (except for children under two years old) only need to present proof of negative SARS-CoV-2 tests done within 72 hours prior to departure in cases of RT-PCR/RT-LAMP or within 24 hours in cases of rapid antigen tests, and the results must be certified by the authorities of the country where the tests are conducted. Those entering via road, sea, and rail will be subjected to the same requirements if their travel time is short. However, those who plan to make a long trip will need to undergo testing at border gates before entering Vietnam. If the test results are positive, they must follow guidelines of the Ministry of Health. No COVID-19 testing and mandatory guarantine are required for air travelers after their arrival. However, they must make health declaration via tokhaiyte.vn before departure and install the PC-Covid app. In the first 10 days after entry, visitors should self-monitor their health and if any symptoms develop, ask for assistance from the nearest medical facilities. Another requirement is that travelers must have health or travel insurance that covers COVID-19 treatment with a minimum liability of 10,000 USD. Passengers themselves will pay for testing, medical guarantine, health checkup and treatment fees and other related expenses (if any).

#### Cases and Deaths as of 18 March 2022

- As of 18 March 2022 (2PM, GMT+8), worldwide, there were 466,772,662 confirmed cases, including 6,084,028 deaths. Globally, Case Fatality Rate (CFR) was 1.3.
- In China, there were 1,120,650 confirmed cases with 10.336 deaths, including deaths in Hong Kong (4,847) and Taiwan (853). Confirmed cases in China include confirmed cases in Hong Kong (975,212), Macau (82) and Taiwan (21,583). CFR was 0.9.
- 25,988,220 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 335,427 deaths, with a CFR of 1.3.
