COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 334 million cases and 5.6 million deaths attributed to COVID-19.
- The World Health Organization (WHO) said on January 18 (Tuesday) that the pandemic will not end as the Omicron variant subsides in some countries, warning the high levels of infection around the world will likely lead to new variants as the virus mutates. WHO's COVID-19 technical lead, Dr. Maria Van Kerkhove, said that new infections have increased by 20% globally over the past week with nearly 19 million total reported cases. She called on governments to strengthen public health measures to bring the virus under better control and head off future waves of infection as new variants emerge.

Regional Update

- Vietnam has recorded its first three community cases of the Omicron variant and health authorities urged people to increase their vigilance due to the threat from the variant. The three positive cases were detected over the weekend in Ho Chi Minh City and confirmed as Omicron late on January 18 (Tuesday). Vietnam reported 16,838 new COVID-19 infections, bringing the cumulative COVID-19 cases in the country to 2,062,128 as of January 18. Among the new cases, 16,763 were locally transmitted and 75 were imported. The capital city of Hanoi remained the locality with highest number of infections on Tuesday with 2,935 cases, followed by northern Hai Phong city with 1,139 cases and central Da Nang city with 943 cases.
- Malaysia's Ministry of Health reported that a total of 186 new cases of the Omicron variant were detected from January 14 to January 18, bringing the cumulative number of cases involving variants of concern (VOCs) to 6,412. MOH's Director-General said that there were 5,726 cases involving Delta, 439 cases involving Omicron, 233 cases involving Beta and 14 cases involving Alpha. As for variants of interest (VOIs), there were 20 cases: 13 were Theta cases, 4 were Kappa cases and 3 were Eta variant cases. In MOH's daily COVID-19 statement, the country reported 3,245 new COVID-19 cases yesterday (January 18). 98.8% of the new cases were in Categories 1 and 2, which meant that the patients were mostly asymptomatic or had mild symptoms while the rest (1.2% or 39 cases) were in Categories 3, 4 and 5.
- Philippine Department of Health (DOH) confirmed on January 18 (Tuesday) 28,471 new COVID-19 cases, a figure lower than Monday's 37,070 cases. Tuesday's case bulletin showed a positivity rate of 43.4% from 51,738 tests performed. According to the DOH, the country has so far confirmed 3,270,758 cases of COVID-19, which include 2,933,338 recoveries and 52,962 deaths.
- Lao health authorities have eased requirements for COVID-19 patients after being discharged from hospital. According to a notice issued on January 17 by the Department of Health Care and Rehabilitation, asymptomatic patients can be discharged from hospitals 10 days after a positive test result without any further testing requirements. The release of COVID-19 patients from hospitals is now to be dependent on symptoms rather than test results, particularly in the case of asymptomatic patients. Meanwhile, patients with mild symptoms will be able to leave medical facilities after at least 13 days provided they do not have a fever or any respiratory issues. Authorities said that patients who were discharged will now be permitted to resume their usual social and work activity after leaving hospital. The new measures are part of a move by the health sector toward the "new normal" way of life, according to the notice.

Vaccine Update

- According to Malaysia's Health Ministry's COVIDNOW portal, a total of 22,909,192 or 97.9% of the adult population have completed the vaccination, while 23,188,245 individuals or 99.1% of the group have received at least one dose of COVID-19 vaccine as of January 18 (Tuesday). For adolescents aged 12 to 17, a total of 2,774,961 individuals or 88.2% have completed the vaccination, while 2,861,715 individuals or 91% have received at least one dose of the vaccine. In addition, a total of 127,066 individuals of the adult population in the country received the COVID-19 booster dose on Tuesday, bringing the the cumulative number of booster doses administered in the country to 9,744,147 or to 41.6% of the group. Meanwhile, daily statistics showed that a total of 129,597 doses of vaccine were administered on January 18, which included 1,043 as first dose and 1,488 as second dose. Overall, the cumulative number of vaccine doses administered under the National COVID-19 Immunization Programme (PICK) is 61,275,453.

Travel Advisories (new update/s)

- Vietnam: National flag carrier Vietnam Airlines resumed its regular flights to Australia since January 15 following approval from authorities. Accordingly, Australia has become the eighth international market tapped by Vietnam Airlines, following the United States, Japan, the Republic of Korea, Singapore, Thailand, Cambodia and Taiwan (China). There will be one weekly flight linking Hanoi and Sydney, and two weekly flights between Ho Chi Minh City (HCM) and Sydney, and HCM and Melbourne. To enter Vietnam, travellers currently have to show a negative RT-PCR test result for SARS-CoV-2 within 72 hours prior to their arrival, along with a negative rapid test result before and after their flights.

Cases and Deaths as of 19 January 2022

- As of 19 January 2022 (2PM, GMT+8), worldwide, there were **334,288,056** confirmed cases, including **5,577,703** deaths. Globally, Case Fatality Rate (CFR) was **1.7**.
- In **China**, there were **136,355** confirmed cases with **5,700** deaths, including deaths in Hong Kong (213) and Taiwan (851). Confirmed cases in China include confirmed cases in Hong Kong (13,066), Macau (79) and Taiwan (17,951). CFR was **4.2**.
- 15,849,098 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **310,655 deaths**, with a CFR of **2.0**.




COVID-19 Epi curve among ASEAN Countries


