COVID-19: Highlights and Situation Overview

Global Update

• Worldwide, there have been over 342 million cases and 5.6 million deaths attributed to COVID-19.

Regional Update

• Singapore's Ministry of Health (MOH) reported that the weekly COVID-19 infection growth rate rose to 2.17 on January 20 (Thursday), up from 1.96 the day before. This is the first time since September 19, 2021, that Singapore's weekly infection growth rate has gone over two. As of Thursday, Singapore has recorded a total of 297,549 COVID-19 cases, with 845 deaths. Meanwhile, there were 1,001 new cases with the Omicron variant on Thursday, down from the 1,185 cases a day earlier. Of these, 952 were local cases and 49 were imported. The co-chair of the multi-ministry task force said on Friday (January 21) that Singapore will likely see a "significant wave" of COVID-19 soon, with the more infectious Omicron variant now causing at least 70% of daily cases. Likewise, a series of measures will be implemented by the Health Ministry to prepare Singapore for the Omicron wave. This includes suspending visits to hospital wards and residential care homes for the next four weeks. MOH has also made plans to optimize healthcare resources and adjust recovery protocols. Studies by the National Centre of Infectious Diseases (NCID) have shown that although the Omicron variant is more transmissible, infected individuals carry a lower viral load and "generally recover faster". Thus, the isolation period for fully vaccinated individuals and children under 12 years old will be reduced from 10 to 7 days.

Vaccine Update

According to Malaysia's Health Ministry's COVIDNOW portal, a total of 22,913,483 or 97.9% of the adult population have completed vaccination, while 23,191,008 individuals or 99.1% of the group have received at least one dose of COVID-19 vaccine as of January 20 (Thursday). For adolescents aged 12 to 17, a total of 2,778,389 individuals or 88.3% have completed vaccination, while 2,863,086 individuals or 91% have received at least one dose. The daily statistics also showed that a total of 234,983 doses of vaccine were administered on Thursday, which included 1,641 as first dose, 3,322 as second dose, and 230,020 as booster dose, bringing the cumulative number of vaccine doses administered under the National COVID-19 Immunization Programme (NIP) to 61,778,396. Meanwhile, Malaysia's COVID-19 vaccination programme for children aged 5 to 12 will begin on February 3. According to the Health Minister, parents can book appointment slots via MySejahtera beginning January 31 and the process will be in phases which starts in the Klang Valley area. He added that the programme will utilize a special vaccine formulation for children, which is by Pfizer, and will be a two-dose regime with an eight-week interval. Each dose will be 0.2ml and contains 10 micrograms of mRNA vaccine.

Travel Advisories (new update/s)

• Malaysia: The Ministry of Health (MOH) has decided to reopen the Vaccinated Travel Lane (VTL) with Singapore that was suspended from December 23, 2021 until January 20, 2022. In a statement, MOH said that the VTL land and air schemes will resume starting today (January 21). Meanwhile, Malaysia also announced on January 20 (Thursday) that the government reduced quarantine period to five

days from the previous seven for arrivals who had received booster shots of the COVID-19 vaccines. Malaysian Minister of Health explained that the new ruling was made after the surveillance and observation period based on data, science and experiences from other countries. He added that travelers will have to undergo an RT-PCR test, conducted within two days before the departure date, with a negative result. The RT-PCR test will also be performed on the day of arrival at the international entry points. However, for asymptomatic patients and travellers who have not received a booster dose but have been fully vaccinated, the quarantine period is seven days.

- Singapore: The Ministry of Health (MOH) announced today (January 21) that the testing regime for travellers entering Singapore via both vaccinated travel lane (VTL) air and land checkpoints will be simplified. Starting January 23 (Sunday), 11:59PM, VTL travellers will only be required to do unsupervised self-administered antigen rapid tests (ART) if they need to leave their accommodation from Days 2 to 7 of their arrival. Travellers need not submit their ART results, but must test negative before going out. On the other hand, VTL travellers who arrive before 11:59pm on Sunday are still required to continue with the existing testing regime. This means an unsupervised self-administered ART on Days 2, 4, 5 and 6 with submission of results online, and supervised ART on Days 3 and 7 from their arrival. Travellers who test positive on ARTs via the on-arrival test for VTL-Land and unsupervised self-administered ARTs on Days 2 to 7, no longer need to undergo a confirmatory polymerase chain reaction (PCR) test but instead, individuals should immediately stop going to work and cancel social activities, self-isolate for 72 hours at home. Meanwhile, those travellers arriving from Sunday at 11:59pm who are fully vaccinated and recently recovered (within 90 days of their last infection), will be exempted from all testing and stay-home notice requirements if they are able to provide appropriate documentary proof.
- Thailand: The country will resume its quarantine-free travel scheme for fully-vaccinated inbound visitors starting next month. The Test & Go quarantine exemption scheme was suspended from December 22 only after seven weeks of its launch due to the fast spreading of COVID-19 linked to Omicron variant. According to the spokesperson of the Center for COVID-19 Situation Administration (CCSA), starting February 1, fully vaccinated travelers will be able to enter the country under the "Test and Go" program if they undergo a RT-PCR test on arrival and spend a night in a pre-booked hotel while awaiting results, and then have a second test and hotel stay five days later. The government also currently allows entry to visitors who quarantine for seven to 10 days in approved hotels, or join "sandbox" programs in areas such as the resort island of Phuket where they have freedom of movement during a seven-day quarantine period. The move came amid the government's efforts to revive the tourism sector and boost economic recovery.

Cases and Deaths as of 21 January 2022

- As of 21 January 2022 (2PM, GMT+8), worldwide, there were **342,174,082** confirmed cases, including **5,597,459** deaths. Globally, Case Fatality Rate (CFR) was **1.6.**
- In China, there were 136,628 confirmed cases with 5,700 deaths, including deaths in Hong Kong (213) and Taiwan (851). Confirmed cases in China include confirmed cases in Hong Kong (13,096), Macau (79) and Taiwan (18,041). CFR was 4.2.
- 15,967,342 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 311,234 deaths, with a CFR of 1,9.
