COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 192 million cases and over 4 million deaths attributed to COVID-19.

Regional Update

- Indonesian President Joko Widodo said on Tuesday (July 20) that the country's COVID-19 cases have fallen and if the trend continues, the current restrictions will gradually be lifted by July 26. Indonesia had imposed COVID-19 restrictions since July 3 for the island of Java and Bali, which include curbing travel and shutting malls. People's movements are restricted according to the sectors they work in, and only employees in critical sectors such as energy and health are allowed to go back to the workplace. COVID-19 cases in Indonesia are currently among the highest globally where cases have been around 50,000 daily in the past week. On Tuesday, authorities reported 38,325 new COVID-19 cases bringing the total number of cases in Indonesia to more than 2.9 million.
- Singapore will again tighten restrictions from Thursday (July 22) as the country returns to Phase 2 (Heightened Alert) amid a spike in COVID-19 cases. This comes as several clusters linked to the Jurong Fishery Port have emerged, especially in wet markets and hawker food centres. According to the Ministry of Health, there was an average of 46 community cases detected per day specifically between July 12 and August 18. Under the restriction, dining-in will be suspended and group sizes for social gatherings will be reduced from five to two. Work-from-home will be the default at workplaces and employers must ensure that employees who are able to work from home do so. There should also be no cross-deployment of workers to multiple worksites. Congregational and other worship services may continue with up to 100 people with pre-event testing, and up to 50 people without pre-event testing. This is down from the 250 people allowed under current restrictions, with pre-event testing.
- Thailand's cabinet on Tuesday (July 20) extended the state of emergency nationwide for two months until the end of September, to cope with the local COVID-19 situation. Deputy government spokeswoman said extension was from August 1 to September 30, as proposed by the National Security Council (NSC). She added that the decision was a response to the thousands of new Covid-19 cases being recorded daily in Greater Bangkok, where the more transmissible COVID-19 variants were spreading and being carried by workers returning to their home provinces.

Vaccine Update

- The Philippines authority announced on July 21 that there about 5 million individuals who have been fully vaccinated. Presidential spokesperson also disclosed in an online press briefing that the country has already administered 15.6 million doses of different COVID-19 vaccines since the government launched its vaccination campaign in March. Additionally, he added that 10,585,261 individuals have now received their first dose while 5,031,301 of them have already received their second dose or are fully vaccinated. This Wednesday, more than 500,000 doses of the COVID-19 vaccine developed by Pfizer-BioNTech are expected to arrive in the country and that some 2.5 million doses of the COVID-19 vaccine made by China's Sinovac will also be delivered this week.
- Malaysia's Special Committee on COVID-19 Vaccine Supply (JKJAV) reported that a total of 15,071,814 doses of Covid-19 vaccine have been administered in Malaysia as of Tuesday (July 20). A total of 10,301,905 people (or 44% of the adult population) have received their

first dose while 4,769,909 (or 20.4% of the adult population) had received both doses or have been fully vaccinated. It also said that a total of 299,593 doses of Covid-19 vaccines were administered on Tuesday (July 20) where 204,064 individuals had received their first doses while another 95,529 people completed their second dose

Travel Advisories (new update/s)

- Singapore: Singapore's Ministry of Transport (MOT) said on Tuesday (July 20) that discussions on the Singapore-Hong Kong air travel bubble will resume only when the COVID-19 situation allows given the recent surge in community cases and the imposition of Phase 2 (Heightened Alert) measures in Singapore until August 18.

Cases and Deaths as of 20 July 2021

- As of 20 July 2021 (2PM, GMT+8), worldwide, there were **192,038,288** confirmed cases, including **4,116,140** deaths. Globally, Case Fatality Rate (CFR) was **2.1**.
- In **China**, there were **119,720** confirmed cases with **5,617** deaths, including deaths in Hong Kong (212) and Taiwan (769). Confirmed cases in China include confirmed cases in Hong Kong (11,959), Macau (55), and Taiwan (15,429).
- **6,193,312 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **118,983 deaths**, with a CFR of **1.9**.




COVID-19 Epi curve among ASEAN Countries

as of 19 July 2021


