COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 276 million cases and over 5 million deaths attributed to COVID-19.
- The United Kingdom (U.K), Denmark, and South Africa have released early data on hospitalizations for the past weeks paired with the rise of Omicron variant cases. The data reported from South Africa evidenced a consistently lower hospitalization rate of Omicron infections when compared with Delta variant infections, while the latest daily report from Denmark from December 20, with data aathered from November 22 to December 15, has shown that the proportion of cases with the Omicron variant that were hospitalized has been fairly similar, even slightly lower, to the proportion of those infected by other variants in the same timeframe, including Delta. However, early analyses of data from the U.K. suggest that Omicron variant does not have a lower hospitalization rate than infections caused by the Delta variant. On December 16, a preliminary risk factor analysis by the Imperial College London did not find hospitalization to be associated with infection by the Omicron variant, compared to Delta, suggesting that there are "at most limited changes in severity" of disease caused by the Omicron variant compared to Delta. It is important to note that analyses from the U.K. and Denmark were based on relatively few cases and insufficient time has elapsed for mild cases to become more severe and require hospitalization. The immunity profile of the populations in the U.K. and Denmark differs from the regions of South Africa that have been heavily infected by the Omicron variant. A large proportion of the South African population had previous exposure to other SARS-CoV-2 variants and only over 30% of the population have received one dose of a COVID-19 vaccine. In contrast, the U.K. and Denmark have a much higher vaccination coverage but relatively less exposure to SARS-CoV-2. While there is still the need for data and more robust population-based analyses to fully assess the severity of Omicron variant, it is clear that this variant is more transmissible than Delta and more easily overcomes preexisting immunity. Even if Omicron is equally or even slightly less virulent than other variants, the fact that it is more transmissible and spreads faster than Delta variant poses a significant increased risk at the population-level. With a rapid rise in new infections, an equal or smaller fraction of a larger number of Omicron cases that lead to severe outcomes (i.e., Omicron being equally or even slightly less virulent than other variants) could exceed the absolute number of cases resulting in hospitalization and/or deaths previously caused by other variants, like Delta. In such a scenario, although it could mean no noticeable difference in risk at the individual-level, the burden on the public health and healthcare system would be significant. Thus, it is highly important that we maintain vigilance while actively improving upon other mitigation efforts including the use of higher-quality masks indoors, increasing testing capacity, and improving ventilation of enclosed areas to avoid further impacts at different levels of society.
- The World Health Organization's European head on December 21 (Tuesday) warned countries to brace for a "significant surge" in COVID-19 cases as Omicron spreads, saying the variant has so far circulated mostly among young adults. Since it emerged in late November, Omicron has been detected in at least 38 of the 53 countries in the WHO's European region and is already dominant in several of them including Denmark, Portugal and the United Kingdom. According to Dr. Hans Kluge, so far, 89% of the early Omicron cases in Europe were associated with common COVID symptoms such as cough, sore throat and fever. Most cases had been reported among adults in their 20s and 30s, spreading initially in cities at social and workplace gatherings.

Regional Update

- Thailand will reinstate its mandatory COVID-19 quarantine for foreign visitors and scrap a quarantine waiver starting December 21 (Tuesday) due to concerns over the spread of the COVID-19 Omicron variant. The announcement came a day after Thailand reported the first case of local transmission of the Omicron variant. According to the senior health official, a 49-year-old-Thai woman is the first case of local infection with the Omicron variant. The woman caught the infection from her infected husband, a pilot who arrived from Nigeria on November 26.
- Singapore reported its first suspected local omicron cluster, a group of three COVID-19 infections traced to a gym. Two of the three cases in Singapore's cluster have been preliminarily confirmed as omicron, while the third is still pending. All who tested positive had no recent travel history and were fully vaccinated.

Vaccine Update

- Singapore's COVID-19 vaccination for children aged 5 to 11 will begin on December 27 (Monday). The Ministry of Education (MOE) and the Early Childhood Development Agency (ECDA) said in a statement on December 21 (Tuesday) that the vaccination exercise would open progressively to children born between 2009 and 2012, followed by those born between 2013 and 2017. The Ministry of Health (MOH) said in a separate statement earlier on Tuesday that the first shipment of pediatric doses of the Pfizer-BioNTech/Comirnaty vaccine was on its way from Europe and is expected to arrive in Singapore on Wednesday. More than 300,000 children between five and 11 years old would be covered by the immunization drive. It is open to children who are Singapore citizens, permanent residents and long-term pass holders.
- The Philippine government is allowing adults to get their COVID-19 booster shot three months after their last of a two-dose COVID-19 vaccine, cutting in half the six-month waiting time. As for adults who got the one-dose Janssen vaccine, they can get a booster two months after, from the initial three months. The new policy, announced by the Department of Health (DOH) on December 21 (Tuesday), takes effect starting December 22 (Wednesday). The DOH stressed that 12 to 17-year-olds are not yet recommended to get booster shots at this time.

Travel Advisories (new update/s)

- Thailand: The decision to halt Thailand's "Test and Go" waiver means visitors will have to undergo hotel quarantine, which ranges between 7 to 10 days. Meanwhile, a so-called "sandbox" programme, which requires visitors to remain in a specific location but allows them free movement outside of their accommodation, will also be suspended in all places except for the tourist resort island of Phuket.
- Indonesia: The government has added the United Kingdom, Norway and Denmark to the list of countries banned from entering the country due to the spread of COVID-19 Omicron variant, while Hong Kong has been removed from the list.

Cases and Deaths as of 22 December 2021

- As of 22 December 2021 (2PM, GMT+8), worldwide, there were **276,798,765** confirmed cases, including **5,390,296** deaths. Globally, Case Fatality Rate (CFR) was **1.9.**
- In China, there were 129,914 confirmed cases with 5,699 deaths, including deaths in Hong Kong (213) and Taiwan (850). Confirmed cases in China include confirmed cases in Hong Kong (12,542), Macau (77) and Taiwan (16,826). CFR was 4.4.
- 14,632,998 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 300,925 deaths, with a CFR of 2.1.
