COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 428 million cases and over 5.9 million deaths attributed to COVID-19.
- According to the World Health Organization (WHO), during the week of February 7 to 13, the global number of new COVID-19 cases decreased by 19% as compared to the number reported during the previous week, while the number of new deaths remained similar to that of the previous week. Across the six WHO regions, just over 16 million new cases and just under 75 000 new deaths were reported. As of 13 February 2022, over 409 million confirmed cases and over 5.8 million deaths have been reported globally. At the regional level, the Western Pacific Region reported an increase of 19% in the number of new weekly cases while all other regions reported decreases: the South-East Asia Region (37% decrease), the Region of the Americas (32% decrease), the African Region (30% decrease), the European Region (16% decrease) and the Eastern Mediterranean Region (12% decrease). The number of new weekly deaths increased in the Eastern Mediterranean Region (38%), the Western Pacific Region (27%), the African Region (14%) and the Region of the Americas (5%), while it remained similar to that of the previous week in the European Region and decreased in the South-East Asia Region (9%).
- In WHO's weekly epidemiological update, it was stated that the current global epidemiology of SARS-CoV-2 is characterized by the global dominance of the Omicron variant. All other variants, including VOCs (Alpha, Beta, Gamma and Delta) and VOIs (Lambda and Mu) continue to decline in all six WHO regions. Among the 432 470 sequences uploaded to GISAID with specimens collected in the last 30 days¹, 425 227 (98.3%) were Omicron, 7 191 (1.7%) were Delta and one (<0.1%) was Lambda. During this same period, there were no Alpha, Beta, Gamma or Mu sequences reported. Meanwhile, the prevalence of BA.2 among sequenced Omicron cases globally submitted to GISAID has been steadily increasing, reaching 21.09% in week 5 of 2022. As of February 14, ten countries reported a predominance of BA.2 (>50%): Bangladesh, Brunei Darussalam, China, Denmark, Guam, India, Montenegro, Nepal, Pakistan, Philippines. However, there are differences between regions observed, with the South-East Asia Region reporting the highest prevalence of BA.2 among Omicron sequences (44.7%) and the Region of the Americas reporting the lowest prevalence (1%). This analysis is based on all sequences submitted to GISAID with samples collected from January 13 to February 11, and should be interpreted with due consideration of the limitations of surveillance system.

Regional Update

- Vietnam registered a new record of 55,879 daily COVID-19 infections on February 22 (Tuesday) according to its Ministry of Health. The new infections, logged in 62 localities nationwide, which include 55,871 local cases and eight imported cases. The epidemic hotspot capital Hanoi logged its highest-ever number of daily infections with 6,860 cases on Tuesday, up 1,383. Other northern localities with high number of transmissions included Bac Ninh province with 2,842 cases and Bac Giang province with 2,500 cases. The cumulative cases in the country have now increased to 2,890,522 with 39,682 deaths.
- Thailand's Public Health Ministry on February 21 (Monday) raised its COVID-19 alert to Level 4 - the second-highest tier, following a sharp increase in Omicron variant infections nationwide. Ministry spokesman said that the government decided that the alert level will be raised

nationwide and containment measures will be stepped up in high-risk areas. Under the new alert, people are advised to work from home, avoid non-essential inter-provincial travels, suspend overseas trips, close at-risk venues, and avoid large gatherings.

Vaccine Update

- Based on Malaysia's CovidNow portal, 22,945,612 or 97.5% of the adult population have completed COVID-19 vaccination, 23,223,983 or 98.7% have received at least one dose of the vaccine, while a total of 14,176,241 or 60.3% of the adult population in the country have received the COVID-19 booster dose as of February 22 (Tuesday). As for adolescents aged 12 to 17 years, a total of 2,799,326 individuals or 90% of the group have completed the vaccination while 2,888,143 or 92.9% have received at least one dose of the vaccine. A total of 615,671 individuals or 17.3% of the child population aged between five and 11 years in the country have received the first dose of the COVID-19 vaccine under the National COVID-19 Immunization Programme for Children (PICKids) as of yesterday. On Tuesday, a total of 147,742 vaccine doses were dispensed with 51,849 as the first dose, second dose (613) and booster dose (95,280) bringing the cumulative number of vaccine doses administered under the National COVID-19 Immunization Programme (PICK) to 66,441,964.

Travel Advisories (new update/s)

- Vietnam: According to the country's Ministry of Transport (MoT), Vietnam has reopened international routes to and from 20 countries and territories. The country opened international flights to and from 28 countries and territories. Specifically, Vietnam's international routes have reopened to countries and territories including Cambodia, Hong Kong, Japan, South Korea, Malaysia, Philippines, Qatar, Singapore, Taiwan (China), Thailand, and Turkey, United Arab Emirates, Laos, mainland China, France, Germany, United Kingdom, Australia, Russia and the United States. The remaining eight countries that have not reopened flights are Brunei, India, Indonesia, Myanmar, Macau, Finland, Italy and Switzerland. The frequency of international routes to and from Vietnam is 370 flights per week per way, equivalent to 53 flights per day per way, while the frequency of international routes in the winter flight schedule in 2019 was 4,185 flights per week per way.

Cases and Deaths as of 23 February 2022

- As of 23 February 2022 (2PM, GMT+8), worldwide, there were **428,302,184** confirmed cases, including **5,930,000** deaths. Globally, Case Fatality Rate (CFR) was **1.4**.
- In **China**, there were **188,569** confirmed cases with **5,788** deaths, including deaths in Hong Kong (300) and Taiwan (852). Confirmed cases in China include confirmed cases in Hong Kong (60,363), Macau (80) and Taiwan (20,100). CFR was **3.1**.
- 19,336,192 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **321,426 deaths**, with a CFR of **1.7**.



COVID-19 Epi curve among ASEAN Countries:



From January 1, 2021 to February 22, 2022


