COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 474 million cases and over 6 million deaths attributed to COVID-19.
- According to the World Health Organization (WHO), the number of new weekly cases increased for the second consecutive week, with a 7% increase reported during the week of March 14-20, as compared to the previous week. The number of new deaths has continued a decreasing trend (-23% as compared to the previous week). Across the six WHO regions, over 12 million cases and just under 33 000 deaths were reported. At the regional level, the number of new weekly cases increased in the Western Pacific region (+21%), remained stable in the European region, and decreased in the Eastern Mediterranean (-41%), Africa (-33%), South-East Asia (-23%) and Americas (-17%) regions.

Regional Update

- Malaysia reported 21,483 new COVID-19 cases on March 22 (Tuesday), bringing the total number of COVID-19 in the country to 4,032,435. The Health Ministry's CovidNow portal reported that 21,089 of Tuesday's COVID-19 cases were local transmissions while there were 394 imported cases. Currently, there are 252,671 active COVID-19 cases with 244,262 or 96.7% undergoing home quarantine and 1,453 patients admitted to low-risk quarantine and treatment centers nationwide. The Ministry of Health Ministry said that 6,617 or 2.6% of active COVID-19 cases have been admitted in hospital wards while 339 individuals, or 0.2%, are currently being treated at intensive care units (ICUs).
- Singapore reported 13,166 new COVID-19 cases on March 22 (Tuesday), bringing the total number of COVID-19 in the country to 1,035,721. The COVID-19 weekly infection growth rate remained below one for the 21st consecutive day at 0.74. Of the local cases, 11,323 were detected through antigen rapid tests (ARTs), which means they were assessed by a doctor to have mild symptoms and of low risk while 1,602 cases were detected through polymerase chain reaction (PCR) tests. In addition, there were 241 new imported cases, of which 27 were detected through PCR tests and 214 through ARTs.
- Laos reported 2,328 new COVID-19 cases on March 22 (Tuesday bringing the total number of COVID-19 in the country to156,422. The
 National Taskforce Committee for COVID-19 Prevention and Control reported 2,306 locally transmitted cases and 22 new imported.
 Meanwhile, schools and restaurants have been closed in some provinces across Laos as the Omicron outbreak worsens from March 21
 to 25. Lao New Year celebrations have also been suspended in the district, while sporting competitions have been canceled. Likewise,
 authorities in Vilabouly District have ordered the closure of all pubs, bars, and entertainment venues, while weddings and funerals may
 not be held with more than 30 participants and a mask mandate has also been instituted in the district, with those who fail to comply
 facing fines of LAK10,000 per offense. Meanwhile, ministries and government offices in the Vientiane capital have begun issuing
 instructions for their employees to begin rotating shifts working from home.

- Thai's cabinet meeting on Tuesday (March 22) approved a proposal from the Centre for COVID-19 Situation Administration (CCSA) to extend the COVID-19 emergency degree, which will end on March 31, by two months, or from April 1 to May 31. The extension of the emergency decree aims to enable health authorities to control the spreading of COVID-19 in an efficient and continuous manner. The cabinet also approved CCSA's proposal on disease control measures during 2022 Songkran Festival to prevent the spreading of COVID-19. In this guideline, vaccinated people are allowed to travel between provinces to visit their families during Songkran holidays (April 13-17), however, people in high-risk groups or having symptoms similar to COVID-19 are advised to take COVID-19 Antigen Test Kit (ATK) test 72 hours before traveling or joining Songkran activities. All Songkran activities must be organized in designated areas approved by the provincial communicable disease committee, whereas organizers must strictly follow the Covid-free Setting practice. In addition to these measures, water splashing, face-powder daubing, and foam parties are prohibited in public areas and selling or drinking alcohol will be prohibited in Songkran activity areas. As of March 22, the government reported 21,382 new COVID-19 cases, bringing the total number of cases in the country to 3,398,792.
- Philippines continues to see declining COVID-19 cases in all regions and remain under minimal risk case classification. On March 22, the
 Department of Health (DOH) reported 290 new COVID-19 cases, bringing the total number of COVID-19 cases in the country to 3,674,983.
 According to DOH, the Omicron variant of COVID-19 remains the most dominant strain in the country based on samples that underwent
 genome sequencing. The result of the latest genome sequencing run showed that 85.9% of the 568 samples nationwide were tested
 positive for the Omicron variant from January 1 to March 18 while only one or 0.18% was positive for the Delta variant from the same
 batch of samples.

Vaccine Update

- Based on Malaysia's CovidNow portal, 22,945,101 or 97.5% of the country's adult population have been fully vaccinated, 23,221,040 or 98.7% have received at least one dose, and 15,530,830 individuals or 66% have received a booster dose. Meanwhile, 2,845,415 adolescents aged 12 to 17 or 91.5% of this age group have received both doses of a vaccine, while 2,943,210 or 94.6% have received at least one dose. A total of 1,272,121 children aged five to 11 years, or 35.8% of that age group in the country, have received their first dose of vaccine under the National COVID-19 Immunization Programme for Children (PICKids) as of March 22 (Tuesday). On March 22, a total of 28,377 doses of vaccine were administered, 5,645 as first dose, 1,357 as second dose and 21,375 as booster dose, bringing the cumulative total vaccine doses dispensed under the National COVID-19 Immunization Programme (PICK) to 68,546,897.
- Cambodia launches campaign for information dissemination throughout the country to increase awareness of health protection and prevention of COVID-19 through vaccination. The campaign's theme "The highly contagious COVID-19 Omicron variant puts you and your family at risk". Local authorities will utilize all types of media including TV, radio, social media, mobile loudspeakers, banners, and leaflets to spread awareness of COVID-19 prevention to the citizens of Cambodia. Cambodia has at least 92.4% of its population vaccinated with at least one dose, 88.6% have been fully vaccinated, almost 50% were already boosted, and around 7% have already gotten their second booster.
- Vietnam is getting ready for the nationwide launch of digital vaccine passport. The Deputy Director of Medical Data Center under the Ministry of Information and Communications said that after a week of piloting, the national vaccination system has responded well to the issuance of digital vaccine passports. The pilot project has been carried out at three Hanoi hospitals: Bach Mai, E and K. These were chosen as these are large-scale, major hospitals in the capital city where COVID-19 vaccination data has been well organized and

stored. Vietnam's vaccine passport will contain personal information including the types of vaccines administered and the number of doses given. The information is encoded and encrypted into a QR code, which expires 12 months after it is created. As of March 22, more than 202 million doses of the COVID-19 vaccine have been administered across the country. Of these, the system has recorded more than 193 million doses, or 96%, and has been updated on the vaccination management platform.

Travel Advisories (new update/s)

- Indonesia: According to the Ministry of Tourism on March 22 (Tuesday), the government will expand its quarantine-free travels to the rest of the country for fully-vaccinated individuals, following a successful two-week trial of the program in Bali, Batam and Bintan islands. However, a negative COVID-19 test would still be required. In similar travel updates, the Directorate General of Immigration, Ministry of Law and Human Rights, said that the government has expanded the list of countries/regions from which tourists can enter Bali via a Special Tourism Visa on Arrival (VOA) arrangement. From the previous 23, the list now consists of 42 countries/regions, and the arrangement only applies to foreigners landing in Bali and the Riau Islands. The government has issued a Circular which regulates immigration facilities through the opening of visa-free visits (BVK) and a VOA, specifically for tourism in the Riau Islands effective March 22. The BVK specifically applies to tourists from Singapore and ASEAN countries (Brunei Darussalam, Philippines, Cambodia, Laos, Malaysia, Myanmar, Thailand, and Vietnam) with permanent residency or citizenship in Singapore, entering the Riau Islands through selected immigration checkpoints. The Special BVK for tourism will be given by the immigration officer and will be valid as a Visit Stay permit with a maximum period of 14 days.
- Philippines: The Philippine government through the Inter-agency Task Force on Emerging Diseases (IATF) has accepted the COVID-19 vaccination certificates of Bulgaria, Iran, and Panama. On March 22 (Tuesday), the IATF gave its green light in recognizing the vaccination certificates from the three countries. The Office of the Presidential Spokesperson (OPS) said that the vaccination certificates will be for purposes of quarantine and mobility.

Cases and Deaths as of 23 March 2022

- As of 23 March 2022 (2PM, GMT+8), worldwide, there were **474,430,144** confirmed cases, including **6,115,950** deaths. Globally, Case Fatality Rate (CFR) was **1.3.**
- In China, there were 1,232,647 confirmed cases with 11,855 deaths, including deaths in Hong Kong (6364) and Taiwan (853). Confirmed cases in China include confirmed cases in Hong Kong (1,075,910), Macau (82) and Taiwan (22,091). CFR was 1.0.
- 27,483,659 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 337,850 deaths, with a CFR of 1.2.
