### **COVID-19: Highlights and Situation Overview**

#### **Global Update**

- Worldwide, there have been over 231 million cases and over 4 million deaths attributed to COVID-19.
- The World Health Organization (WHO) on September 24 has recommended the synthetic antibody treatment Regeneron for COVID-19, but only in patients with specific health profiles. Persons with non-severe COVID-19 who are nonetheless at high risk of hospitalisation can take the antibody combo, as should critically ill patients unable to mount an adequate immune response, according to a WHO finding published in BMJ. Regeneron is only the third treatment for COVID-19 to be recommended by the global health authority, which added it to its "living WHO guideline" on drugs for COVID-19. The Regeneron cocktail of synthetic antibodies casirivimab and imdevimab has been found to reduce the risk of hospitalization for unvaccinated, elderly or immunosuppressed patients with COVID-19, according to three clinical trials that have yet to be peer reviewed, according to the BMJ. For the second category of patient covered by the new WHO recommendation, another trial has reported a reduced number of deaths, and cases requiring mechanical ventilation, in patients taking the drugs. The WHO concluded that for all other covid-19 patients, any benefits of this antibody treatment are unlikely to be meaningful. In July, Japan had become the first country to fully approve Regeneron's antibody treatment for patients with mild to moderate COVID-19. The antibody combination has been authorized for emergency or temporary pandemic use in a number of countries and regions, including the European Union, United States, India, Switzerland and Canada.

#### **Regional Update**

 Laos has authorized the use of rapid COVID-19 tests which were previously prohibited. Director General of the National Center for Laboratory and Epidemiology under the Lao Ministry of Health, told a press conference on September 24 (Friday) that there are many benefits to use rapid test kits, such as being able to see results within 15 to 20 minutes without utilizing a laboratory, and these kits are easy to use. However, people must be aware of the limitations of rapid tests, such as unclear test results, and the fact that the test must be undertaken in an environment with a temperature of 30 degrees Celsius or lower. Laos will allow the use of the rapid tests that are approved by the World Health Organization (WHO), and can be found under the WHO's Emergency Use Listing.

#### Vaccine Update

Malaysia reported that a total of 19,156,694 individuals or 81.8% of the adult population in the country have been fully vaccinated against COVID-19 as of September 23. Based on the Health Ministry's data on CovidNow, 93.3% or 21,847,551 individuals of the adult population had received at least one dose of the vaccine. At the same time, 23,703 individuals or 0.8% of the adolescent population in the country had completed their COVID-19 vaccination as of Thursday. On a daily vaccination rate, a total of 326,612 doses of the vaccine were administered on Thursday, 132,562 of which were for first-dose recipients and 194,050 others were for second-dose recipients, bringing the cumulative total of vaccines administered under the National COVID-19 Immunization Programme to 41,573,883 doses. The Ministry of Health (MoH) has also announced that for now, only targeted groups will get priority for a third dose of the COVID-19 vaccine starting next month. The four groups are medical frontliners, the immunocompromised, the elderly with comorbidities and individuals in long-term healthcare facilities.

• Laos has received 30,000 doses of Sputnik Light COVID-19 vaccine as part of humanitarian assistance from Russia. On September 22, a special flight of the Russian Emergencies Ministry delivered about 30,000 doses of the Sputnik Light vaccine kits as humanitarian aid to the population of Laos.

#### Travel Advisories (new update/s)

- Malaysia: The Malaysian government will continue to negotiate with the Singapore authorities on the gradual reopening of borders, based on the prevailing health situation in both countries. Malaysia's Foreign Minister highlighted that these negotiations include cross-border movement schemes like the Daily Commuting Arrangement (DCA). The DCA scheme was previously proposed by the Johor State Government. The proposed scheme will facilitate the movement of up to 30,000 commuters each day across the two land checkpoints between Singapore and Malaysia. In his speech, the minister said that DCA was still at the "proposal stage" and there were "many things that still needed to be refined before it can be implemented". He added that for any proposal on the reopening of borders, the main issue to be taken into consideration was the question of "health and safety of the people, in addition to the current COVID-19 situation in both Malaysia and Singapore". Meanwhile, Sabah is ready to reintroduce the travel bubble concept for local tourism within the state following the relaxation of standard operating procedures (SOPs) for fully vaccinated individuals. An authority from the state of Sabah said that the travel bubble would further allow locals to travel beyond their districts, but travel agencies and hotels need to get pre-approval from the COVID-19 Disaster Management Committee to participate in the programme.
- Thailand: The country's disease control committee has proposed a halving of a two-week hotel isolation requirement for vaccinated arrivals, amid delays in plans to waive quarantine and reopen Bangkok and tourist destinations starting next month. Under the proposal, to be presented to government on Monday, those without vaccination proof would be isolated for 10 days if arriving by air, and 14 days if by land. Authorities this week has delayed its plans to grant vaccinated visitors entry without quarantine, due to the country's low inoculation rate. Only Phuket and Samui islands currently waive quarantine for vaccinated tourists, as part of a pilot scheme.

#### Cases and Deaths as of 24 September 2021

- As of 24 September 2021 (2PM, GMT+8), worldwide, there were 231,700,579 confirmed cases, including 4,745,422 deaths. Globally, Case Fatality Rate (CFR) was 2.0.
- In China, there were 124,295 confirmed cases with 5,690 deaths, including deaths in Hong Kong (213) and Taiwan (841). Confirmed cases in China include confirmed cases in Hong Kong (12,170), Macau (63), and Taiwan (16,168). CFR was 4.6.
- 11,713,652 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 256,619 deaths, with a CFR of 2.2.
