### **COVID-19: Highlights and Situation Overview**

#### **Global Update**

- Worldwide, there have been over 358.8 million cases and 5.6 million deaths attributed to COVID-19.
- According to the World Health Organization (WHO), the number of new COVID-19 cases globally has increased in the past week (17-23 January 2022) by 5%, while the number of new deaths remained similar to that reported during the previous week. Across the six WHO regions, over 21 million new cases were reported this week, representing the highest number of weekly cases recorded since the beginning of the pandemic. Nearly 50 000 new deaths were also reported. As of 23 January 2022, over 346 million confirmed cases and over 5.5 million deaths have been reported worldwide. Meanwhile, a slower increase in case incidence was observed at the global level, with only half of the regions reporting an increase in the number of new weekly cases, as compared to five out of six regions in the previous week. The Eastern Mediterranean Region reported the largest increase in the number of new cases (39%), followed by the South-East Asia Region (36%) and the European Region (13%). The number of new weekly deaths increased in the South-East Asia Region (15%) and the Region of the Americas (7%), while the other Regions all reported declines in new weekly deaths.

#### **Regional Update**

- Philippines' Department of Health (DOH) reported 17,677 new COVID-19 infections on January 25 (Tuesday), raising the number of confirmed cases in the country to 3,459,646. The DOH said the number of active cases dropped to 247,451 as the country's positivity rate also dipped to 37.2%, below 40% for the first time since January 6. The COVID-19 risk levels for the Philippines and its capital region have been lowered to "high risk" from "critical risk. DOH said that the number of COVID-19 cases in Metro Manila continues to decline after reaching the peak.
- Malaysia's health Director-General said on January 25 (Tuesday) that a total of 162 Omicron cases were detected in the country in the past 24 hours. The Institute of Medical Research identified 89 new cases, the University of Malaya Faculty of Medicine 71 new cases and the Malaysia Genome and the Vaccine Institute identified 2 new cases. To date, the cumulative number of cases with Delta variant is 6,188, 601 cases of Omicron variant, 233 Beta variant and 14 Alpha variant. The Director-General added that over the same comparison period, a total of 13 new clusters were identified, bringing the tally to 244 active clusters in Malaysia.
- Vietnam's Deputy Director of the Ho Chi Minh City's Centre for disease control (HCDC) said that most COVID-19 infections related to the Omicron variant of coronavirus SARS-CoV-2 in Vietnam show no symptoms. Vietnam has so far recorded 163 Omicron cases nationwide, mostly in Ho Chi Minh City with 72 cases. He said that only 7 out of the 88 cases treated in HCM City have mild symptoms such as fever, chills, and sore throat. All patients have been in stable health, with the average time from testing positive to negative being only about 6-7 days. The health of the most serious case of Omicron an 82-year-old woman who entered the country on January 10 with many background diseases such as final-stage blood cancer and diabetes has also stabilized. Meanwhile, Hano's municipal Steering Committee for COVID-19 Prevention and Control's meeting on January 26 announced that the first community Omicron case in Hanoi. A person who came in contact with 13 imported cases of COVID-19 Omicron variant was the first recorded case of Omicron in the community in the capital city of Hanoi. The capital city has now seen 118,111 cases and is still on alert level 2 (medium-risk).

#### Vaccine Update

- According to Malaysia's Health Ministry's COVIDNOW portal, a total of 25,702,311 individuals or 97.9% of the adult population have completed the COVID-19 vaccination, while 26,062,066 individuals or 99.1% have received at least one dose of the vaccine as of January 25 (Tuesday). A total of 11,119,363 individuals or 47.5% of the adult population in the country have also received the COVID-19 booster dose. For adolescents aged between 12 and 17, a total of 2,783,457 individuals or 88.4% have completed the vaccination, while 2,865,416 individuals or 91.0% of the group have received at least one dose of the vaccine. On daily statistics, a total of 213,226 doses of the vaccine were dispensed yesterday, with 2,169 as first dose, 2,680 second dose and 208,377 as booster dose, bringing the cumulative number of vaccine doses administered under the National Covid-19 Immunization Programme (NIP) to 62,679,781.
- Laos has received COVID-19 vaccines. 899,730 doses of the vaccine donated by the United States of America (USA) arrived at Wattay International Airport on Monday evening (January 24), and is the second such donation to be delivered this month. The first shipment of 799,110 doses arrived in Laos on January 2, bringing the total of vaccines received from the USA this month to 1,698,840 doses of vaccine. The vaccine will be distributed among priority groups in Laos in line with the National Deployment and Vaccination Plan. Adolescents aged 12 to 17, people aged 60 and over, people with underlying health conditions, and pregnant women will be among those who will benefit from the latest donation of Pfizer BioNTech vaccine. The new shipment has been procured through the COVAX Facility, which is a partnership co-led by Gavi, the Coalition for Epidemic Preparedness Innovations, and WHO, with UNICEF as a key delivery partner. The United States, through USAID, UNICEF and WHO, is strengthening Laos' capacity to safely and effectively distribute COVID-19 vaccines. This latest contribution from the United States will support the government's efforts to vaccinate 80% of the population by the end of 2022 and contributes to the COVAX Facility's mission of ensuring global equitable access to COVID-19 vaccines during the pandemic. Meanwhile, the eighth batch of China-donated COVID-19 vaccines has arrived in Laos on January 25 (Tuesday). 1.5 million doses of COVID-19 vaccines have been handed yesterday by Chinese ambassador to Laos' Prime Minister. China has so far provided 8.9 million doses of the COVID-19 vaccines to Laos.
- Vietnam has received an additional 6.27 doses of COVID-19 vaccines from Germany, Luxembourg, Portugal and the United Kingdom. 4,000,230 doses of BioNTech/Pfizer COVID-19 vaccine was donated by the Government of Germany, 99,450 doses of BioNTech/Pfizer came from by the Government of Luxembourg, 159,120 doses of BioNTech/Pfizer were given by the Government of Portugal and 2,012,960 doses of AstraZeneca vaccine were donated by the United Kingdom, all through the COVAX Facility.

#### Travel Advisories (new update/s)

Vietnam: National flag carrier Vietnam Airlines has officially reopened direct services between France and Vietnam. This was one of the first two flights operated by Vietnam Airlines after it announced to resume regular flights between Vietnam and Europe. From February 8, the flight schedule to the UK, France and Germany will be fixed on two routes. The flights on the first route depart every Tuesday from Hanoi to London, via Frankfurt and back to Hanoi, while those on the second depart every Thursday from Hanoi to Paris, via Frankfurt and back to Hanoi. Airlines have so far relaunched regular services to 12 countries and territory, namely the United States of America, Japan, the Republic of Korea, Singapore, Thailand, Cambodia, Taiwan (China), Australia, Russia, the United Kingdom, France and Germany.

#### Cases and Deaths as of 26 January 2022

- As of 24 January 2022 (2PM, GMT+8), worldwide, there were **358,878,574** confirmed cases, including **5,642,348** deaths. Globally, Case Fatality Rate (CFR) was **1.6.**
- In China, there were 137,595 confirmed cases with 5,700 deaths, including deaths in Hong Kong (213) and Taiwan (851). Confirmed cases in China include confirmed cases in Hong Kong (13,395), Macau (79) and Taiwan (18,411). CFR was 4.2.
- 16,282,186 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 312,635 deaths, with a CFR of 1.9.
