COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 260 million cases and over 5 million deaths attributed to COVID-19.
- Scientists in South Africa said on Thursday (November 25) that they had detected a new COVID-19 variant with a large number of mutations, blaming it for a surge in infection numbers. The number of daily infections in Africa's hardest-hit country has increased tenfold since the start of the month. In response, Britain banned all travel from the country and five other southern African nations as concerns grow about the new variant. Singapore swiftly joined Britain, with the health ministry saying on Friday it would restrict arrivals from South Africa and countries nearby as a precaution. Japan's government also decided to tighten border controls for visitors from South Africa and five other African countries. According to the scientist, the variant, which goes by the scientific lineage number B.1.1.529, has a very high number of mutations and is unfortunately causing a resurgence of infections. Scientists said that the new B.1.1.529 variant has at least 10 mutations, compared to two for Delta or three for Beta. The variant has also been detected in Botswana and Hong Kong among travellers from South Africa. The World Health Organization (WHO) said it is "closely monitoring" the reported variant and is expected to convene a technical meeting this week to determine if it should be designated a variant of "interest" or of "concern".

Regional Update

- Vietnam's Ministry of Health (MOH) reported 12,450 new cases of COVID-19 on Thursday (November 25), the highest daily figure in over two and a half months, bringing the total number of cases in the country to 1,168,228. Among the new cases, 6,842 were found in the community and 21 were imported. Ho Chi Minh City topped the list with 1,582 new infections, followed by Càm Thơ Province with 741 and Tây Ninh with 683. The capital city of Hanoi also reported 264 new cases.

Vaccine Update

- Malaysia reported a total of 22,442,346 individuals or 95.9% of the adult population have completed the COVID-19 vaccination as of November 25. Based on the Health Ministry's CovidNow portal, 22,944,240 individuals or 98% of the adult population have received at least one dose of the vaccine. As for adolescents aged 12-17, 82.8% or 2,607,392 individuals have completed the vaccination, while 87.7% or 2,762,739 have received at least one dose of the vaccine. A total of 138,752 doses of the vaccine were dispensed on November 25, with 8,428 doses as second dose, 5,067 doses to first dose recipients and 125,257 doses as booster dose, bringing the total number of doses administered under the National Covid-19 Immunization Programme (NIP) to 52,391,444. On the booster dose, a total of 1,823,474 doses have been administered so far.

Travel Advisories (new update/s)

- Singapore: The country's Ministry of Health (MOH) said on Friday (November 26) that the government will restrict entry to travellers with recent travel history to seven African countries after reports that a potentially more contagious COVID-19 variant may be circulating there. Starting November 27 (Saturday), all long-term pass holders and short-term visitors with travel history within the last 14 days to Botswana, Eswatini, Lesotho, Mozambique, Namibia, South Africa and Zimbabwe will not be allowed to enter or transit Singapore. The

restrictions also apply to those who have obtained prior approval for entry into Singapore. Singapore citizens and permanent residents returning from these countries will have to serve a 10-day stay-home notice at a dedicated facility. The new border restrictions will initially apply for four weeks, and MOH will review and extend the restrictions if necessary. Meanwhile, the Civil Aviation Authority of Singapore (CAAS) announced on Friday (November 26) that Singapore will extend vaccinated travel lanes (VTLs) to six more countries next month. Travellers from Thailand may enter Singapore under the quarantine-free VTL starting December 14 while travellers from Cambodia, Fiji, Maldives, Sri Lanka and Turkey can also do so starting December 16. This latest move will increase the number of countries with which Singapore has VTL arrangements to 27.

- Philippines: The country announced today (November 26) that it will reopen its borders to some foreign tourists starting December 1. Vaccinated foreigners from countries designated low risk by the Philippines for COVID-19 will be allowed entry over an initial 15-day period. The government said that it will monitor the situation and will make necessary adjustments if necessary.

Cases and Deaths as of 26 November 2021

- As of 26 November 2021 (2PM, GMT+8), worldwide, there were **260,639,089** confirmed cases, including **5,204,685** deaths. Globally, Case Fatality Rate (CFR) was **2.0**.
- In **China**, there were **127,622** confirmed cases with **5,697** deaths, including deaths in Hong Kong (213) and Taiwan (848). Confirmed cases in China include confirmed cases in Hong Kong (12,418) and Taiwan (16,554). CFR was 4.5.
- **13,929,792 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **289,732 deaths**, with a CFR of **2.1**.




COVID-19 Epi curve among ASEAN Countries

as of 25 November 2021


