COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 366 million cases and 5.7 million deaths attributed to COVID-19.

Regional Update

- Philippines' Department of Health (DOH) said of January 28 (Friday) that the National Capital Region (NCR) is now classified as moderate risk from the previous high-risk status for COVID-19 after recording a 67% decrease in new cases from the previous week. According to the health authority, NCR recorded an average of 4,398 new COVID-19 cases in the last seven days, compared to 13,298 average new cases in the preceding week. However, the DOH is monitoring the increase in COVID-19 cases in the Visayas and Mindanao. Vergeire said that cases are increasing in Western and Central Visayas and in Davao Region. The country's Health Secretary earlier said that the rise of COVID-19 cases in NCR have already peaked and the decline in the number of new cases is expected after the infections have reached its peak.

Vaccine Update

- According to Malaysia's Health Ministry's COVIDNOW portal, a total of 22,921,716 or 97.9% of the adult population have completed vaccination, while 23,199,172 individuals or 99.1% of the group have received at least one dose of the COVID-19 vaccine as of January 27 (Thursday). In addition, a total of 199,251 adults in Malaysia received the COVID-19 booster dose on Thursday bringing the cumulative number of booster doses administered to the adult population in the country to 11,531,403 or 49.3% of the group. For adolescents aged 12 to 17, a total of 2,785,992 individuals or 88.5% have completed their vaccination, while 2,866,545 individuals or 91.1% have received at least one dose of the vaccine. The daily statistics also showed that a total of 203,613 doses of vaccine were administered yesterday, which included 1,660 as the first dose and 2,702 as the second dose, and 199,251 booster doses, bringing the cumulative number of vaccine doses administered under the National COVID-19 Immunization Programme to 63,100,577. Malaysia today (January 28) has also received the first shipment of 624,000 Pfizer-BioNTech Comirnaty 10mcg Concentrate for Dispersion vaccine doses that will be used for the vaccination of children aged 5 to 12 in February. The Ministry of Health estimates that there are four million children aged five to 12 who would be eligible to receive the vaccine. As of Friday, the ministry said 484,639 children from the age of 5 to 12 had been registered for vaccination on MySejahtera app.

Travel Advisories (new update/s)

- Philippines: The country will reopen to fully vaccinated tourists from most countries starting February 10 and lift quarantine requirements. Today's (January 28) announcement allows for the resumption of visa-free travel for short visits by nationals from the 157 countries who already enjoyed permit-free entry to the Philippines before the pandemic began. Fully vaccinated tourists from countries on the list will need to test negative for COVID-19 shortly before flying to the Philippines and will not have to quarantine on arrival. Travellers should be holders of passports valid for at least six months at the time of arrival and with return or outbound ticket to their country of origin or next country of destination. Children below 18 years old are exempted from the requirement of complete vaccination and providing proof of vaccination status before boarding. The list excludes China, as well as Taiwan and India but it includes Manila's remaining top 10

tourism sources, such as the United States, South Korea, Japan, Australia, Canada and Britain. On the other hand, unvaccinated foreigners will be banned from entry from February 16.

- Thailand: The Ministry of Foreign Affairs announced today the details of measures related to travel to Thailand, according to the resolution of the Centre for COVID-19 Situation Administration (CCSA) for visitors under Thailand's 'Test and Go'. Thailand Pass registration will be reopened to enter the country under the 'Test and Go' policy from February 1, 9am Thailand time. Registration is not restricted by country/region of origin. Travellers are required to have two RT-PCR examinations: on the first day of arrival and on the fifth day of stay in Thailand. They must provide proof of booking and payment for two nights of SHA Extra Plus /AQ/OQ/AHQ hotel or accommodation on days 1 and 5, not necessarily in the same hotel or in the same province. Hotel bookings include RT-PCR testing, or a paid examination (both times) and travellers must wait in the hotel for the results. In case the period of stay is less than five days, proof of booking and payment of accommodation and second examination fee is not required, but the return flight ticket must be presented instead. The meeting of the CCSA also resolved to open additional sandbox areas from February 1 in Chonburi province (Bang Lamung district, Pattaya City, Sriracha district, Koh Sichang, Sattahip district -- only Na Chom Thian and Bang Saray subdistricts) and Trat province (Koh Chang). Travellers can move between the new and original sandbox areas (Phuket, Krabi, Phang Nga and Surat Thani (Koh Samui, Koh Tao and Koh Phangan) within seven days of stay in the sandbox and must book a seven-day SHA Extra Plus or AQ hotel with two-time RT-PCR examination with a maximum of three hotels in the Sandbox area.

Cases and Deaths as of 28 January 2022

- As of 28 January 2022 (2PM, GMT+8), worldwide, there were **366,052,290** confirmed cases, including **5,660,962** deaths. Globally, Case Fatality Rate (CFR) was **1.5**.
- In **China**, there were **138,094** confirmed cases with **5,700** deaths, including deaths in Hong Kong (213) and Taiwan (851). Confirmed cases in China include confirmed cases in Hong Kong (13,626), Macau (79) and Taiwan (18,566). CFR was **4.1**.
- 16,400,583 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **313,134 deaths**, with a CFR of **1.9**.




COVID-19 Epi curve among ASEAN Countries


