COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 246 million cases and over 5 million deaths attributed to COVID-19.
- The World Health Organization (WHO) and other aid groups on October 28 (Thursday) issued a USD23.4 billion plan to bring COVID-19 vaccines, tests and drugs to poorer countries in the next year, appealing to leaders of the G20 who are meeting this weekend for funding. The plan outlines the strategy of the Access to COVID-19 Tools Accelerator (ACT-A) until September 2022, which may include use of an experimental oral antiviral pill made by Merck & Co for treating mild and moderate cases. If the pill is approved by regulatory authorities, the cost could be as little as USD10 per course. According to WHO Chief Scientist, COVAX, the vaccines arm of the ACT-A, has delivered some 400 million COVID-19 doses to more than 140 low- and middle-income countries, where vaccination rates remain low adding that there are about 30 countries that are dependent on COVAX alone and have no other source of vaccines.

Regional Update

- Vietnam's Ho Chi Minh City resumed in-person dining at restaurants and eateries from October 28 after five months of closure and delivery-only operations due to COVID-19 outbreak. Restaurants, cafes, and other food and beverages places can cater for sit-in services again, but they must close at 9pm each day, however, the number of customers is capped at 50% of its capacity and alcoholic drinks are still not allowed (except in wedding venues, or restaurants at hotels for tourists). Customers are expected to leave records of entry at each food and drink establishment using QR codes via the health declaration/medical surveillance system. The establishments have to have proper food safety licenses, separate section/quarter for reception of food, full stock of soap and hand sanitation products, and register their venues. Meanwhile, District 7 and Thu Duc city, due to their success in containing outbreaks, are allowed to carry out a 'pilot' period of selling alcoholic beverages starting tomorrow until November 15, with specific areas to be decided by local authorities. The two localities will report to the city's authorities after November 15 to inform their decisions on whether to expand the permission to other localities. As of October 29, 2021, Vietnam's Ministry of Health confirmed a total of 905,477 cases of COVID-19. 813,963 of the affected patients have recovered and been discharged from hospitals. The latest community transmission cases have been reported from Ho Chi Minh City, Binh Duong, Dong Nai, An Giang, and Tay Ninh among others. In addition, Vietnam has also recorded 21,910 deaths due to COVID-19.
- Malaysia's National Unity Ministry announced that only fully vaccinated individuals are allowed to go to temples and participate in religious activities in non-Muslim places of worship in conjunction with the Deepavali celebration on November 4. However, the standard operating procedure (SOP) varies depending on the phase of the National Recovery Plan (PPN) in each state. For the states in Phase Three and Four, religious activities and prayers at the houses of worship are allowed for fully vaccinated individuals with attendance capacity based on the size of the premises, taking into account physical distancing of not less than one meter. States that are in Phase Three of the PPN are Perlis, Kedah, Penang, Perak, Kelantan, Sabah and Sarawak. Meanwhile, Federal Territories of Putrajaya, Kuala Lumpur, Labuan, Selangor, Pahang, Negri Sembilan, Johor and Melaka are already in Phase Four. The ministry also said that religious processions are also not allowed while Deepavali bazaars are permitted but subject to approval from the local authorities.

Vaccine Update

- Vietnam's Ministry of Health has approved COVID-19 Pfizer and Moderna vaccines for inoculation of children aged from 12-17. Deputy Minister of Health said on October 29 that children living in high-risk areas will be inoculated first. According to the Deputy Minister, Vietnam has to date administered over 78 million doses of vaccines of all kinds. The health sector is also giving priority to vaccinating children aged from 16-17. Parents or guardians of children are required to sign papers allowing the vaccination. On October 27 morning, Ho Chi Minh City, Vietnam's current largest pandemic hotspot, started giving COVID-19 vaccines to school children in the district of Cu Chi. According to Chairwoman of the People's Committee of Cu Chi Pham Thi Thanh Hien, the vaccination is being piloted at one site initially, with about 1,500 students aging from 16-17 to receive the shots adding that the vaccination will only be carried out with agreement from their parents.
- Malaysia reported a total of 22,214,490 individuals or 94.9% of the adult population in the country have completed their COVID-19 vaccination as of October 27. Based on the Health Ministry's data on the CovidNow portal, 97.6%, or 22,839,280 individuals, have received at least one dose of the vaccine. A total of 147,242 doses were dispensed on Wednesday, involving 123,182 complete doses, 18,493 first doses and 5,567 booster doses, bringing the total number of doses administered under the National COVID-19 Immunization Programme (NIP) to 49,581,855. As for teenagers aged 12 to 17 years, 62% or 1,951,450 individuals have completed their vaccination while 2,592,048 individuals or 82.4% of them were administered at least one dose of the vaccine since the PICK programme for the adolescent group was launched on September 8.

Travel Advisories (new update/s)

- Cambodia: The Cambodian tourism ministry has announced earlier a November 30 reopening for popular beach spots Sihanoukville and the island of Koh Rong, as well as Dara Sakor. The northern city of Siem Reap -- gateway to the world heritage-listed Angkor Wat complex
 will be added to the kingdom's hotel quarantine-free travel scheme in January 2022. Foreign travellers will require certificates showing they have been vaccinated, health insurance covering treatment for COVID-19, and negative swab tests prior to departure and upon arrival in the country. Tourists must remain for a minimum of five days at the pilot locations and undergo a further swab test before being allowed to explore other parts of Cambodia.
- Malaysia: Starting November 1, travellers holding Malaysian long-term visit passes including Diplomat (Exemption Order)/Dependent/Foreign Maid, Employment Pass (Category I, II, III)/Dependent/Foreign Maid, Resident Pass-Talent (RP-T)/ Dependent/Foreign Maid, Professional Visit Pass-Specialist and Professional Visit Pass, will be permitted to enter the country without going through immigration clearance via MyTravelPass/MyEntry. In addition, Permanent Resident (PR)/Spouse to PR/Child to PR, Long-Term Pass (Husband/Wife/Child) to Citizen, Senior Citizen Pass, Widow/Widow Pass to Citizen, Student Pass/Dependent/Escort, Malaysia Pass My Second Home/Dependents/Foreign Maid, Resident Pass, Temporary Work Visit Pass, Foreign Maid are also allowed. Travellers not under the above-mentioned categories would still need to apply via the MTP/MYEntry for clearance to enter Malaysia. These include those on social visits and long-term visit pass holders with expired passes.

Cases and Deaths as of 29 October 2021

- As of 29 October 2021 (2PM, GMT+8), worldwide, there were **246,552,866** confirmed cases, including **5,000,366** deaths. Globally, Case Fatality Rate (CFR) was **2.0**.
- In China, there were 125,747 confirmed cases with 5,696 deaths, including deaths in Hong Kong (213) and Taiwan (847). Confirmed cases in China include confirmed cases in Hong Kong (12,338), Macau (77), and Taiwan (16,394). CFR was 4.5.
- 13,105,288 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 277,377 deaths, with a CFR of 2.1.
