# COVID-19: Highlights and Situation Overview

## Global Update

- Worldwide, there have been over 290 million cases and over 5.4 million deaths attributed to COVID-19.
- According to the World Health Organization (WHO), during the week of December 20-26, the global number of new cases has increased by 11% when compared to the previous week. This is in line with the gradually increasing trend that has been occurring since October. The global number of new deaths reported (44,000), was similar to the number reported the previous week (45,000). The region of the Americas reported the largest increase in new cases (39%), followed by the African region (7%). The South-East Asian region was the only region to report a continued decreasing trend in new cases (-12%) when compared to the previous week. The African region reported the largest increase in the number of new deaths (72%), which was followed by the South-East Asian (9%), and Americas (7%) regions. The European and Eastern Mediterranean regions reported a decrease in new deaths of -12% and -7%, respectively. Based on the BlueDot COVID-19 Data Suite, as of December 28, the top five countries with the highest seven-day rolling average number of daily new cases are the United States, United Kingdom, France, Spain, and Italy. The top five countries with the highest seven-day rolling average number of daily new cases per million population are Andorra, Denmark, San Marino, Aruba, and Ireland. As of December 28, Europe is the continent with the largest proportion of countries (47%, or 24 out of 51) with a high incidence rate (>350 per 100,000 over the past 14 days) and a stable or increasing trend in daily new cases over the last seven days. Africa has the highest proportion of countries (43%, or 24 out of 56) with a low (<=140) to moderate (140.1 - 350) incidence rate and an increasing trend in new cases over the last seven days. Both Asia (44%, or 21 out of 48) and Oceania (44%, or seven out of 16) have the highest proportion of countries reporting a low incidence rate (<= 140) with a stable or decreasing trend in new cases.
- As of December 29, a total of 327,313 confirmed cases of the Omicron variant (B.1.1.529) reported across 123 countries.

## Regional Update

- Philippines' Department of Health (DOH) reported 4,600 new COVID-19 infections on January 2 (Sunday), bringing the total number of confirmed cases in the country to 2,851,931. The DOH also reported 25 more deaths from COVID-19 complications, bringing the country's death toll to 51,570. Authorities will tighten the COVID-19 restrictions in Metro Manila starting today (January 3) to curb the spreading infections blamed on high mobility during the holiday season, poor compliance with safety health protocols, and the emergence of the fast-spreading Omicron variant.
- Malaysia reported a total of 64 cases of the Omicron COVID-19 variant as of Monday (January 3) morning. According to the Health Director-General, along with the Omicron, 5,151 cases of the Delta variant, 233 cases of the Beta variant, and 14 cases of the Alpha variant were also detected; making up a total of 5,460 "Variants of Concern" (VoC). Meanwhile, for the Variants of Interest (Vol) cases, there were 13 cases of the Theta variant, four cases of the Kappa variant, and three cases of the Eta variant, adding the total to 20 cases. All Omicron cases, except one case in Sarawak, were imported cases. The highest number of the Omicron cases were found in Selangor (19) and Kuala Lumpur (17), followed by Sarawak (8), Pahang (4), Negeri Sembilan (3), Perlis (3), Johor (2), Penang (2), Perak (2), Kedah (2), Melaka (1) and Terengganu (1). On January 2 (Sunday), the Health Ministry announced an indefinite halt to all Muslim minor pilgrimages to Saudi Arabia from January 8 after hundreds who returned to the country following their umrah were infected with COVID-19.

## Vaccine Update

- A total of 10 countries accounted for 65.1% of all vaccinations administered globally as of December 28. The top five countries/territories with the highest number of cumulative people fully vaccinated per 100,000 population are Gibraltar (118,860), United Arab Emirates (90,680), Portugal (89,310), Brunei Darussalam (87,290), and Singapore (87,000). Conversely, the top five countries with the lowest number of cumulative people fully vaccinated per 100,000 population are Burundi (30), the Democratic Republic of the Congo (110), Chad (480), Haiti (620), and Guinea-Bissau (1,130).
- Malaysia reported a total of 22,860,910 individuals or 97.7% of adult population have completed the vaccination, while 23,152,917 individuals or 98.9% have received at least one dose of the vaccine as of January 2 (Sunday). Based on the Health Ministry's CovidNow portal, a total of 2,756,810 individuals or 87.6% of the adolescent population aged between 12 and 17 in the country have completed

the vaccination while a total of 2,848,312 individuals or 90.5% cent of the group have received at least one dose of the vaccine. Meanwhile, a total of 94,040 doses of the vaccine were dispensed yesterday, with 1,264 of them as first dose, 1,340 second dose and 91,436 booster dose, bringing the cumulative number of vaccine doses administered under the National COVID-19 Immunization Programme (NIP) as of yesterday to 57,841,435, including 6,422,084 in booster doses.

#### **Travel Advisories** (new update/s)

- Malaysia: The government had decided to temporarily suspend travel permission to perform umrah starting January 8 to curb the spread of the Omicron COVID-19 variant. The postponement was due to concerns over the spread of the variant due to non-compliance by umrah pilgrims with the home-quarantine procedure, resulting in infection among family members.
- Myanmar: Myanmar's Foreign Ministry on Saturday night announced the extension of the entry restrictions for travelers until January 31 due to the COVID-19 pandemic. The ministry said that the extension was made to continue its effective response to prevent the risks of import and spread of COVID-19. Until the end of January, the issuance of all types of visas and visa exemption services will also be suspended.

#### **Cases and Deaths as of 03 January 2022**

- As of 03 January 2022 (2PM, GMT+8), worldwide, there were **290,798,535** confirmed cases, including **5,466,830** deaths. Globally, Case Fatality Rate (CFR) was **1.9**.
- In **China**, there were **132,350** confirmed cases with **5,699** deaths, including deaths in Hong Kong (213) and Taiwan (850). Confirmed cases in China include confirmed cases in Hong Kong (12,693), Macau (79) and Taiwan (17,070). CFR was **4.3**.
- **14,933,092 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **305,344 deaths**, with a CFR of **2.0**.




# COVID-19 Epi curve among ASEAN Countries

as of 2 January 2022


