COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 485 million cases, almost 6.2 million deaths attributed to COVID-19, with a case fatality rate (CFR) of 1.3%.
- According to the World Health Organization's Weekly Epidemiological Update, between the end of January and early March 2022, there
 was a decreasing trend in the number of new COVID-19 cases, which was followed by two consecutive weeks of increases in cases.
 During the week of 21 through 27 March 2022, the number of new cases declined again with a 14% decrease as compared to the
 previous week. On the other hand, during the same period, the number of new weekly deaths increased by 43%, likely driven by changes
 in the definition of COVID-19 deaths in some countries in the Region of the Americas (Chile and the United States of America) and by
 retrospective adjustments reported from India in the South-East Asia Region. Across the six WHO regions, over 10 million new cases and
 over 45,000 new deaths were reported. All regions reported decreasing trends in the number of new weekly cases and four regions
 reported a decreasing trend in new weekly deaths. As of 27 March 2022, over 479 million confirmed cases and over 6 million deaths have
 been reported globally.
- South Korea: Daily COVID-19 cases in Korea reached 347,374 amid surge of 'stealth' Omicron subvariant or also known as the BA.2 in March 29. The cases in the country brings a total of 12,350,428 according to the Korea Disease Control and Prevention Agency (KDCA). Critically ill patients are still about 1,200 and serious cases increased above 1,000 earlier this month, the KDCA said. The health authorities expect the decline of cases below 300,000 on average in two weeks as the virus has wave peaked last week. The BA.2 subvariant became the dominant strain in the country at about 56.3% of total infections last week. The government reiterates to its citizens to get boosted, particularly the elderly population aged 60 and above, as infection in the age group has increased recently above 20%.
- European Union (EU) sent €22.4 million humanitarian fund to Myanmar as needs grow exponentially since the military take-over. The Southeast Asian region also received €2 million for the refugee population's protection and assistance. The humanitarian funding the EU will also be used for the COVID-19 response, which has further worsened the humanitarian situation in the region.
- Shanghai, China on March 30 (Wednesday) extended its lockdowns in some western parts of the city, earlier than scheduled, as it reported a total of 5,982 new local cases on March 29 (Tuesday). The city reported a record 5,656 asymptomatic COVID-19 cases and 326 symptomatic cases on Tuesday, up from 4,381 new asymptomatic cases and 96 new cases with symptoms for the prior day. While residents in the east have been locked down since March 28 (Monday), those in the west were officially scheduled to start their 4-day lockdown on April 1 (Friday). However, the city's southwestern district of Minhang announced late on Tuesday that it would suspend public bus services until April 5. Several residents living in western districts also on Tuesday received notice from their housing committees that they would be restricted from leaving their compounds for the next seven days, citing reasons such as pandemic control or being a close contact of a positive case in the neighborhood.

Regional Update

- Brunei: Public, private, and international schools in Brunei are going back to face-to-face learning starting April 4 or 5 depending on the beginning of Ramadhan. Face-to-face classes will be open for preschoolers and year six for schools with less than 50 students, daycare centers, kindergarten, secondary schools, tertiary schools, and sixth form centers. Return to face-to-face classes for children aged five to 11, who are yet to be vaccinated, will be announced soon, said the minister. The minister advised the parents of children, going back to face-to-face classes, to monitor their health to ensure that they would not experience any symptoms of COVID-19 and undergo antigen rapid test twice a week.
- Malaysia: Minister reminds its citizens in Malaysia to continue health practices, including personal hygiene, despite downgrading the country to endemic phase starting April 1. Other practices like work from home and online shopping are still encouraged even the country goes to new normal.
- Singapore: COVID-19 restrictions in Singapore is further relaxed as the number of daily COVID-19 cases steadily declines. On March 29, the country no longer requires face masks outdoors and allows public gatherings of 10 people.

Vaccine Update

- Brunei: The Ministry of Health (MoH) does not require COVID-19 vaccination of children ages five to 11, Minister of Health Dato Seri Setia Dr. Mohd Isham Jafaar announced during the press conference in the capital on March 29. Vaccination of children will not also be mandatory for entry to schools and other premises. Parents are advised to weigh risks versus the benefits of the vaccine for their children; however, the minister also mentioned that there are three in every 1,000 unvaccinated children may have a severe case of COVID-19 that may also lead to death according to the WHO. On the other hand, head of Pediatric Services at the MoH Dr. Rohayati Mod Taib highly recommends COVID-19 vaccination for children to prevent increase of hospital admission among pediatric patients amid the Omicron surge.
- Cambodia: 1.5 million doses of China-donated Sinovac COVID-19 vaccines arrived in Cambodia on March 29. Another 3.5 million doses
 will arrive in Cambodia in succeeding days. The donated vaccines from China will be used to bolster their booster program and to
 vaccinate their children aged three to five. Cambodia already received almost 50 million doses of COVID-19 vaccines through bilateral
 procurement, the WHO's COVAX facility, and donations.
- Based on Malaysia's CovidNow portal, a total of 22,951,201 people or 97.5% of the adult population in the country have been fully vaccinated against COVID-19, 23,227,197 or 98.7% have received at least one dose of the vaccine, and 15,711,005 people or 66.8% have received booster dose as of March 29 (Tuesday). For adolescents aged 12 to 17, a total of 2,850,360 or 91.6% of the age group have completed the vaccination, while 2,947,122 or 94.7% received at least one dose of the vaccine. As for children aged five to 11, a total of 1,319,899 of them or 37.2% of the child population in Malaysia have received the first dose under the National COVID-19 Immunization Programme for Children (PICKids). On the daily immunization update on Tuesday, a total of 47,608 vaccine doses were dispensed including 5,296 first doses, 1,594 second doses and 40,718 booster doses, bringing the cumulative number of vaccine doses administered under the National COVID-19 Immunization Programme (PICK) to 68,795,057.

- Philippines: Health Undersecretary Maria Rosario Vergeire reported on March 29 that the adverse events following immunization (AEFI) against COVID-19 is only 0.07% of the total vaccine administered in the Philippines. Currently, the country has administered at total of 140 million doses of COVID-19 vaccine Those individuals who suffered serious AEFI will be compensated by the Philippine Health Insurance Corporation (PhilHealth) once a final decision on the causality has been issued by the experts of the National AEFI Committee.
- Vietnam's Ministry of Health (MOH) stated that the government will start its COVID-19 vaccination for children aged between 5 and 11 years old in the second week of April 2022. MOH stated that the COVID-19 vaccine for children will arrive in Vietnam in coming days and the vaccination will be implemented right after the testing and certification procedures for the vaccine are completed. The ministry also asked Health Departments of provinces and cities to accelerate the vaccination of booster doses for adults in order to stand ready to conduct the vaccination campaign for children. The vaccination of children will be implemented at both fixed and mobile injection sites as well as at schools where children are attending in-person learning. As of March 29, over 77.8 million individuals were fully vaccinated including 45.4 million individuals were administered with first booster dose.

Travel Advisories (new update/s)

- Brunei: Foreign tourists going to Brunei will only need to test for COVID-19 rapid antigen upon arrival to the country starting April 1. The MoH of Brunei also announced that aside from the exemption of undergoing an RT-PCR test from the country of origin, tourists will no longer need to undergo mandatory self-quarantine upon arrival.
- Cambodia: The Ministry of Health stated on March 29 that the government has re-instated COVID-19 rapid testing for workers returning from Thailand, to contain the spread of the new SARS-CoV-2 variants as the traditional new year festival is nearing. Workers who have yet to be inoculated will be quarantined and people testing negative for COVID-19 will receive vaccine shots at the border.
- Indonesia: Joko Widodo, Indonesia's president, has allowed boosted Indonesians to go an annual exodus for the Islamic holiday, the Hari Raya Aidilfitro festivities, this year. The announcement was made as the country's COVID-19 cases has continuously decline and has officially opened its borders to foreign tourists; however, the tourists should show two-dose vaccination certificates completed at least 14 days before arriving in Indonesia. Foreign travellers are also required to undergo COVID-19 RT-PCR tests upon arrivals. The Health Ministry has also conducted serology survey in 1,000 villages across Indonesia and showed that Indonesian people have had high levels of antibodies against the coronavirus.

Cases and Deaths as of 30 March 2022

- As of 30 March 2022 (2PM, GMT+8), worldwide, there were **485,398,212** confirmed cases, including **6,172, 885** deaths. Globally, Case Fatality Rate (CFR) was **1.3.**
- In China, there were 1,312,670 confirmed cases with 13,062 deaths, including deaths in Hong Kong (7,571) and Taiwan (853). Confirmed cases in China include confirmed cases in Hong Kong (1,143, 788), Macau (82) and Taiwan (22,992). CFR was 1.0.
- 28,829,104 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 340, 752 deaths, with a CFR of 1.2.
