# COVID-19: Highlights and Situation Overview

## Global Update

- Worldwide, there have been over 299 million cases and 5.5 million deaths attributed to COVID-19.
- The World Health Organization (WHO) said on the media briefing on January 6 (Thursday) that Omicron variant of COVID-19 appears to produce less severe disease than the globally dominant Delta strain, but should not be categorized as "mild". Speaking at a media briefing, WHO Director-General Tedros Adhanom Ghebreyesus also repeated his call for greater equity globally in the distribution and access to vaccines adding that based on the current rate of vaccine rollout, 92 of the WHO's 194 member states missed the target set for the end of 2021 — 36 of them had not even jabbed the first 10%, largely due to being unable to access doses. He therefore urged the world to share out vaccine doses more fairly in 2022, to end the "death and destruction" of COVID-19.

## Regional Update

- Laos' National Taskforce Committee for COVID-19 Prevention and Control said during a press briefing on January 6 (Thursday) that the country has detected its first infection case of Omicron variant of SARS-CoV-2. The committee revealed that Omicron variant had been detected in a passenger who arrived from Malaysia on January 2. The flight carried 42 people where two individuals from the same family tested positive for the virus. Omicron variant was detected in one of the two patients who had traveled from India, through Sri Lanka, transferring in Malaysia before arriving in Laos. Both had been fully vaccinated against COVID-19. The patients are undertaking quarantine at a location arranged by the committee. Meanwhile, the quarantine hotel where other passengers from the flight are staying has been instructed to take strict precautions, ensuring the individuals remain in their rooms at all times, in order to contain the spread of the variant.
- Vietnam's Ho Chi Minh City (HCM) confirmed five more cases of infection with the Omicron variant on January 6, raising the total number of such infections in the city to 11. According to the HCM City Centre for Disease Control (HCDC), five patients have entered Vietnam from overseas last December and have stayed in quarantine since arrival. Their samples were sent for gene sequencing and the results confirmed they were infected with the Omicron variant. All 223 people with contact with those five patients, including passengers and crew members travelling on the same flight have been quarantined in line with the regulations and have so far tested negative for the COVID-19.
- Thailand's has raised its COVID-19 alert level following rising infections driven by the spread of the Omicron variant of SARS-CoV-2. According to the senior health official, the change from level three to four, sets a pretext for possible measures that could follow, such as closing high-risk areas and placing restrictions on domestic travel or public gatherings. Thailand reported 5,775 new cases yesterday (January 6), a 48% rise from the previous day.

## Vaccine Update

- Malaysia reported a total of 22,876,224 individuals or 97.7% of the adult population in the country had completed their COVID-19 vaccination while a total of 23,162,767 individuals or 98.9% of the group had received at least one dose of the vaccine as of Thursday (January 6). Based on the Ministry of Health's COVIDNOW portal, a total of 2,763,787 individuals or 87.8% of the adolescent population aged between 12 and 17 had completed their vaccination while 2,854,126 individuals or 90.7% of the group had received at least one

dose of the vaccine. A total of 252,817 doses of the vaccine were administered on Thursday, with 2,898 of them as first shots, 4,549 as second jabs and 245,370 as booster doses. Malaysia's Drug Control Authority (DCA) has also granted conditional approval for the use of Pfizer Inc.'s COVID-19 vaccine for children aged between 5 and 11 years old. According to the health minister, the 10mcg dosage approved for this age group has a lower potency than the vaccine given to individuals 12 years of age and older. Separately, the DCA has also given conditional approval for the use of the CanSino vaccine as a booster dose to individuals aged 18 years and above.

### Travel Advisories (new update/s)

- Thailand: Thailand is lifting its travel ban on the eight African countries that were considered to be at high risk of the Omicron variant. Restrictions for those travelling from other African countries will also be lifted starting January 11. The countries being removed from Thailand's ban list include Botswana, Eswatini, Lesotho, Malawi, Mozambique, Namibia, Zimbabwe, and South Africa. The Sandbox programme will be open to all vaccinated travellers, regardless of what country they travelled from. Those who are unvaccinated must, however, undergo a 10-day quarantine. With the Test & Go quarantine exemption scheme suspended indefinitely, more areas have been approved to welcome travellers under the Sandbox programme, which allows those who are fully vaccinated to enter and stay in a designated area or province rather than undergoing quarantine at a hotel or facility. Starting January 11, travellers can register to enter Thailand through the Sandbox schemes in Krabi, Phang Nga, or the Surat Thani islands of Koh Samui, Koh Phangan, and Koh Tao. The Sandbox programme is open to fully vaccinated travellers. An RT-PCR test is required upon arrival in Thailand and travellers must book a stay at a hotel or resort approved by the Safety and Health Administration.

### Cases and Deaths as of 07 January 2022

- As of 07 January 2022 (2PM, GMT+8), worldwide, there were **299,719,477** confirmed cases, including **5,491,868** deaths. Globally, Case Fatality Rate (CFR) was **1.8**.
- In **China**, there were **133,230** confirmed cases with **5,699** deaths, including deaths in Hong Kong (213) and Taiwan (850). Confirmed cases in China include confirmed cases in Hong Kong (12,832), Macau (79) and Taiwan (17,198). CFR was **4.3**.
- 15,084,808 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **306,552 deaths**, with a CFR of **2.0**.




# COVID-19 Epi curve among ASEAN Countries

as of 6 January 2022


