COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 250 million cases and over 5 million deaths attributed to COVID-19.
- According to the World Health Organization (WHO), during the week of October 25 to October 31, globally just over 3 million new cases were reported, marking a slight upward trend (3%) in new cases when compared to the previous week. With over 50,000 new deaths, there was also an increase (8%) in new deaths when compared to last week. The European region continues to be the only region to report an increase (6%) in new cases. The largest decrease in new cases was reported by the Eastern Mediterranean region (-12%). The South-East Asian (50%), European (12%), and Western Pacific (10%) regions have reported the largest increases in new deaths. Based on the BlueDot COVID-19 Data Suite, as of November 4, the top five countries with the highest seven-day rolling average number of daily new cases per million population are Cayman Islands, Estonia, Faroe Islands, Slovenia, and Georgia. As of November 4, Europe is the continent with the largest proportion of countries (37%, or 19 out of 51) with a high incidence rate (>350) and a stable or increasing trend in daily new cases over the last seven days. Europe has the highest proportion of countries (18%, 9 out of 51) with a low (<=140) to moderate (140.1 350) incidence rate and an increasing trend in new cases over the last seven days, followed closely by Africa (16%, 9 out of 56). Both continents of Africa and South America have the highest proportion of countries (71%; 40 out of 56, and 10 out of 14, respectively) reporting a low incidence rate (<= 140) with a stable or decreasing trend in new cases.</p>
- On October 27, results from a platform trial including fluvoxamine, a known oral anti-depressant, was published in the Lancet. This trial showed encouraging results for COVID-19 patients with risk factors for developing severe diseases, such as cardiac disease, hypertension, and diabetes. Fluvoxamine is originally prescribed for obsessive-compulsive disorder or major depressive disorders but may have an antiinflammatory property useful in treating COVID-19. The fluvoxamine arm in the TOGETHER randomized clinical trial recruited 1,497 participants aged 18 years and older with confirmed COVID-19 by rapid antigen test and symptom onset within seven days from 11 sites in Brazil. Participants were assigned to either placebo (n=756) or fluvoxamine (n=741) group with 100 mg pills taken twice daily for 10 days in addition to standard care. The primary outcome was whether hospitalization (i.e., emergency setting visits with over six hours of observation or a referral for hospitalization) occurred within 28 days after randomization. Fluvoxamine reduced the relative risk of observation or hospitalization by 32%, with 79 participants in the treatment group (11%) and 119 from the placebo group (16%) requiring further medical attention. A larger effect was observed in patients that completed approximately 80% of the treatment regimen. There was no overall significant difference in deaths between the placebo (3%) and fluvoxamine (2%) group; however, individuals with high adherence to the treatment observed a 91% relative reduction in mortality. Additionally, the incidence of adverse events was comparable in the fluvoxamine and placebo aroups, although adherence to treatment was marginally higher in the placebo aroup. As a drug with a known safety profile and ease of use at low costs, fluvoxamine may be another promising treatment for equitable disease management in under-resourced regions. It has the potential to reduce the burden on overwhelmed health systems, especially as an early treatment targeting a stage of disease without many conclusive care protocols. However, additional investigation is required to better understand the use of fluvoxamine because of inconclusive and nonsignificant results for secondary outcomes involving viral clearance and disease progression indicators.

Regional Update

- A total of 10 countries accounted for 68.1% of all vaccinations administered globally as of November 4. The top five countries/territories with the highest number of cumulative people vaccinated with at least one dose per 100,000 population are Gibraltar (120,460), Palau (100,600), United Arab Emirates (97,110), Portugal (88,780), and Cuba (88,040). Conversely, the top five countries with the lowest number of cumulative people vaccinated with at least one dose per 100,000 population are the Burundi (10), Congo (120), South Sudan (750), Haiti (760), and Chad (980).
- Malaysia's Health Ministry (MOH) confirmed on November 7 (Sunday) the discovery of the first two cases of COVID-19 subvariant Delta AY.4.2 in the country, involving imported cases of Malaysian students returning from the United Kingdom. In a statement today, Ministry of Health's Director-General said that the cases were detected when the individuals arrived at the Kuala Lumpur International Airport (KLIA) on October 2. Both individuals underwent the RT-PCR test and were initially found negative before being confirmed positive after a second test was conducted on October 7 during the quarantine period. The sample has undergone full genome sequencing at the Institute of Medical Molecular Biology, Universiti Kebangsaan Malaysia (UMBI-UKM) and the result was released on October 30. He added that the AY.4 variant is among 75 types of lineages originating from the Delta variant and among the sub lineages of AY.4 is the AY.4.2 variant which is also known as Delta Plus. The Health Ministry said that it will continue to monitor closely to detect the existence of Delta subvariants in the community.
- The Philippines recorded its first case of the B.1.617.1 COVID-19 variant. During the Department of Health forum, the Undersecretary for Health explained that the B.1.617.1 variant, formerly known as the Kappa variant, is a variant under monitoring as designated by the World Health Organization (WHO). She added that the country's first case of the B.1.617.1 variant was detected in a 32-year-old male from Floridablanca, Pampanga and that further investigation is being done by the country's regional epidemiology and surveillance unit in order to gather more information on this case.

Vaccine Update

• Malaysia reported a total of 24,552,038 individuals or 75.2% of the total population in the country have completed their COVID-19 vaccination as of November 7. Based on the MoH's data on the CovidNow portal, 78.2% of the total population or 25,525,035 individuals have received at least one dose of the vaccine. On Sunday (November 7), a total of 38,027 doses of the vaccine were dispensed with 13,110 doses as second dose, 3,068 doses to first dose recipients and 21,849 doses as booster dose, bringing the total number of doses administered under the National COVID-19 Immunization Programme (PICK) to 50,402,399.

Travel Advisories (new update/s)

 Singapore: Singapore and Malaysia will launch a vaccinated travel lane (VTL) between Changi Airport and Kuala Lumpur International Airport starting November 29. This was announced in a joint statement by both Prime Minister on Monday (November 8). Under the VTL, fully vaccinated travellers will be able to travel between Singapore and Malaysia, and be subjected to COVID-19 tests in lieu of serving quarantine or stay-home notice. The statement added that both leaders also looked forward to restoring travel across the land links "between both countries in the near future". Singapore and Malaysia currently have in place safe travel arrangements through the Periodic Commuting Arrangement. The Reciprocal Green Lane scheme between the countries is presently suspended. Under the VTL scheme, travellers must have remained in one or more of the VTL countries in the last 14 days before departure to Singapore. Singapore currently has VTLs with Australia, Brunei, Canada, Denmark, Germany, France, Italy, the Netherlands, Spain, Switzerland, the United Kingdom and the United States.

• Malaysia: Malaysia is ready to discuss with the United Kingdom on opening up the vaccinated travel lane (VTL) for its fully-vaccinated citizens to enter Malaysia without having to undergo quarantine. Malaysia's Health Minister said that the matter had been conveyed to UK Secretary of State for Foreign, Commonwealth and Development Affairs during their meeting today (November 8).

Cases and Deaths as of 07 November 2021

- As of 07 November 2021 (2PM, GMT+8), worldwide, there were **250,608,574** confirmed cases, including **5,065,257** deaths. Globally, Case Fatality Rate (CFR) was **2.0.**
- In China, there were 126,549 confirmed cases with 5,696 deaths, including deaths in Hong Kong (213) and Taiwan (847). Confirmed cases in China include confirmed cases in Hong Kong (12,368), Macau (77), and Taiwan (16,439). CFR was 4.5.
- 13,368,871 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 281,380 deaths, with a CFR of 2.1.
