### **COVID-19: Highlights and Situation Overview**

#### **Global Update**

- Worldwide, there have been over 449.9 million cases and over 6 million deaths attributed to COVID-19.
- According to the COVID-19 weekly epidemiological update of the World Health Organization (WHO), during the week of February 28 to March 6, the number of new COVID-19 cases and deaths continued to decline globally by 5% and 8% respectively, as compared to the previous week. Across the six WHO regions, over 10 million new cases and over 52,000 new deaths were reported. As of March 6, over 433 million confirmed cases and over 5.9 million deaths have been reported globally. At the regional level, while the Western Pacific Region continued to report an increase (+46%) in the number of new weekly cases, all other regions reported decreases: the Eastern Mediterranean Region (-46%), the African Region (-40%), the South-East Asia Region (-31%), the Region of the Americas (-24%), and the European Region (-18%). The number of new weekly deaths increased in the Western Pacific Region (+29%) and remained stable in the Eastern Mediterranean Region (+2%), while decreases were reported by the African Region (-39%), the European Region (-15%), the Region of the Americas (-9%) and the South-East Asia Region (-3%). These trends should be interpreted with caution as several countries are progressively adopting targeted testing strategies, resulting in lower overall numbers of tests performed and consequently of cases detected.

#### **Regional Update**

 Malaysia's Prime Minister said on March 8 (Tuesday) that Malaysia will begin transitioning into the endemic phase starting April 1. Under the endemic phase, operation hours for businesses will no longer be limited, but face masks will remain mandatory. Social distancing will also no longer be imposed at mosques and places of worship. Business owners are also allowed to carry out operating hours on their respective premises in accordance with the terms of their operating licenses. In addition, there will no longer be the 50% capacity limit for event venues. Check-ins on MySejahtera will still be required for entry into premises, but exceptions are given to open areas that are not crowded and have no large gatherings. However, according to the government official, this is also a temporary stage before the country truly moves into the endemic phase, which is subject to the World Health Organization's (WHO) announcements,

#### Vaccine Update

- The Technical Advisory Group on COVID-19 Vaccine Composition (TAG-CO-VAC) of the WHO is reviewing the available data to optimize
  vaccine mediated protection against the prevalent circulating variants. TAG-CO-VAC encourages COVID-19 vaccine manufacturers to
  generate and provide data to WHO on performance of current and variant-specific COVID-19 vaccines to be continuously be
  considered to be part of a broad decision-making framework on COVID-19 vaccine composition, to allow a more specific advisory from
  the WHO.
- Based on Malaysia's CovidNow portal, a total of 22,930,441 or 97.5% of the adult population have completed COVID-19 vaccination, 23,207,220 or 98.7% received at least one dose of the vaccine, and 15,113,923 individuals or 64.2% have received the COVID-19 booster dose as of March 8 (Tuesday). For adolescents aged 12 to 17, a total of 2,832,919 individuals or 91% of the group have completed their vaccination while 2,933,324 or 94.2% received at least one dose of the vaccine. For children aged five to 11, a total of 1,060,063 individuals

or 29.9% of the group have received the first dose of COVID-19 vaccine under the National COVID-19 Immunization Programme for Children (PICKids). On Tuesday, a total of 68,624 doses of vaccine were administered, with 19,511 as first doses, 1,835 as second doses and 47,278 as booster doses, bringing the cumulative total vaccine doses dispensed under the National COVID-19 Immunization Programme (PICK) to 67,869,343.

#### Travel Advisories (new update/s)

- Indonesia: The COVID-19 Task Force has issued Circular No. 11/2022 and Circular No. 12/2022 that relaxes the health protocol for, respectively, domestic and international travel during the COVID-19 pandemic. Circular No. 11/2022 stipulates that domestic travelers who are fully vaccinated are no longer required to show a negative Antigen or PCR Test Result. Meanwhile, Circular No. 12/2022 stipulates that Indonesians and foreigners travelling from abroad who have been fully vaccinated will only be required to guarantine for 24 hours starting March 8. The COVID-19 Task has also issued Circular No. 13/2022 and Circular No. 14/2022 that clarifies the simplification of health protocols for travelers entering Bali, Bintan or Batam for tourism purposes, as well as the travel bubble system for MotoGP 2022 in Mandalika, West Nusa Tenggara. Circular No. 13/2022 stipulates that all fully vaccinated travelers entering Bali, Bintan or Batam from abroad will not be required to guarantine, though the requirement of negative PCR Test result that is valid for 24 hours at the time of departure still applies, among other provisions. Meanwhile, Circular No. 14/2022 stipulates that all fully vaccinated travelers entering Mandalika from abroad are also not required to guarantine as long as they are travelling within the MotoGP 2022 travel bubble scheme starting March 8. The Indonesian government has also opened special visa on arrival services for international travelers from 23 countries to restore the tourism sector. The 23 countries include Australia, the United States, the Netherlands, Brunei, the Philippines, Britain, Italy, Japan, Germany, Cambodia, Canada, South Korea, Laos, Malaysia, Myanmar, France, Qatar, New Zealand, Singapore, Thailand, Turkey, the United Arab Emirates, and Vietnam. International travellers are only required to bring passports valid at least for six months, return or onward tickets to continue their journeys to other countries, proofs of hotel room reservation in Indonesia, health insurance, and certificates showing negative results of COVID-19. With the special visa, foreign travellers are allowed to stay in Indonesia for a maximum of 30 days and the permit can be extended once.
- Malaysia: Malaysia will reopen its borders to international travellers starting April 1. According to the Prime Minister, visitors, as well as Malaysian returnees, who are fully vaccinated are not required to undergo quarantine upon arrival, however, they must undergo a RT-PCR test two days before departure and a rapid test (RTK) upon arrival. For foreign travellers arriving into Malaysia, they are no longer required to apply through MyTravelPass but are required to download the MySejahtera app and must complete a pre-departure form. As for Malaysians, those with valid documents are free to travel to any other country that has reopened their borders to visitors.

#### Cases and Deaths as of 09 March 2022

- As of 09 March 2022 (2PM, GMT+8), worldwide, there were **449,862,481** confirmed cases, including **6,041,549** deaths. Globally, Case Fatality Rate (CFR) was **1.3.**
- In China, there were 629,301 confirmed cases with 7,776 deaths, including deaths in Hong Kong (2,287) and Taiwan (853). Confirmed cases in China include confirmed cases in Hong Kong (496,767), Macau (82) and Taiwan (20,922). CFR was 1.2.
- 22,837,785 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 329,956 deaths, with a CFR of 1.4.
