### **COVID-19: Highlights and Situation Overview**

#### **Global Update**

- Worldwide, there have been over 236 million cases and over 4 million deaths attributed to COVID-19.
- According to the World Health Organization (WHO), as of September 28, all regions continued to report a substantial decline in weekly new cases. Globally, there was a 10% decline in both new COVID-19 cases and deaths reported between September 20 to 26 compared to the prior week. The largest decrease in weekly new cases was reported by the Eastern Mediterranean Region (17%), followed by the Western Pacific Region (15%), the Region of the Americas (14%), the African Region (12%), and the South-East Asia Region (10%). Based on the BlueDot COVID-19 Data Suite, as of September 30, the top five countries with the highest seven-day rolling average number of daily new cases are the United States, United Kingdom, Turkey, India, and Russia. The top five countries with the highest seven-day rolling average number of daily new cases per million population are New Caledonia, Serbia, Bermuda, Guyana, and Mongolia. As of September 30, Oceania is the region with the largest proportion of countries (50%, or eight out of 16) with a high incidence rate (>350 cases per 100,000 over the past 14 days) and a stable or increasing trend in daily new cases over the last seven days. Europe has the highest proportion of countries is the continent with the highest proportion of countries (15%, or eight out of 51) with a low (<=140 cases) to moderate (140.1 350 cases) incidence rate and an increasing trend in new cases over the last seven days. North America is the continent with the highest proportion of countries (15%, or 40 out of 56) reporting a low incidence rate (<= 140 cases) with a stable or decreasing trend in new cases over the last week, followed by South America (57%, eight out of 14).</p>

#### **Regional Update**

Brunei government has introduced more control measures to curb the spread of the COVID-19 pandemic, including a curfew and more enforcement activities. According to a statement from the country's Prime Minister's Office (PMO) on Friday, the current control measures will be extended for 14 days from October 4 to 17. Before detecting seven local cases on August 7 this year, Brunei had kept a record of 457 days without community infections. Facing a new wave of outbreak, the country introduced the strictest control measures ever. Besides closing religious places, schools switching to online learning, no dine-in for restaurants and closing indoor and outdoor sports facilities, leisure centers and cinemas, Brunei also banned most mass gatherings, requiring all non-essential sector workers to work from home and barring all residents from leaving their houses without any important reason. The PMO statement said additional control measures would be implemented over the next two weeks. Enforcement agencies will step up surveillance and enforcement activities. The public is required to stay at their respective residences every night from 8pm until 4pm the next day to reduce the risk of Covid-19 local transmission. The PMO statement also said that over the next few weeks, the government would ramp up efforts to ensure that 80% of the total population in the country would complete two doses of COVID-19 vaccine injection before the end of the year.

#### Vaccine Update

• A total of 10 countries account for 70% of all vaccinations administered globally as of September 30. The top five countries/territories with the highest number of cumulative people vaccinated with at least one dose per 100,000 population are Gibraltar (118,540), Palau (98,930), United Arab Emirates (92,950), Portugal (87,830), and Cayman Islands (82,900). Conversely, the top five countries with the lowest

number of cumulative people vaccinated with at least one dose per 100,000 population are the Democratic Republic of the Congo (100), Haiti (370), Tanzania (570), South Sudan (650), and Chad (670).

- Malaysia's Special Committee on COVID-19 Vaccine Supply (JKJAV) reported that 20,513,168 individuals or 87.6% of the adult population have been fully inoculated while 22,081,548 adults (94.3%) have received at least one dose of COVID-19 vaccine. It also added that out of the total doses administered on October 3 (Sunday), 96,024 received their first dose of a two-dose vaccine and 110,550 people have received their second dose. Johor leads the state with the most first doses administered at 21,249, followed by Penang (10,931), Kedah (10,747) and Perak (9,853). It also topped the list of the most second doses administered with 20,728, followed by Perak (14,038), Sabah (13,325) and Sarawak (12,374).
- Philippines' National Task Force against COVID-19 said that 1,813,500 doses donated by the United States government through the COVAX facility arrived in the country on October 3 (Sunday). So far, a total of 48,719,770 doses were procured by the national government, 17,840,230 doses were donated through the COVAX Facility, 5,398,000 were procured by local government units and private sector while 3,639,140 doses donated by several nations. Meanwhile, a total of 21,560,795 individuals in the Philippines are now fully vaccinated against COVID-19.

#### Travel Advisories (new update/s)

- Singapore: The government is shortening the quarantine period for travellers entering the city-state and further easing arrival rules for some countries in the latest move to reopen its borders. Arriving travelers from certain regions will need to spend 10 days in isolation starting October 7, instead of 14 days currently, officials told reporters in a briefing on Saturday. Those quarantine rules apply to so-called category III countries, which will include the United States of America and the United Kingdom from next week. The government also plans to move several countries to category II, from where travelers only need to spend seven days in quarantine, starting October 7. Those being moved to that group include France, Spain, the Netherlands and Sweden. At the same time, countries including Ireland and Greece will be moved to category III.
- Thailand: Thai government has announced a plan to waiver mandatory quarantine requirement for fully vaccinated visitors arriving starting November in the capital Bangkok and certain tourism hotspots in nine other regions. Thailand planned to reopen Bangkok and some tourist destinations such as Krabi, Hua Hin, Pattaya and Koh Phayam, following the reopening of Phuket and Samui islands in pilot schemes since July according to the Centre for COVID-19 Situation Administration (CCSA). Nationwide, the CCSA planned to halve the mandatory quarantine period for fully vaccinated visitors arriving from Friday to seven days, and reduce it to 10 days for those that have not finished vaccination.
- Vietnam: Domestic flights officially resumed in October under a four-phase plan outlined by the Ministry of Transport, which applies in localities with relaxed COVID-19 prevention and control measures. In the first phase, to be carried over 10 days, airlines would resume air routes with a flight frequency not exceeding half of that in the first 10 days of April, the time before the fourth COVID-19 wave broke out in Vietnam. Passengers on the planes must be distanced as well. In the second phase, to last for no more than 10 days, the frequency would increase to up to 70% of the frequency in April. No seat distancing is required. The third phase would see the flight frequency return to the level seen in the first 10 days of April (but not exceeding it), with no seat distancing required. The final phase would see airlines resume activities as normal. Air routes that had only one flight a day even pre-pandemic can resume operations as normal in the first and second phases, with seat distancing required. Passengers must follow the "5K message", make health declarations, and present a

negative COVID-19 test result issued within 72 hours before departure. However, passengers who had the first vaccine shot three weeks ago, or those who were fully vaccinated or recovered from the disease within six months are exempt from COVID-19 testing. The Ministry of Transport also requested airlines to offer hand sanitizers to passengers, ask them to wear masks during the flight, and disinfect high-contact surfaces of planes such as door handles and seats after each flight.

#### Cases and Deaths as of 04 October 2021

- As of 04 October 2021 (2PM, GMT+8), worldwide, there were 236,083,725 confirmed cases, including 4,821,610 deaths. Globally, Case Fatality Rate (CFR) was 2.0.
- In China, there were 124,779 confirmed cases with 5,692 deaths, including deaths in Hong Kong (213) and Taiwan (843). Confirmed cases in China include confirmed cases in Hong Kong (12,227), Macau (71), and Taiwan (16,250). CFR was 4.6.
- 12,243,630 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 264,686 deaths, with a CFR of 2.2.



### **COVID-19 Epi curve among ASEAN Countries**




