COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 204 million cases and over 4 million deaths attributed to COVID-19.

Regional Update

- Indonesia extended its COVID-19 curbs on populous Java and Bali islands until August 16 but will ease them in 26 areas. Malls will reopen at 25% capacity for vaccinated people, except for children and the elderly, and people must show their vaccination proof using a digital application. Meanwhile, restrictions in areas outside Java and Bali will be extended until August 23 as cases went up by 1.2%, whereas cases on Java and Bali dropped by 27% this month. On August 10 (Tuesday), the number of COVID-19 cases in Indonesia rose by 32,081 within one day bringing the total number of cases to 3,718,821.
- Malaysia's Senior Minister said on August 10 that 11 more localities in Sabah and one in Pahang will be placed under the Enhanced Movement Control Order (EMCO). Three localities in Kota Kinabalu included under this movement control order are in Jalan Kokol, Kampung Gudon in Menggatal and Kampung Lobou. Another eight localities involve areas are in Kota Belud, Papar, Putatan, Penampang, Ranau, Sipitang and Tawau. Meanwhile in Pahang, Felda Jengka 25 in Temerloh was also placed under the EMCO starting from August 12 to August 25.
- The Philippines' COVID-19 task force has suspended the shortened quarantine period for arriving fully vaccinated individuals who are close contacts of probable and confirmed COVID-19 cases. According to a government official on August 11 (Wednesday), instead of undergoing a facility-based quarantine for just seven days, fully vaccinated persons considered close contacts of COVID-19 cases will undergo a 14-day quarantine period as stated by the Department of Health's (DOH) protocol. The decision to temporarily suspend said protocol is part of the continued implementation of proactive measures to slow down the surge in COVID-19 cases and to stop the further spread of the variants. The new policy comes as the Philippines was again placed at a "high risk" status following the rise in new COVID-19 cases recorded daily.

Vaccine Update

- Singapore reported on August 10 (Tuesday) that 70% of its population has been fully vaccinated and 79% have received at least one dose. In an effort to vaccinate the rest, Singapore said citizens and long-term residents will no longer need to make an appointment to get the Pfizer-BioNTech vaccine, and can instead walk in to any of the more than two dozen clinics offering it to get a vaccine. Singapore on Tuesday began easing some of its COVID-19 rules, allowing dining-in to resume and raising group sizes to five for those who've been fully vaccinated. Work from home rules are also expected to ease next week. According to the Ministry of Health, Singapore will also "very soon" be able to offer vaccinations to short-term visa holders who have been living in Singapore. The country is targeting vaccinating 80% of its population by early September in order to start relaxing some of its toughest restrictions, including allowing quarantine-free travel for vaccinated travelers where frequent testing could replace mandatory stay-home rules upon arrival.

- Malaysia reported on August 10 (Tuesday) that 28.3% of its population has been fully vaccinated and 49.4% have received at least one dose. As of August 10, a total of 25,366,211 has been administered in the country. 9,246,295 has been fully vaccinated while 16,119,916 received at least one dose.
- Vietnam administered over 1.4 million doses of COVID-19 vaccine on August 10 (Tuesday), the highest one-day increase in vaccination count since the country starts its vaccination campaign on March 8. The total doses given in the country has reached 11,341,864 and the number of fully vaccinated people is 1,036,102 as of August 10. The country has currently received some 18.7 million doses of vaccines of various types, mostly AstraZeneca and Moderna. Up to 2.5 million doses of Moderna along with 250,000 doses of Sinopharm, donated by the US and Chinese governments respectively, would remain in storage until second doses are given. According to the National Government Portal on COVID-19 Vaccination, Ho Chi Minh City, the epicentre of the fourth wave of COVID-19 and which has been allocated the most vaccines, is leading the race with over 3.5 million doses administered. The southern city has given at least one dose to 51.6% of the official population over 18 years old (around 7 million). Ha Noi, also the recipient of a large number of vaccines, has administered about 1.5 million doses, with 25.4% of the population getting at least one dose. The country's Health Minister, during a meeting on Tuesday, has asked for close collaboration between the medical sector and the army as vaccines will come in great quantity especially in the final months of the year. The Ministry of Health, meanwhile, issued a document on scheduled allocation of vaccines for localities between now and year's end to ensure vaccination progress.
- Laos reported on August 10 (Tuesday) that 16.8% of its population has been fully vaccinated and 18.9% have received at least one dose. As of August 10, a total of 2,620,478 has been administered in the country. 1,233,395 has been fully vaccinated while 1,387,083 received at least one dose. The Lao Ministry of Health said that the country will purchase additional supplies of COVID-19 vaccines in 2022, allowing for further free vaccines to be provided to residents. The ministry has asked the government to provide a budget for the purchase of more vaccines because the free vaccines received as part of the COVAX conclude this year. The country's national vaccination plan aims to see 50% of the total population vaccinated against COVID-19 by the end of 2021.
- Thailand reported on August 10 (Tuesday) that 6.6% of its population has been fully vaccinated and 23.7% have received at least one dose. As of August 10, a total of 21,504,722 has been administered in the country. 4,627,661 has been fully vaccinated while 16,576,731 received at least one dose. 0.3% of the population has received a third – or booster – shot, most of them healthcare workers. To date, Thailand has been heavily reliant on just 2 vaccine brands, with 48.77% of administered doses being the Chinese Sinovac and 43.95% being AstraZeneca. 7% of doses are Sinopharm, while just 0.28% of the doses administered are Pfizer. Nearly 76% of Phuket residents have now been vaccinated, followed by Bangkok with over 70%, the eastern province of Rayong with 41.6%, and the southern province of Phang Nga, where just over 41% are vaccinated. On August 10, the Public Health Ministry started its distribution of 645,000 Pfizer doses that were donated by the United States government to those considered most vulnerable in the 13 dark red zone provinces. The groups that are deemed vulnerable include the elderly, and people who have 1 or more of 7 underlying diseases, and pregnant women.

Travel Advisories (no new update/s)

Cases and Deaths as of 11 August 2021

- As of 11 August 2021 (2PM, GMT+8), worldwide, there were **204,944,814** confirmed cases, including **4,328,938** deaths. Globally, Case Fatality Rate (CFR) was **2.1**.

- In **China**, there were **121,850** confirmed cases with **5,662** deaths, including deaths in Hong Kong (212) and Taiwan (814). Confirmed cases in China include confirmed cases in Hong Kong (12,020), Macau (63), and Taiwan (15,798).
- **8,211,220 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **175,235 deaths**, with a CFR of **2.1**.

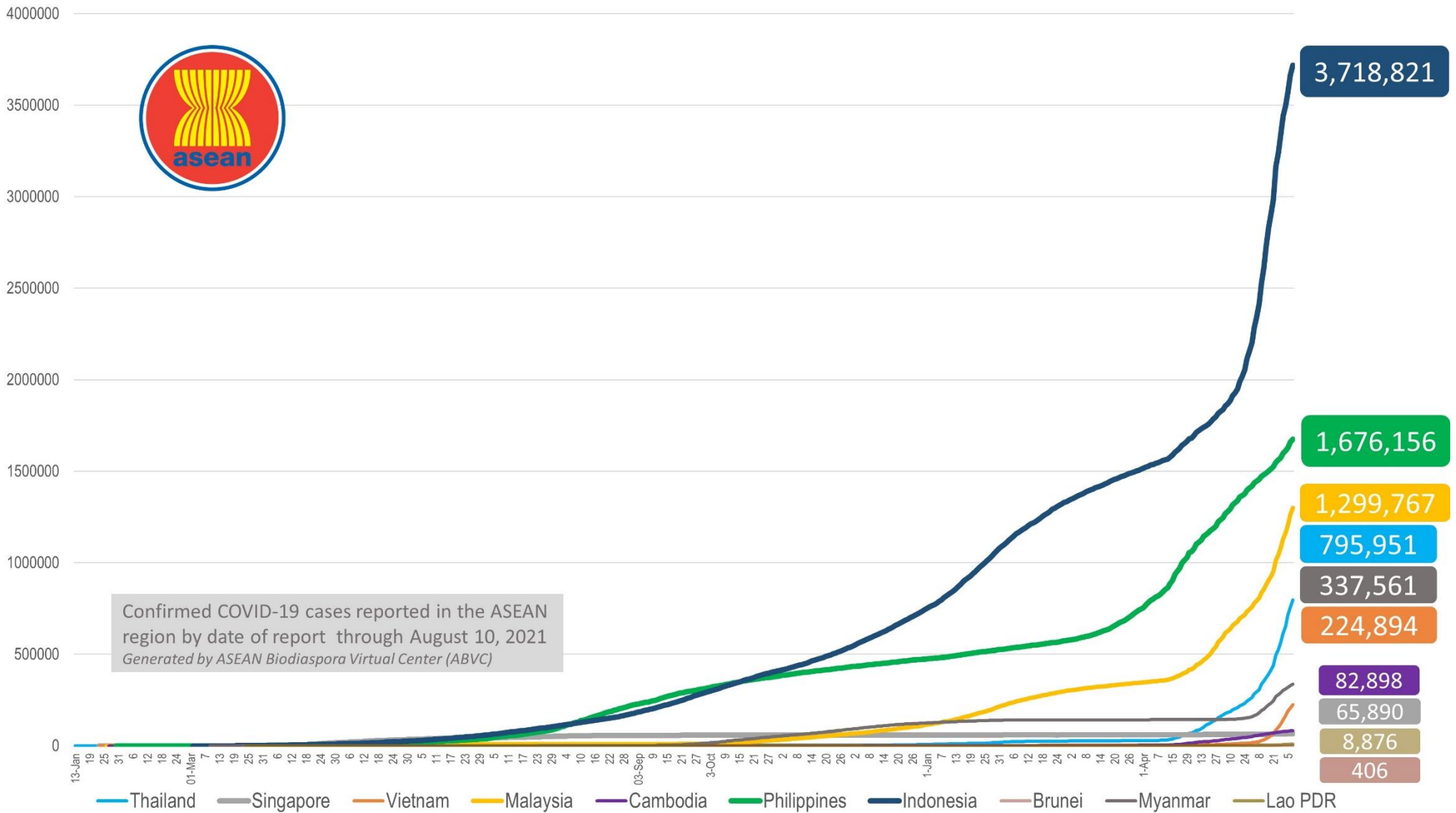

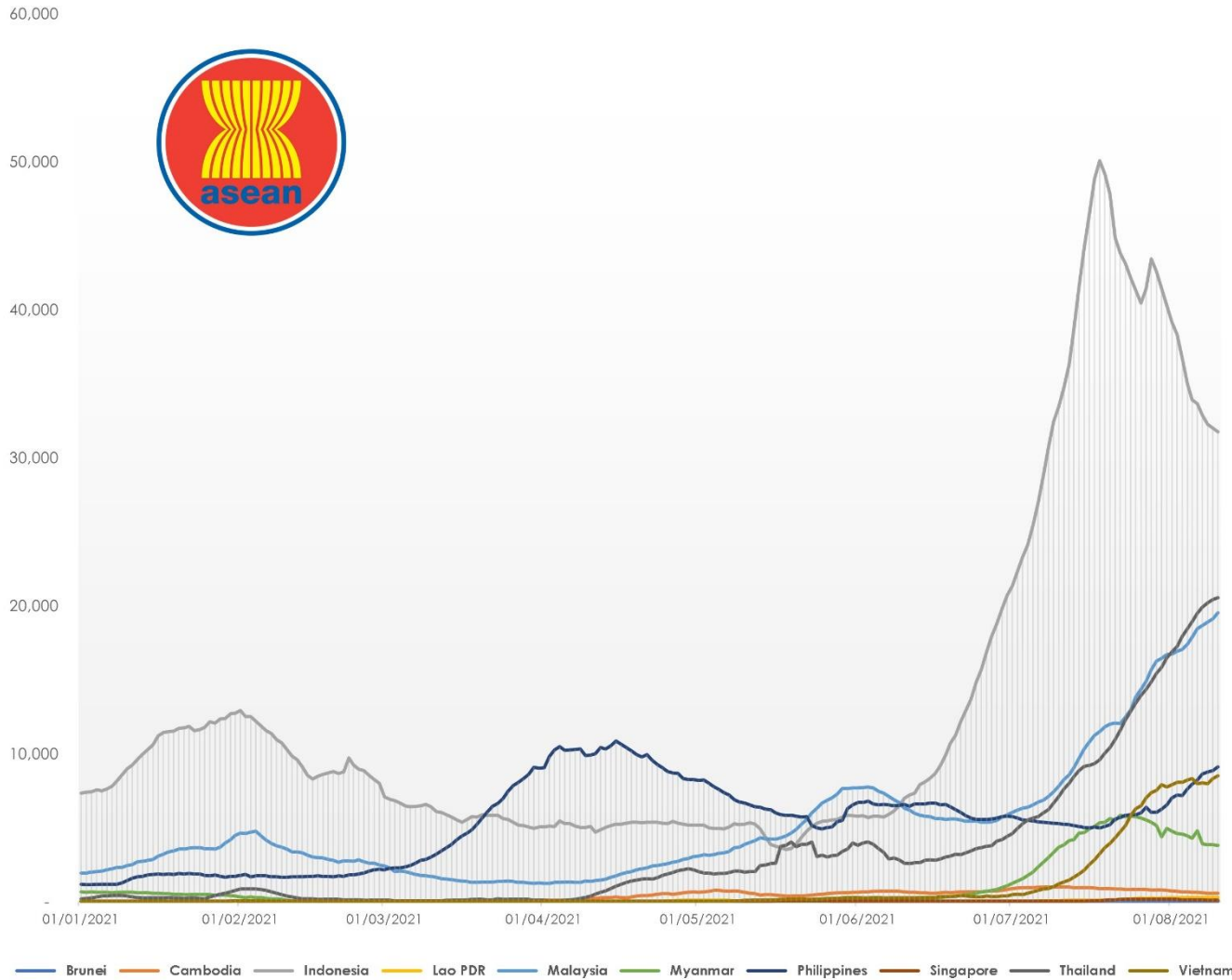
COVID-19 Epi curve among ASEAN Countries

as of 10 August 2021

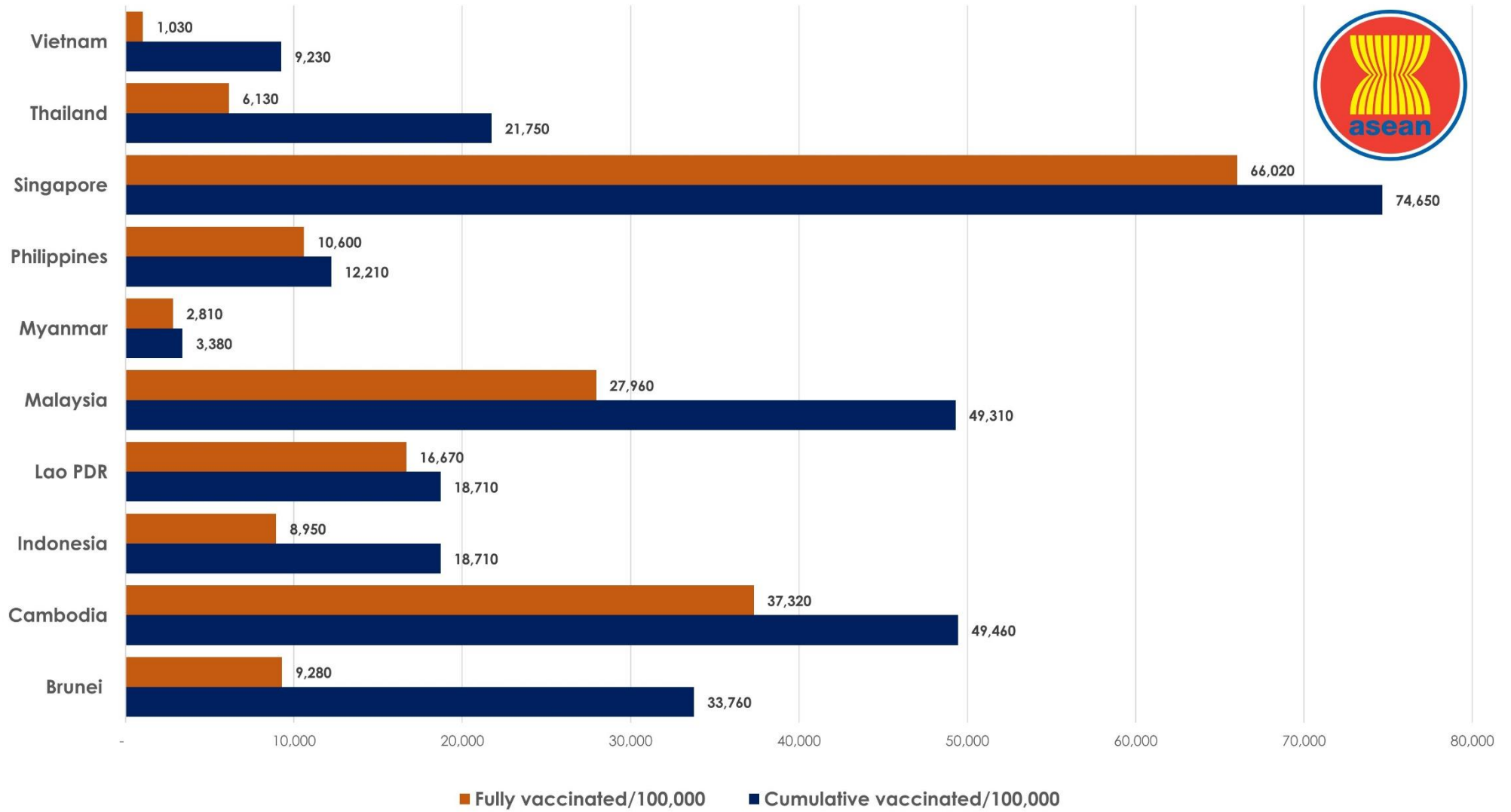
