COVID-19: Highlights and Situation Overview

Global Update

• Worldwide, there have been over 233 million cases and over 4 million deaths attributed to COVID-19.

Regional Update

- Lao Ministry of Health on September 28 (Tuesday) called for continued vigilance as local cases of COVID-19 continued to increase and spread across multiple provinces in Laos. Deputy Director General of the Department of Communicable Diseases Control under the Lao Ministry of Health told a press conference that all the people in the country must continue to fully comply with government guidelines against COVID-19 in order to curb the spread of the virus. He added that 5,911 tests were conducted across the country over the past 24 hours, with 500 cases confirmed, with 471 cases of community spread and 29 imported ones across the country. Among the community cases, 363 were reported in the Lao capital Vientiane and the rest logged in other provinces. Meanwhile, 29 imported cases were recorded, with 20 in Savannakhet province, six in Vientiane, and three in Champasak province. As of Tuesday, the total number of confirmed COVID-19 cases in Laos has reached 22,941 with 16 deaths.
- Vietnam's Prime Minister said that the National Steering Committee for COVID-19 Prevention and Control has agreed to change the strategy policy from "zero COVID-19" to "safe and flexible adaptation and effective control of the COVID-19 pandemic", striving to bring the country back to a new normal by the end of the month. Speaking at the online meeting between the Steering Committee and officials from 10,400 communes, wards and townships, 705 districts, and 63 cities and provinces nationwide on Saturday, the Prime Minister noted that so far, COVID-19 has been gradually controlled in the majority of localities. A report from the steering committee at the meeting said that, from the beginning of the fourth wave of the pandemic to Sept 24, the whole country recorded 734,000 cases, while 503,000 people or 69% have recovered, and more than 18,000 deaths were reported. Last week, there were 72,236 new cases, down 9.7% compared to the previous week and the number of deaths in the week decreased by 12.1% compared to the previous week. Currently, there are 16 out of 63 provinces and cities that have gone 14 days without any new infections. In 23 localities implementing social distancing measures, the pandemic situation is gradually being controlled, the number of cases in the last seven days decreased by 9.8% compared to the same previous period.

Vaccine Update

• Pfizer and BioNTech said on September 28 (Tuesday) that they had begun submitting data to the United States Food and Drug Administration for the highly anticipated authorization of the COVID-19 vaccine in children aged 5 to 11. The news comes a week after the companies announced positive results from a global clinical trial showing the vaccines were safe and evoked a robust response of neutralizing antibodies, which stop the coronavirus from entering cells. Children in the 5-11 age group received a two-dose regimen of 10 micrograms in the trial, compared with 30 micrograms for older age groups. The shots were given 21 days apart. The Pfizer vaccine received full, formal approval in the US in August and is therefore technically available to younger children if prescribed by a doctor, but US authorities have cautioned against doing this until the safety data was in. Pfizer and BioNTech are also trialing their vaccine for infants aged 6 months to 2 years, and children aged 2 to 5. Initial data for these groups may come as soon as the "fourth quarter" of the year.

- Philippines has approved COVID-19 jabs for children as young as 12 according to a government authority on September 28 (Tuesday), as the country battles surging infections fueled by the Delta variant. Inoculating children is seen as a key step towards reopening schools in the Philippines, which is one of the few countries in the world to have kept them shut since the start of the pandemic. The government recently announced plans for a pilot reopening of 120 primary and high schools, but few details have been released. Children will be allowed to receive the jabs starting next month as the vaccination drive is being expanded which also include all adults not previously prioritized for shots. The Philippines' food and drug regulator recently approved the Pfizer and Moderna jabs for kids aged 12 and above. The government has previously set a target of vaccinating 70% of the adult population by the end of the year. In the national capital region, more than 72% have been fully vaccinated to date.
- Malaysia reported that a total of 19,156,694 individuals or 81.8% of the adult population in the country have been fully vaccinated against COVID-19 as of September 23. Based on the Health Ministry's data on CovidNow, 93.3% or 21,847,551 individuals of the adult population had received at least one dose of the vaccine. At the same time, 23,703 individuals or 0.8% of the adolescent population in the country had completed their COVID-19 vaccination as of Thursday. On a daily vaccination rate, a total of 326,612 doses of the vaccine were administered on Thursday, 132,562 of which were for first-dose recipients and 194,050 others were for second-dose recipients, bringing the cumulative total of vaccines administered under the National COVID-19 Immunization Programme to 41,573,883 doses.

Travel Advisories (new update/s)

Malaysia: Interstate travel for tourism activities is only permitted for the Langkawi Tourism Bubble programme with compliance of the stipulated standard operating procedure (SOP) on COVID-19. Referring to the government's announcement on domestic tourism, the Tourism Ministry said domestic travellers were currently allowed to carry out intra-state tourism activities for states that were in Phase 2 and above of the National Recovery Plan (NRP). The Prime Minister also said that the government would allow the opening of tourism centres, islands and areas as well as cross state travel provided the country's adult population vaccination rate reached 90% based on data and analysis conducted by the Health Ministry.

Cases and Deaths as of 29 September 2021

- As of 29 September 2021 (2PM, GMT+8), worldwide, there were 233,819,893 confirmed cases, including 4,781,929 deaths. Globally, Case Fatality Rate (CFR) was 2.0.
- In **China**, there were **124,566** confirmed cases with **5,690** deaths, including deaths in Hong Kong (213) and Taiwan (842). Confirmed cases in China include confirmed cases in Hong Kong (12,210), Macau (63), and Taiwan (16,205). CFR was **4.6**.
- 11,972,537 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 260,487 deaths, with a CFR of 2.2.




COVID-19 Epi curve among ASEAN Countries

as of 28 September 2021


