COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 200 million cases and over 4 million deaths attributed to COVID-19.

Regional Update

- Malaysia reported another high number 17,105 new cases of COVID-19 on Tuesday (August 3), bringing the country's total number of cases to 1,163,291 to date. Selangor remains the state with the highest number of cases with 5,836 new infections. Four other states have more than 1,000 cases - Kuala Lumpur with 2,309, Johor with 1,275 Kedah with 1,036 and Sabah with 1,010. Total active cases have reached 203,664, surpassing the 200 thousand-mark for the first time. Of that total, 1,066 are in intensive care units (ICU), with 537 on ventilator support.
- Philippine government is now observing the impact of the highly transmissible Delta variant of COVID-19 on a national scale according to Department of Health (DOH) on Wednesday (August 4) as it sees a sharp increase in cases since the end of July. According to an authority, half of the provinces, HUCs (highly-urbanized cities), and ICCs (Independent Component Cities) are already showing an increase in cases and/or health care utilization. She added that given the ongoing Delta VOC (variant of concern) transmission, the government need to immediately address increasing cases, closely monitor healthcare utilization, and consider implementing higher community quarantine as pre-emptive measures to contain the Delta variant spread. The DOH has yet to declare a community transmission of the variant for lack of evidence, though it conceded that it would be better to assume that there already is. The country saw an average of 7,239 daily COVID-19 cases from July 28 to August 3, higher than the 6,303 average cases from July 21 to 27 or 5,183 cases from July 14 to 20. So far, a total of 216 cases of the Delta variant was reported in the country.
- Laos has extended COVID-19 restriction measures until August 28 after confirming a further 250 cases on August 3. Thirteen cases of community spread were confirmed today, with four cases in Vientiane Province, four cases in Bokeo Province (Ton Pheung District), one case in Luang Namtha (originating in Ton Pheung), and four cases in Savannakhet, including one border official. Under the extended lockdown measures, authorities will continue to monitor border areas and continue scans and temperature checks at all border checkpoints, as well as expanding quarantine centers and field hospitals in areas with large numbers of returning migrant workers. Contact tracing and coordination between local authorities and health officials, as well as testing and vaccinations, will continue. Pubs and bars, karaoke bars, entertainment venues, cinemas, snooker halls, spas, and internet cafes are to remain closed across the country. Gatherings or parties of any kind may not be held at any location. COVID-19 prevention measures such as temperature checks, social distancing of at least one meter, wearing facemasks, and using alcohol will remain in place.

Vaccine Update

- Malaysia's Special Committee on COVID-19 Vaccine Supply (JKJAV) reported on Wednesday (August 4) a total of 14,711,532 people (or 62.8% of the adult population) have received their first dose while 7,440,835 (or 31.8% of the adult population) had both doses. It was also reported that a total of 483,368 doses of COVID-19 vaccines were administered on Tuesday where 240,394 individuals had received their

first doses while another 242,974 people completed their second dose. A total of 22,152,367 doses of Covid-19 vaccine have been administered in Malaysia as of Tuesday (August 3) alone. Meanwhile, Malaysia received 415,000 doses of the AstraZeneca COVID-19 vaccine contributed by the United Kingdom (UK) on Tuesday (August 3). The consignment was flown in via Emirates Airlines flight EK 346 which landed at KL International Airport (KLIA) here at 2PM yesterday. The vaccine supply is the fourth contribution from a foreign country to Malaysia. Prior to this, Japan had donated 998,400 doses of AstraZeneca, the United States contributed 1,000,350 doses of Pfizer-BioNtech and China contributed 500,000 doses of the Sinovac vaccine.

Travel Advisories (new update/s)

- Laos: Under the extended lockdown measures, entry into red zones will remain prohibited, except for persons authorized by the Taskforce or local authorities until August 28. Land, water, and air transportation may resume between provinces that do not have community spread of COVID-19 without a quarantine requirement. Foreign citizens who travel to Laos and intend to travel to another province must submit a travel itinerary, evidence of 14-day quarantine, and authorization from the National Taskforce for Covid-19 Prevention and Control to relevant officials without having to undertake quarantine at the destination province. Foreigners who reside in Laos or have been in Laos for some time will be allowed to travel under the same conditions as Lao citizens. Passengers entering or exiting a province with community spread must ensure they have received two doses of COVID-19 vaccine and will not be required to request travel authorization from their destination province, and will not be required to quarantine. However, airline or transportation employees and passengers must ensure to check their temperatures, wear a facemask, wash hands regularly or use hand gel.

Cases and Deaths as of 04 August 2021

- As of 04 August 2021 (2PM, GMT+8), worldwide, there were **200,439,601** confirmed cases, including **4,261,898** deaths. Globally, Case Fatality Rate (CFR) was **2.1**.
- In **China**, there were **120,968** confirmed cases with **5,639** deaths, including deaths in Hong Kong (212) and Taiwan (791). Confirmed cases in China include confirmed cases in Hong Kong (11,995), Macau (59), and Taiwan (15,721).
- **7,552,842 confirmed cases** of COVID-19 have been reported in the ASEAN region with a total of **155,715 deaths**, with a CFR of **2.1**.

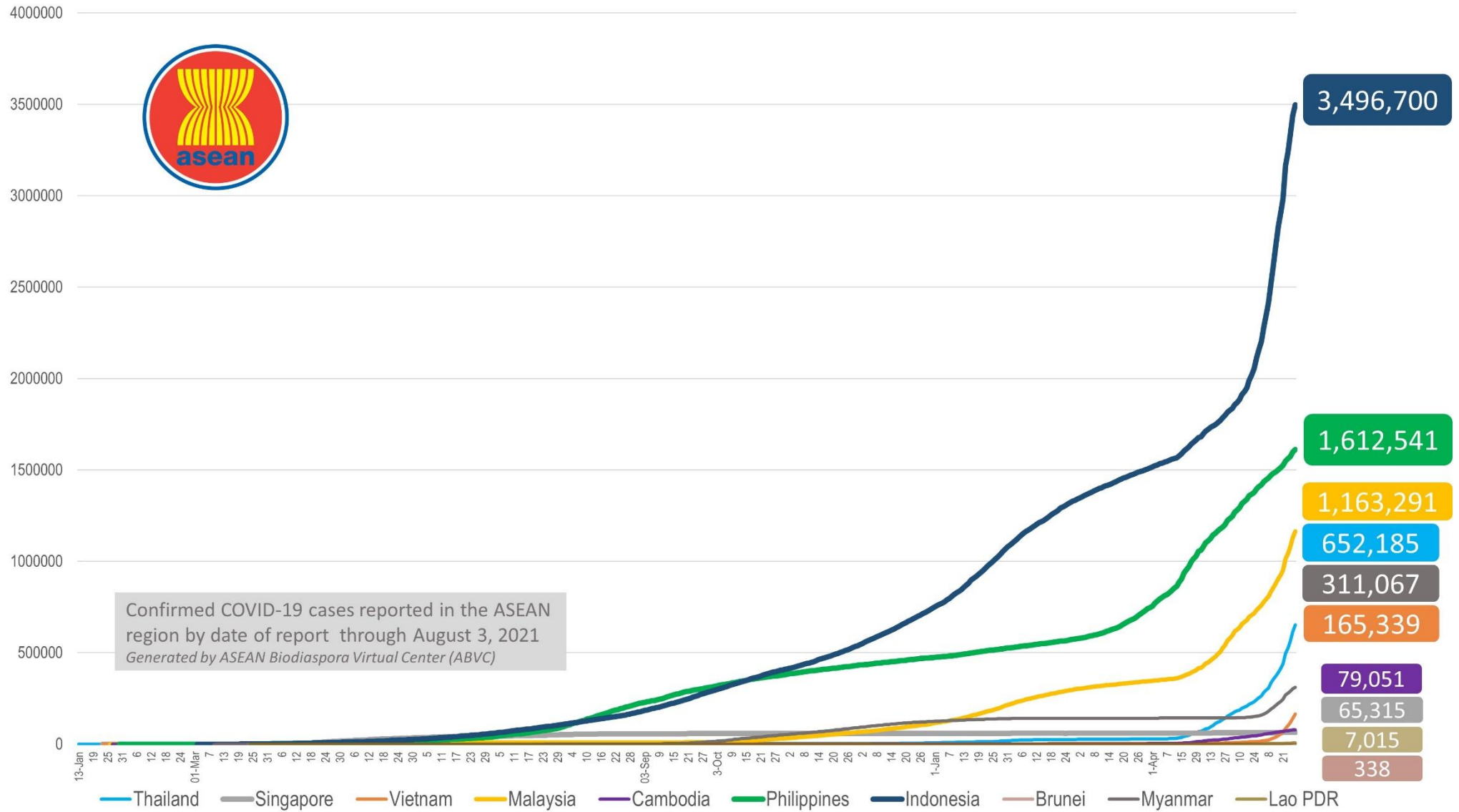

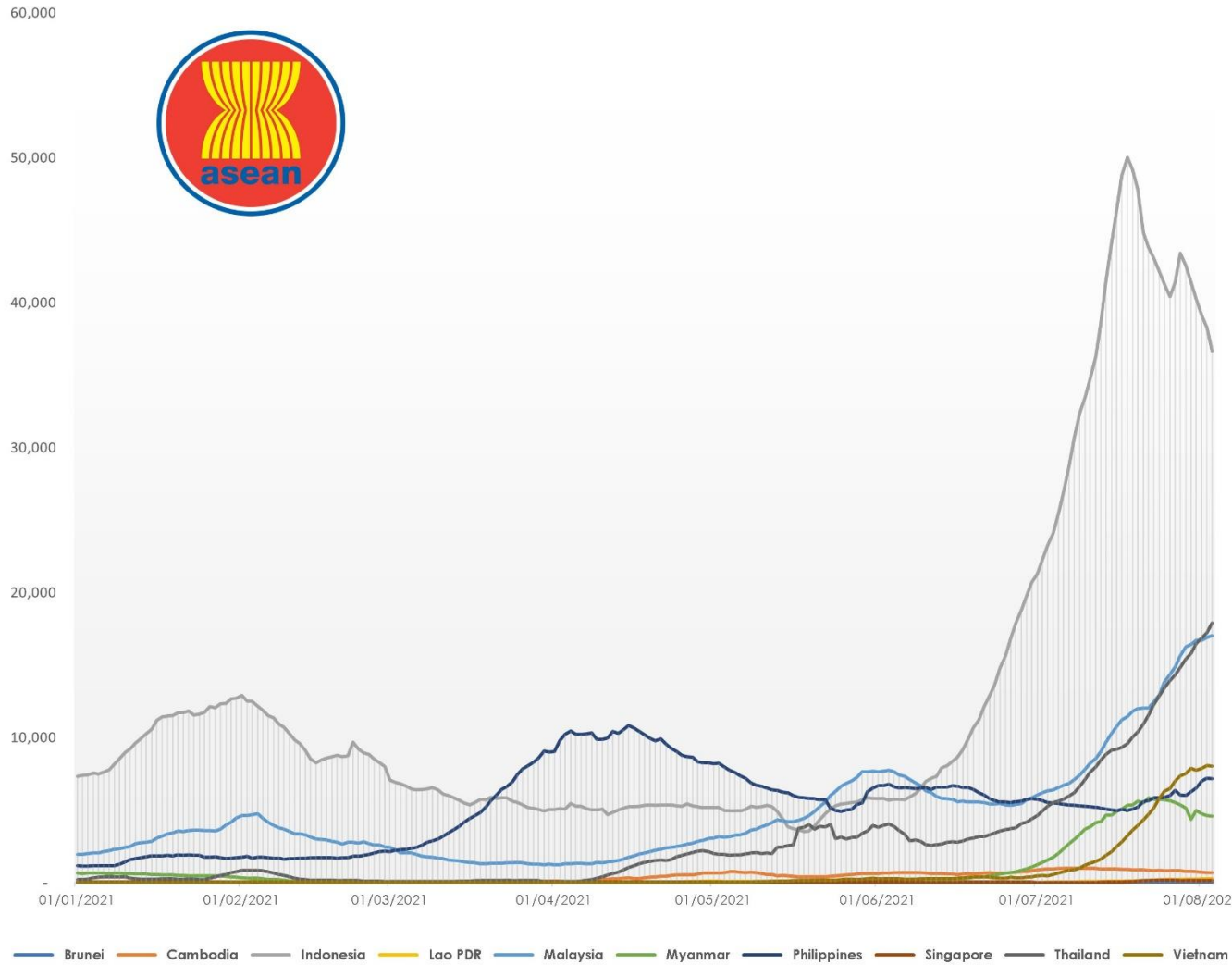
COVID-19 Epi curve among ASEAN Countries

as of 3 August 2021

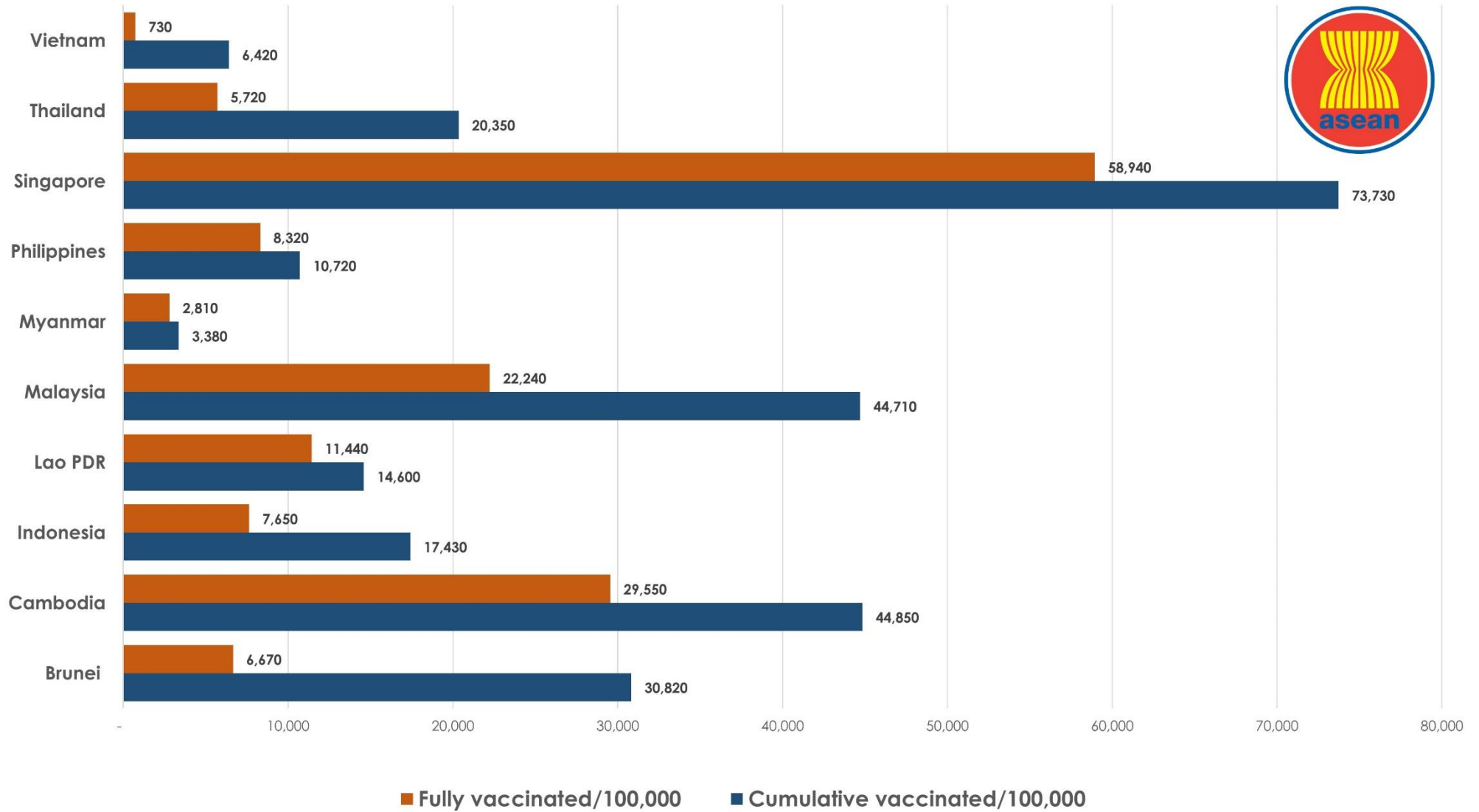
