COVID-19: Highlights and Situation Overview

Global Update

• Worldwide, there have been over 203 million cases and over 4 million deaths attributed to COVID-19.

Regional Update

- Malaysia's Prime Minister announced on August 8 (Sunday) that fully vaccinated Malaysians and permanent residents (PR) returning from overseas will be able to serve their quarantine at home starting August 10 (Tuesday). Citizens and non-citizens with homes in Malaysia, including PRs and those staying in the country under the Malaysia My Second Home (MM2H) programme, can undergo home quarantine under digital home surveillance order. Other privileges extended to fully vaccinated individuals included allowing long-distance married couples to cross district or state borders to meet up, while fully vaccinated parents are also allowed to travel within the country to meet their children who are under 18 years old. Fully vaccinated individuals may also enter mosques and other non-Muslim houses of worship for prayers in the country. According to the government, a person is considered fully vaccinated 14 days after being administered the second dose of two-dose COVID-19 vaccines
- Indonesia's capital Jakarta is set to ease COVID-19 curbs from August 10 (Tuesday), allowing shopping malls and restaurants in the city to reopen with limited capacity as the number of confirmed cases and hospital admissions continue to fall. Easing restrictions to level 3 will mean shopping malls and stand-alone restaurants can open at 25% capacity, while 25% of non-essential workers can return to work from the office. As of August 7 (Sunday), the occupancy rate of COVID-19 isolation wards in Jakarta's hospitals has dropped to 39%, while the occupancy rate for intensive care units (ICUs) has decreased to 65%. Occupancy levels reached above 90% in July, at the peak of the capital's fight against the more transmissible Delta variant of the coronavirus. However, many regions in Java and Bali, are expected to remain on level 4 restrictions while Jakarta will be lowered to level 3 restrictions.

Vaccine Update

- Another batch of China-donated COVID-19 vaccines arrived in Laos on August 7. China has provided Laos with a further one million
 doses of its Sinopharm COVID-19 vaccine to assist in the country's vaccination program. Dr. Bounfeng Phoummalaysith, Lao Minister of
 Health, formally accepted the vaccines from representatives of the Chinese Embassy to Laos at Wattay Airport. The vaccines were
 delivered alongside vaccination equipment as part of Chinese assistance to Laos in its efforts to contain the spread of COVID-19 and
 complete its goal of vaccinating 50% of the population be the end of the year. Laos has received over 5.2 million doses of vaccines from
 friendly countries and through the COVAX initiative, including one million doses of the Johnson & Johnson vaccines from the United States
 of America.
- Philippines' Department of Health (DOH) said on August 9 (Monday) that more than 11.3 million Filipinos have so far completed already the two doses of COVID-19 vaccine. As of August 8, the DOH said a total of 11,391,969 individuals have received two doses of the vaccine including health workers (1,730,762), senior citizens (3,318,212), persons with comorbidities (4,244,272), economic frontliners (1,734,089) and indigents (364,634). Meanwhile, over 13 million individuals have received at least one dose of the COVID-19 vaccine. The doses make up 24,479,750 doses administered in the country. Metro Manila has given at least one dose of COVID-19 vaccine to 5.3 million

individuals and two doses to 3.9 million residents, making a total of 9.2 million doses administered in the capital region. The government aims to vaccinate at least 50% of the population in Metro Manila to achieve population protection.

Travel Advisories (new update/s)

- Singapore: Travellers from eight countries who are fully vaccinated against COVID-19 will soon be able to apply to serve their stay-home notice at their place of residence rather than a dedicated facility. From 11:59pm on August 20, fully vaccinated travellers from Australia, Austria, Canada, Germany, Italy, Norway, South Korea, and Switzerland, can do so if they "fulfil certain criteria". According to the Ministry of Health, an individual is considered fully vaccinated two weeks after he or she has received the full regimen of Pfizer-BioNTech/ Comirnaty, Moderna or any vaccine in the World Health Organization's Emergency Use Listing. This includes Sinovac-Coronavac, Sinopharm and AstraZeneca's vaccines. Applications will be considered if the vaccinated traveller has remained in the eight countries as well as countries or regions Brunei, Hong Kong, Macau, mainland China, New Zealand and Taiwan - in the last 21 consecutive days prior to arriving in Singapore. For Singaporeans and permanent residents, the application must be made three days prior to arrival via the SafeTravel website. All travellers must present the approval to opt-out upon arrival in Singapore. Also, starting August 10, the Ministry of Manpower (MOM) will resume entry approvals for fully vaccinated work pass holders and their dependents with travel history to higher risk countries or regions. They must be fully vaccinated before arrival in Singapore, and they will be subjected to the prevailing health protocols. Higher risk countries or regions refer to all places except Brunei, Hong Kong, mainland China, Macau, New Zealand and Taiwan. Work pass holders and their dependents will need to show documentary proof of their full vaccination status to the airlines before boarding and at the checkpoint upon arrival in Singapore. The vaccination condition for entry will not apply to dependents who are below the age of 12. Those between the ages of 12 and 18 can enter without proof of vaccination, on the condition that they take their first vaccination shot using a pandemic special access route (PSAR) vaccine within one month of arriving in Singapore, as well as the second shot within one month of the first dose.
- Vietnam: Civil Aviation Authority of Vietnam (CVAA) has proposed that all flights between Hanoi and Ho Chi Minh City (HCMC) be suspended as the nation fights a prolonged COVID-19 wave. The CVAA said Saturday that it has asked the Ministry of Transport to freeze all regular flights between localities that are under social distancing orders, including Hanoi and HCMC. For now, flights from HCMC to Hanoi and many other localities have been suspended; and there are very few flights from Hanoi to HCMC. The airports in the southern region that are implementing social distancing campaigns include Tan Son Nhat, Can Tho, Phu Quoc, Rach Gia, Ca Mau and Con Dao.. So far, flights from Hanoi to Rach Gia, Ca Mau, Con Dao, Can Tho and Phu Quoc have been suspended.

Cases and Deaths as of 09 August 2021

- As of 09 August 2021 (2PM, GMT+8), worldwide, there were 203,677,529 confirmed cases, including 4,311,297 deaths. Globally, Case Fatality Rate (CFR) was 2.1.
- In **China**, there were **121,560** confirmed cases with **5,657** deaths, including deaths in Hong Kong (212) and Taiwan (809). Confirmed cases in China include confirmed cases in Hong Kong (12,014), Macau (63), and Taiwan (15,782).
 - 8,035,558 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 169,812 deaths, with a CFR of 2.1.




COVID-19 Epi curve among ASEAN Countries


