COVID-19: Highlights and Situation Overview

Global Update

- Worldwide, there have been over 400 million cases and 5.8 million deaths attributed to COVID-19.
- According to the World Health Organization (WHO), during the week of January 31 to February 6, the number of new COVID-19 cases globally has decreased by 17% compared to the number reported during the previous week, while the number of new deaths has increased by 7%. Across the six WHO regions, over 19 million new cases and just under 68,000 new deaths were reported. As of February 6, over 392 million confirmed cases and over 5.7 million deaths have been reported globally. At the regional level, the Eastern Mediterranean Region reported an increase of 36% in the number of new weekly cases while all other regions reported decreases: The Region of the Americas (36%), the South-East Asia Region (32%), the African Region (22%), the Western Pacific Region (8%) and the European Region (7%). The number of new weekly deaths continued to increase in the South-East Asia (67%) and Eastern Mediterranean Regions (45%), while the number remained similar to that of the previous week in the Region of the Americas and the European Region and decreased in the African (14%) and Western Pacific Regions (5%). WHO also reported that the current global epidemiology of SARS-CoV-2 is characterized by the continued rapid global spread of the Omicron variant. All other variants, including VOCs (Alpha, Beta, Gamma and Delta) and VOIs (Lambda and Mu) continue to decline in all six WHO regions. Among the 426 363 sequences uploaded to GISAID with specimens collected in the last 30 days, 412 265(96.7%) were Omicron, 13 972(3.3%) were Delta, two (<0.1%) were Gamma, and two (<0.1%) were Alpha. There were no sequences reported for another variant, including for VOIs Mu and Lambda.

Regional Update

- Brunei's Ministry of Health said on Monday (February 7) evening that the country is now going through the third wave of COVID-19, where the number of cases is expected to increase beyond the total reported during the second wave. The country's COVID-19 cases reached 1,371 from January 31 to February 6, up from 281 in the past week, which is also higher than the caseloads of 251 and 247 for the previous two weeks. However, the ministry said that the number of severe cases who would require oxygen assistance and intensive care during the third wave will continue to be low and not exceed the number recorded during the second wave. The ministry also said that Omicron variant has been found to be replacing the Delta variant as the main or dominant variant in Brunei Darussalam at this time, but adding that all the Omicron variant cases detected in Brunei only had mild symptoms or were asymptomatic. The ministry urged the public to adhere to the standard operation procedures (SOPs) and guidelines set by the government. The SOPs and guidelines listed by the health ministry include getting the third dose of the COVID-19 vaccine as soon as possible, wearing a well-fitting face mask when going outdoors, and maintaining physical distancing.
- Malaysia reported that a total of 89 new clusters were reported in the fifth epidemiological week (ME) from January 30 to February 5, bringing the total number of active clusters to 353 which is a 21.3% increase compared to the previous corresponding period. Of the 89 clusters, 52 were from educational institutions, 20 from workplaces, 7 from within the community, 6 within high-risk groups, 3 from detention centers and one from religious activities. On the same epidemiological week, the country reported a total of 43,062 new COVID-19 cases, a 34.7% increase compared to the previous week, but has however seen an 8.1% decrease in the number of deaths. Meanwhile, the government announced on Tuesday (February 8) that the standard operation procedure requiring temperature checks and manual recording of personal particulars for entry in premises will abolished starting February 11. However, checking in with the MySejahtera

- application is still mandatory. The authority also said that the government would have a new set of SOPs for umrah travel, including making the booster dose compulsory and allowing home quarantine starting February 14.
- Vietnam reported 21,909 new COVID-19 cases on February 8 (Tuesday), the highest daily number of cases reported in 2022. The cases reported in 63 localities nationwide include 21,901 locally transmitted and eight imported. Hanoi continued to record the highest number of infections with 2,903 cases, followed by Nghe An with 1,717 and Hai Duong with 1,245. The total number of COVID-19 cases in the country has reached 2,380,695, including 192 infections of Omicron.

Vaccine Update

• Based on Malaysia's CovidNow portal, a total of 22,931,979 individuals, or 98% of the adult population, have completed COVID-19 vaccination, while 23,207,389 individuals, or 99.2%, have received at least one dose of the vaccine as of February 8 (Tuesday). In addition, 53.9% of the adult population in Malaysia, or 12,616,238 individuals, have received the COVID-19 booster dose. For adolescents aged between 12 and 17, a total of 2,792,830 or 88.7% of the age group have completed the vaccination, while 2,870,546 or 91.2% have received at least one dose of the vaccine. On Tuesday (February 8), a total of 152,358 doses of the vaccine were dispensed, involving 10,471 as first dose, 1,506 as second dose and 140,381 as booster dose, bringing the cumulative number of doses administered under the National COVID-19 Immunization Programme to 64,264,073.

Travel Advisories (new update/s)

• Philippines: The Bureau of Immigration (BI) on February 8 (Tuesday) clarified that only fully vaccinated foreign nationals coming from over 150 countries are allowed to enter the country without a visa starting February 10. In a statement, the Immigration Commissioner said that foreigners whose country of nationality is not listed under Executive Order (EO) 408 cannot avail of the visa-free privilege and are required to secure visas before traveling to the Philippines. Under the EO, nationals from 157 countries may be admitted into the country without a visa for an initial stay of 30 days. The nations include Canada, Japan, Singapore, the United States, New Zealand, Malaysia, and South Korea. Meanwhile, foreign travellers from countries not listed under EO need to secure a 9(a) visa and an entry exemption document (EED) through any of the Philippine embassies or consulates abroad and must also be fully vaccinated or else they will be denied entry even if they have valid 9(a) visas and EED. The task force also required arriving foreign travellers to present a negative RT-PCR test, taken at least 48 hours prior to departure from the country of origin, a return ticket, a passport valid for at least six months, and a travel and health insurance for COVID-19 with a minimum coverage of USD 35,000 that is valid for the entire duration of their stay.

Cases and Deaths as of 09 February 2022

- As of 09 February 2022 (2PM, GMT+8), worldwide, there were 400,110,139 confirmed cases, including 5,784,449 deaths. Globally, Case Fatality Rate (CFR) was 1.4.
- In **China**, there were **141,865** confirmed cases with **5,700** deaths, including deaths in Hong Kong (213) and Taiwan (851). Confirmed cases in China include confirmed cases in Hong Kong (16,022), Macau (79) and Taiwan (19,239). CFR was **4.0**.
- 17,273,172 confirmed cases of COVID-19 have been reported in the ASEAN region with a total of 316,117 deaths, with a CFR of 1.8.




COVID-19 Epi curve among ASEAN Countries


